Non-governmental organizations**Report of the Committee on Non-Governmental Organizations on its 2022 resumed session**

(New York, 29 August–7 September and 15 September 2022)*

Summary

At its 2022 resumed session, held from 29 August to 7 September and on 15 September, the Committee on Non-Governmental Organizations had before it 564 applications for consultative status, including 348 applications deferred from earlier sessions. Of the non-governmental organizations submitting those applications, the Committee recommended 173 for consultative status, deferred 321 for further consideration at its regular session in 2023 and closed without prejudice consideration of 59 applications of organizations that had failed to respond to queries over two consecutive sessions of the Committee. The Committee considered and took note of seven requests for a change of name. It also had before it 403 quadrennial reports, of which it took note of 308. The Committee heard five representatives of the non-governmental organizations that attended the session.

The present report contains seven draft decisions on matters calling for action by the Economic and Social Council.

By draft decision I, the Council would:

- (a) Grant special consultative status to 173 non-governmental organizations;
- (b) Note that the Committee decided to take note of the change of name of seven non-governmental organizations;
- (c) Note that the Committee took note of 308 quadrennial reports submitted by non-governmental organizations;
- (d) Note that the Committee decided to take note of the withdrawal by two organizations of their applications for consultative status;

(e) Close without prejudice consideration of the request for consultative status made by 59 non-governmental organizations after the organizations had failed to respond to queries over the course of two consecutive sessions of the Committee.

(f) Decide not to grant consultative status to nine organizations.

By draft decision II, the Council would suspend, for a period of one year, the consultative status of 205 organizations with outstanding quadrennial reports.

By draft decision III, the Council would decide to reinstate the consultative status of 48 organizations that had submitted their outstanding quadrennial reports.

By draft decision IV, the Council would decide to withdraw the consultative status of 168 organizations with continued outstanding quadrennial reports.

By draft decision V, the Council would approve the dates and provisional agenda of the 2023 session of the Committee.

By draft decision VI, the Council would take note of the present report.

By draft decision VII, the Council would take note of the addendum to the report of the Committee on its 2022 regular session.

The Committee considered a total of 348 deferred applications for consultative status.

4. At its 20th and 26th meetings, held on 31 August and 6 September, the Committee took note of the decisions by two non-governmental organizations (NGOs) to withdraw their applications (see chap. I, draft decision I, subpara. (d)).

7. At the 19th meeting, on 31 August, the representative of Cuba referred to a note verbale from the Permanent Mission of Philippines to the United Nations dated 30 August 2022 regarding the organization Transnational Anti-Organized Crime Intelligence Group (TAOC-IG), informing the Committee that the certificate of incorporation of the organization had been revoked due to the organization's violation of national laws. He sought clarification from the Secretariat regarding whether the Committee could proceed with the review the application while its registration had been revoked.

8. The representative of the United States of America stated that the registration of a non-governmental organization in a particular jurisdiction is not a requirement under Council resolution 1996/31.

9. The representative of Cuba recalled the provisions of paragraph 10 of the resolution, in which it is stipulated that non-governmental organizations should have established headquarters and a democratically adopted constitution. He inquired whether a non-governmental organization could still be deemed legitimate if the country in which the organization operated had informed the Committee that it was no longer recognized as a non-governmental organization.

10. The representative of the Russian Federation concurred with the representative of Cuba and added that the issuance of an official letter regarding the non-registration of the organization called into question its legitimacy. He sought clarification from the Secretariat regarding the verification processes for determining the authenticity of the documents submitted by non-governmental organizations in support of their applications. The representative of China echoed the concerns raised by the representatives of Cuba and the Russian Federation.

11. The representative of the United States of America maintained that the application of the organization complied with the requirements of resolution 1996/3 because the organization had an established headquarters in the Philippines. The representative of Estonia concurred with the position of the United States of America.

12. The representative of Türkiye also shared the concerns raised by the representatives of Cuba and the Russian Federation. Recalling the decision of the Committee in 2017 with regard to the cases concerning non-governmental organizations in Türkiye that had been dissolved through a decree with force of law, he asserted that when an organization lost its legal status in the country in which it was initially registered, the basis for its consultative status ceased to exist. He further stated that, in cases in which national legislation required NGOs to formally register, the revocation of such registration needed to be duly taken into account by the Committee.

13. The Secretariat indicated that NGOs applying for consultative status were only required to provide evidence of registration for the sole purpose of establishing proof of their existence for at least two years prior to their application, as stipulated in the resolution. The Secretariat further clarified that the issue of registration was distinct from that of legal personality and that the application before the Committee differed from the context of the deliberations of the Committee in 2017 regarding the organizations in Türkiye in 2017.

14. The representative of India underlined that the question of legal personality was important and proposed that the Committee deliberate on the issue in detail in the future to consider the question of registration and legal personality in jurisdictions in which the registration of non-governmental organizations was required.

15. Following further deliberations, the Committee agreed to transmit the note verbale to the organization to seek its views before taking further action.

16. At the 20th meeting, on 31 August, the representative of the Russian Federation referred to the question posed by the delegation of Estonia to the organization International Association for the Development of the Abaza-Abkhaz Ethnos “Alashara” about the alleged incorrect use of terminology. He stated that his delegation did not consider the question as a position of the Committee on the official status of the Republic of Abkhazia and that it did not affect the position of the Russian Federation on the recognition of the Republic of Abkhazia as a sovereign State.

Gulf Centre for Human Rights, Limited

17. At its 27th meeting, on 7 September, the Committee considered the application of the non-governmental organization Gulf Centre for Human Rights, Limited. The representative of the United States of America noted that the application of the

organization had been deferred by the Committee since 2016 and stated that the organization had responded to the Committee's questions in a thorough way. She put forward a motion for a vote, under rule 59 of the rules of procedure of the Council, for the Committee to recommend the granting of consultative status to the organization.

18. The Committee voted against the motion by the United States to recommend the organization for consultative status by a roll-call vote of 10 to 5, with 2 abstentions. Of the 19 members of the Committee, 15 were present and voting. The voting was as follows:

In favour:

Brazil, Estonia, Israel, Mexico, United States of America.

Against:

Bahrain, Burundi, China, Cuba, India, Nicaragua, Nigeria, Pakistan, Russian Federation, Sudan.

Abstaining:

Türkiye, Greece.

Absent:

Eswatini, Libya.

International Dalit Solidarity Network

19. At the same meeting, the Committee considered the application of the non-governmental organization International Dalit Solidarity Network. Following a question posed to the organization by the representative of India, the representative of the United States of America noted that the organization's application had been deferred by the Committee since 2008. She stated that the organization had responded to repetitive questions asked by the Committee. She put forward a motion for a vote, under rule 59 of the rules of procedure of the Council, for the Committee to recommend the granting of consultative status to the organization.

20. Before the vote, the representative of India, in a statement in explanation of vote, maintained that the questions posed to the organization were part of the due diligence process exercised by all members of the Committee based on their right and duty to ensure the fulfilment of the Committee's mandate. He stated that his delegation would vote against the motion and urged other members to vote against it.

21. The Committee voted against the motion by the United States to recommend the organization for consultative status by a roll-call vote of 10 to 5, with 2 abstentions. Of the 19 members of the Committee, 15 were present and voting. The voting was as follows:

In favour:

Brazil, Estonia, Israel, Mexico, United States of America.

Against:

Bahrain, Burundi, China, Cuba, India, Nicaragua, Nigeria, Pakistan, Russian Federation, Sudan.

Abstaining:

Türkiye, Greece.

Absent:

Eswatini, Libya.

22. After the vote, the representative of Pakistan made a statement in explanation of vote. He stated that the premise of his delegation's vote was in respect of the

procedure followed by the Committee and cautioned against the politicization of the established working methods of the Committee. In that regard, he underlined that the Committee worked by consensus. He stressed that his delegation's vote was not against the activities of the organization concerned but on fundamental principles upheld by his delegation.

23. In a general statement after the vote, the representative of the United States of America expressed regret about the politicization of the Committee and its arbitrary decisions. She recognized the right of the Committee to thoroughly vet every non-governmental organization but noted that the organization in question had been deferred for 15 years and that it had responded to all of the Committee's questions. She asserted that the organization had been targeted because of its work and that the questions posed to the organization were not based on resolution 1996/31. She reiterated her delegation's concerns regarding the politicization of non-governmental organizations and the misuse of the criteria of resolution 1996/31, and stated that they amounted to a misuse of the authority of the Committee.

24. At the 27th meeting, on 7 September, the representative of the United States of America put forward a motion for a vote, pursuant to rule 59 of the rules of procedure of the Council, for the Committee to vote on recommending the granting of consultative status to several organizations. She informed the Committee that her delegation had selected the organizations concerned on the basis of an objective set of criteria, namely that their applications had been deferred by the Committee for at least four years and that they had been responding to the Committee's questions satisfactorily, and that consideration had been given to the diverse locations of the organizations and the areas of their work. She added that the credibility of the organizations concerned was in line with the provisions of resolution 1996/31 and that they had been carefully vetted by her delegation.

25. The Committee proceeded to vote on the applications of the organizations set out below.

Bahrain Center for Human Rights

26. The Committee voted against the motion by the United States to recommend the organization for consultative status by a roll-call vote of 10 to 5, with 2 abstentions. Of the 19 members of the Committee, 15 were present and voting. The voting was as follows:

32. The Committee voted against the motion by the United States to recommend the organization for consultative status by a roll-call vote of 11 to 5, with 1 abstention. Of the 19 members of the Committee, 16 were present and voting. The voting was as follows:

33. After the vote, the representative of Mexico made a statement in explanation of vote regarding all the organizations that the Committee had voted upon. She welcomed the proposal made by the United States for the Committee to recommend the granting of consultative status to the organizations concerned and affirmed her delegation's conviction that the information that had been provided by the organizations was adequate and in line with the provisions of resolution 1996/31. In that regard, she stated that her delegation did not have further questions and considered that a recommendation to grant consultative status to the organizations was appropriate. She affirmed that her delegation's vote was in line with the principle of openness towards non-governmental organizations that her Government practices as national policy, as well as her Government's support for the involvement of civil

society in the United Nations. She expressed appreciation for the specific set of criteria applied in the selection of the organizations put to a vote and recognized that it could be a good practice for the whole Committee to agree on criteria for taking action on long-deferred applications.

34. After the vote, the representative of Cuba made a statement in explanation of vote regarding all the organizations that had been put to a vote. He stated that the votes by his delegation were not a judgment on the specific work or merit of the organizations but had been based on procedural issues. He stated that, as a responsible member of the Committee, his delegation based its work on the established practice and the methods of work of the Committee as well as resolution 1996/31. In that regard, he asserted that his delegation could not support the selective exercise proposed by the delegation of the United States, which, he stated, was a violation of the Committee's methods of work. He pointed out that the members of the Committee were elected by the Council to undertake the difficult task of assessing organizations applying for consultative status and that the vast majority of organizations applying for consultative status conducted commendable work, in very difficult circumstances, in support of the work of the United Nations. In that regard, he stated that the selective exercise by the delegation of the United States called into question the membership of the Committee. He pointed out that the outcome of the votes demonstrated a rejection of the selective approach by the members of the Committee. In reference to the criteria used for the organizations selected for a vote, he pointed out that there were many other organizations whose applications had been deferred by the Committee since 2016 and that had met the criteria cited but had not been included in the list of organizations put forward for a vote. In that regard, he maintained that the criteria that had been applied in the selection of the organizations was selective and not objective. He re-emphasized that his delegation's votes were not a judgment on the work of the organizations concerned, but were about the process that had been followed. He stated that the outcome of the votes had demonstrated that the Committee was acting responsibly, in line with resolution 1996/31. He reaffirmed his delegation's commitment to the working methods of the Committee, its established practice and resolution 1996/31, and reiterated that his delegation could not support a selective exercise that violated the methods of work of the Committee.

35. After the vote, the representative of Pakistan made a statement in explanation of vote, in which he reiterated that all votes cast by his delegation were based on the premise of the working methods of the Committee and stressed that they did not constitute a judgment on the activities of the organizations concerned. He emphasized that the Committee had been working by consensus and stated that the criteria used in the evaluation of applications was different for every delegation. He pointed out that eight of the organizations that had been put to a vote had not responded to questions posed to them by the Committee. Regarding the criteria cited for bringing the applications before the Committee for a vote, he pointed out that there were many other deferred organizations that met the criteria, but they had not been included in the list. He underlined that his delegation respected the right of members to raise questions and reiterated that his delegation's vote was based on the premise that the Committee should work by consensus.

36. After the vote, the representative of Bahrain made a statement in explanation of vote. She stated that her delegation had voted against the motions made by the representative of the United States of America because of its concern regarding the procedure followed and its implication on the work and functioning of the Committee as well as the rights and obligations of elected members of the Committee. She reiterated her delegation's firm belief in the importance of the contributions made by civil society to the work of the United Nations.

37. After the vote, in a statement in explanation of vote, the representative of the Russian Federation stated that the Committee had witnessed a policy of double standards by the delegation of the United States. In reference to the statement regarding the objective criteria applied in selecting the organizations put forward for a vote before the Committee, he pointed out that the list of organizations put forward did not include many of the deferred organizations that had met the criteria and contended that the delegation of the United States had exercised its own subjective criteria. He cited the example of an organization that had been under review by the Committee for seven years and whose request for status had been blocked by the delegation of the United States. He asserted that there were at least 30 organizations in a similar situation, which had been asked repetitive and unfounded questions, and he urged members of the Committee to adhere to their stated principles.

38. After the vote, in a statement in explanation of vote regarding all the votes cast by his delegation, the representative of China affirmed his delegation's support for the participation of non-governmental organizations in the work of the United Nations in an orderly manner, in line with Council resolution 1996/31. He stated that his delegation's votes were based on respect for the rules of procedure of the United Nations and the authority of the Committee. He expressed regret about the continuing politicization of the Committee's work and about actions that undermined the Committee's working methods, its consensus and resolution 1996/31. He stated that the votes by the majority of the members of the Committee demonstrated that they disapproved of such ongoing practices, which showed disregard for the working methods and the authority of the Committee. He recalled that the members of the Committee had worked together in an efficient manner and had successfully concluded the review of its agenda, and he urged the members to respect the consensus, the rules and the authority of the Committee.

39. After the vote, the representative of India made a statement in explanation of vote regarding all the votes cast by his delegation. He emphasized that his delegation's votes did not reflect a position on the work of the nine organizations but were based on the principled and consistent position of his delegation on the procedure followed by the Committee. He asserted that the proposals for votes made before the Committee could undermine and adversely affect the long-standing practice followed by the Committee. He further stated that his delegation did not concur with the assertion that the work of the Committee was not in line with resolution 1996/31. He maintained that, in the resolution, the Council did establish specific criteria for evaluating applications, and stressed that the resolution provided broad guidelines to direct the work of the Committee. He maintained that the establishment of objective criteria should be undertaken by the Committee and not be imposed upon the members of the Committee at the subjective discretion of one member. He pointed out that the list of non-governmental organizations presented for a vote before the Committee did not include all the organizations whose applications had been deferred for at least four years and stated that the emphasis on objective criteria was flawed. He emphasized that it was the role of the Committee as an intergovernmental body to assess the credibility of the organizations before it and cautioned against the implication that some organizations were not genuine.

40. In a general statement after the vote, the representative of the United States of America expressed her delegation's disappointment at the results of the vote and stated that it demonstrated the politicization of the Committee and a misuse of the rights of the Committee under resolution 1996/31. She reiterated that the organizations brought before the Committee had been selected on the basis of specific criteria, including that their applications had been deferred for at least four years and that the organizations had all been responding to the Committee's questions satisfactorily. She further reiterated that the organizations concerned were credible in

line with resolution 1996/31. She stated that they had been thoroughly vetted by her delegation and that there were no concerns regarding their links to Governments, terrorism or corruption. She further noted that the organizations concerned worked in diverse locations, and she informed the Committee that they had all agreed to be brought to a vote before the Committee. She asserted that the Committee had failed to act within its mandate of opening space for civil society to participate in the work of the United Nations.

41. After the vote, the representative of the United States of America made a further general statement. She clarified that the list of nine organizations put forward for votes before the Committee did not comprise the entire list of organizations that fulfilled the criteria applied by her delegation and added that the motion by her delegation was an attempt to chip away at the list of many deferred organizations that met the criteria. She maintained that the criteria outlined by her delegation should be applied by all members of the Committee because it was based on the principles of resolution 1996/31. She further stated that the statements in explanations of vote, which had been made after the vote, had indicated that there were no credible concerns regarding the nine organizations. She stated that her delegation was working to establish the credibility of some of the organizations whose applications had been deferred for many years. She reiterated her delegation's view that the Committee was not abiding by resolution 1996/31. In that regard, she recalled that the Council had reversed the decision of a no-action motion by the Committee in July; she called upon the Committee to do more to fulfil its mandate.

42. The representative of Cuba pointed out that the criteria applied by the United States in selecting the nine organizations put to a vote before the Committee and the determination of the credibility of the organizations had been applied subjectively. He maintained that the subjective actions that had been taken violated the methods of work of the Committee and undermined the authority of the Committee.

Applications closed without prejudice

43. At its 27th meeting, on 7 September, the Committee decided to close without prejudice its consideration of the applications of 59 NGOs that had not responded to the Committee's questions despite three reminders sent to them (see chap. I, draft decision I, subpara. (e)).

B. New applications for consultative status and new requests for reclassification

44. The Committee considered item 3 (b) of its agenda, New applications for consultative status and new requests for reclassification, at its 15th to 18th meetings, held on 29 and 30 August, and at its 25th and 26th meetings, held on 6 September. The Committee considered a total of 216 new applications for consultative status.

New applications recommended

45. Of the 216 organizations whose new applications had been received, the Committee recommended that the following 142 should be granted consultative status with the Council (see chap. I, draft decision I, subpara. (a)):

C. Other related matters

Requests for a change of name

51. At its 24th meeting, on 2 September, the Committee considered and took note of seven new requests for a change of name submitted by organizations in consultative status (see chap. I, draft decision I, subpara. (b)).

IV. Strengthening of the Non-Governmental Organizations Branch; review of the methods of work of the Committee: implementation of Council resolution 1996/31; and general voluntary trust fund in support of the United Nations Non-Governmental Organizations Informal Regional Network

52. At its 15th meeting, on 29 August, the Committee jointly considered the following agenda items and heard oral reports made by the Secretariat: agenda item 5, Strengthening of the Non-Governmental Organizations Branch; agenda item 6, Review of the methods of work of the Committee: implementation of Council resolution 1996/31, including the process of accreditation of representatives of non-governmental organizations, and Council decision 1995/304; and agenda item 8, General voluntary trust fund in support of the United Nations Non-Governmental Organizations Informal Regional Network.

53. The Chief of the Non-Governmental Organizations Branch of the Department of Economic and Social Affairs of the Secretariat briefed the Committee on the work of the Branch, including the preparations for the Committee's consultations with NGOs in consultative status scheduled for 9 December 2022. He highlighted examples of the work of the Branch, including reviewing applications submitted by NGOs for consultative status with the Council and guiding them through the applications process; processing quadrennial reports submitted by NGOs in consultative status; facilitating the participation of NGOs in the work of the United Nations through the issuance of grounds passes; and supporting their registration at meetings and conferences held by the United Nations. He stated that, owing to the surge in both the number of applications for consultative status received by the Branch and the number of NGOs in consultative status with the Council (over 6,300), the workload of the Branch had increased exponentially, resulting in the accumulation of a backlog of applications. He reiterated the appeal of the Director of the Office of Intergovernmental Support and Coordination for Sustainable Development to the Committee and to Member States, made during the regular session, for support in securing additional human resources to facilitate the work of the Branch. He also informed the Committee that the new enhanced information technology system being developed to replace the old electronic platform currently used by the Non-Governmental Organizations Branch, was in its final testing phase and was scheduled to be rolled out by the end of 2022.

V. Special reports and complaints by Member States

54. At its 15th and 24th meetings, on 29 August and 2 September, the Committee considered agenda item 7, Special reports. The representative of Pakistan commended NGOs for their role in enriching discussions by bringing diverse perspectives and contributing to the activities of the various United Nations organs and subsidiary bodies in accordance with the principles and purposes set out in resolution 1996/31 and affirmed his delegation's commitment to facilitating the accreditation of credible national and international NGOs and enabling their constructive contributions to the work of the Organization within the Committee. He expressed regret, however, that some NGOs indulged in politically motivated disinformation campaigns targeting Member States. He recalled that his delegation had brought a complaint before the Committee, in a note verbale dated 4 January 2021, regarding nine organizations with consultative status that had carried out politically motivated disinformation campaigns targeting his country, in violation of resolution 1996/31. He welcomed the Committee's decision at the time to request specific information from the organizations regarding their activities, finances, membership and representatives, and expressed regret that the organizations had failed to respond fully to the Committee's requests. He noted that the activities of the organizations amounted to violations of resolution 1996/31, the Charter of the United Nations and national laws. He informed the Committee that his Government had initiated an investigation into the matter with a view to taking appropriate action against the organizations and stated that his delegation would revert to the matter at a later date. The Committee took note of the request by Pakistan to withdraw its complaint.

VI. Provisional agenda and documentation of the 2023 session of the Committee

55. At its 27 meeting, on 7 September, the Committee considered agenda item 9, Provisional agenda and documentation for the 2023 session of the Committee, and had before it the draft provisional agenda for its 2023 session ([E/C.2/2022/L.1](#)).

56. At the same meeting, the Committee decided to recommend to the Council the following dates for the sessions in 2023: regular session, from 23 January to 1 February and on 13 February; and resumed session, from 15 to 23 May and on 5 June.

VII. Organization of the session

A. Opening and duration of the session

57. The Committee on Non-Governmental Organizations held its 2022 resumed session from 29 August to 7 September and on 15 September. The Committee held 14 meetings.

58. At the 15th meeting, on 29 August, the Vice-Chair of the Committee at its 2022 resumed session made opening remarks. She stated that the increase in the number of applications for consultative status by non-governmental organizations from all over the world signified their strong interest in participating in the work of the United Nations and highlighted the important role of the Committee in facilitating their engagement. She announced that the Committee had decided to convene consultations with NGOs in consultative status with the Council on 9 December 2022 to exchange views on how to strengthen their engagement in the work of the United Nations, and that it had also held constructive discussions on the review of its working methods, to explore options with regard to the participation of NGO representatives in the question-and-answer segments of the Committee's sessions, including the possibility of incorporating a virtual component to the segments.

59. The representative of the United States of America emphasized the critical role of the Committee in elevating the voices of civil society at the United Nations and beyond, thereby enhancing the work of Member States. Noting the challenges faced by civil society organizations in making their voices heard on critical issues at the United Nations during the pandemic, she stressed that, in its efforts towards achieving the "new normal", the United Nations should actively re-engage with civil society in innovative ways to ensure inclusivity. She urged the Committee to reaffirm its commitment to ensuring transparent and fair NGO accreditation processes to facilitate civil society participation. She recalled the requirement, set out in paragraph 61 (a) of resolution 1996/31, for the Committee to hold consultations with NGOs in consultative status before each of its sessions. In that regard, she requested that the Committee ensure that such consultations were scheduled prior to all its sessions and welcomed the Committee's discussions at its informal sessions regarding long-term modalities for regular consultations.

60. Noting that the global pandemic had demonstrated the need for flexibility and innovation to ensure the participation of civil society in decision-making on policy, the representative of the United States of America urged the Committee to prioritize the use of technology to facilitate the participation of NGOs in its sessions. She stated that her delegation would continue to advocate the incorporation of a hybrid option in the Committee's question-and-answer segments. She added that it would benefit NGOs, in particular those in the global South, who might lack the means to travel to New York, and urged the Committee to demonstrate its willingness to hear their voices by considering the option without delay. She affirmed her delegation's commitment to increasing the accessibility and transparency of the Committee's work, including by amplifying civil society voices and pushing back against efforts to stifle them for politically motivated reasons.

61. The representative of Türkiye stressed the significance of the participation of non-governmental organizations in the work of the Council and its subsidiary bodies, as well as in United Nations conferences. He noted that international organizations

relied increasingly on the assistance of localized actors and civil society in confronting the multidimensional challenges facing the world. In that regard, he stressed that the contributions of NGOs were critical to achieving the Sustainable Development Goals set by the United Nations. The contributions of NGOs highlighted their role in enriching the knowledge and capacities of the Organization, their advocacy and their work in remote and inaccessible parts of the world. He welcomed the significant contributions of NGOs in consultative status with the Council and affirmed his delegation's support for the establishment of consultative relations with NGOs, in conformity with the spirit, purposes and principles of the Charter and within the framework of resolution 1996/31. He commended the Non-Governmental Organizations Branch for reducing the backlog of new applications and welcomed the steps taken by the Committee towards enhancing the transparency and efficiency of its work and in addressing its working methods. He further affirmed his delegation's position that resolution 1996/31 provided a solid basis for the Committee's work. He stated that the Committee should strive to implement its mandate by organizing consultations with NGOs in consultative status with the Council, without overburdening the Secretariat or affecting the Committee's work. He emphasized that the modalities of the consultations should be based on the principles of equity, transparency and fairness and expressed hope that those efforts would enable the Committee to fulfil its mandate in a more efficient and transparent way.

62. The representative of Mexico highlighted the devastating consequences of the coronavirus disease (COVID-19) pandemic around the world and its impact on the work of Governments and the United Nations as well as civil society. He pointed out that despite the challenges, the number of applications for consultative status had not decreased, demonstrating that non-governmental organizations were eager to collaborate with the United Nations, in the face of adversity. He welcomed the steps taken to improve the working methods of the Committee and thanked the Bureau and the Secretariat for providing information and opportunities for discussions to facilitate consensus on pertinent issues. He stressed the inevitable necessity to incorporate a virtual component in the interactive question-and-answer segments involving NGOs applying for consultative status. In that regard, he noted that the pandemic had demonstrated that virtual meetings would allow the Committee to offer an additional option to NGO applicants and encouraged the participation of organizations from all regions, especially those from developing countries, as mandated by the Council in resolution 1996/31. He welcomed the consultations of the Committee with organizations in consultative status prior to Committee sessions, as an integral part of the implementation of its mandate. In that regard, he emphasized that the Committee's functions were not limited to recommending the granting of consultative status, noting that the Committee was also responsible for monitoring the relationship between NGOs and the United Nations. The representative highlighted the long-standing role of civil society as an ally in advancing the ideals and objectives of the United Nations, as encapsulated in the phrase "We the peoples of the United Nations", as enshrined in the Charter. In that regard, he stressed that his delegation maintained an impartial stance so as to ensure greater diversity of voices and to enrich the strategies for solving the major challenges confronting humanity, noting that such strategies required multilateral collaboration. He called on all members of the Committee to take an impartial stance and prevent further applications from being deferred for long periods of time.

63. The representative of Estonia affirmed his delegation's strong support for the participation of non-governmental organizations in the work of the United Nations, noting that they created a vital link to civil society, whose views, experiences and contributions enabled the United Nations to fulfil its objectives. He stressed the need for the Committee to be more efficient in fulfilling its mandate by avoiding unjustified

delays of applications and by upholding the principles of resolution 1996/31. He welcomed the interactive consultations with NGOs in consultative status scheduled for 9 December 2022 and called for the continuation of similar meetings on a regular basis, in order to bring the Committee into closer contact with civil society representatives, in line with its mandate. He urged the Committee to seek ways of modernizing its engagement with NGOs and added that the introduction of a hybrid component to the question-and-answer segments would be a positive step towards a more effective Committee.

64. The representative of Greece expressed confidence that the Committee's work during the session would contribute to the enhancement of the participation and the role of the civil society in the Council and the United Nations system. He stated that the Committee's lengthy and drawn-out processes involved in the screening of NGO applications had prevented hundreds of NGOs from receiving consultative status. He stressed that it was time for meaningful reform in order to put an end to the practice of groundless deferrals and asymmetric practices, including duplicative questioning, especially with respect to NGOs working on human rights. He urged the Committee to enhance both the in-person and remote participation of NGOs, on the basis of the lessons learned during the COVID-19 pandemic in order to fortify the representation of NGOs from all regions. He affirmed his delegation's commitment to working towards strengthening the role of civil society in the United Nations and other forums.

65. The representative of Cuba welcomed the briefing on the Secretariat's work. He noted that the public list of NGOs in consultative status with the Council on the website of the Non-Governmental Organizations Branch had not been updated since 2019 and requested the Secretariat to issue an updated information list to give visibility to all NGOs in consultative status with the Council. He further requested the Secretariat to ensure that members of the Committee were given adequate time to familiarize themselves, before the next session of the Committee, with the new information technology platform that was being developed to replace the current system. He emphasized that it was critical to respect the role of the Committee and its right to scrutinize and review all issues on the agenda, including applications for consultative status, quadrennial reports and all issues related to the implementation of its mandate. He further stressed that it was crucial to ensure that the consultations with NGOs in consultative status with the Council were inclusive and transparent in order to ensure the participation of NGOs from all regions of the world, especially those from the South and developing countries. In that regard, he noted that the Secretariat should circulate the list of participants in advance in order to ensure transparency for the benefit of the non-governmental organizations, the Committee and the United Nations community. He further noted that the deliberations regarding the incorporation of a hybrid component in the Committee's question-and-answer segments were ongoing, and he affirmed his delegation's commitment to working towards a consensus to establish arrangements that would facilitate the participation of NGOs from all regions of the world, on an equitable regional and geographical basis.

66. The representative of China expressed his delegation's support for the positive role of NGOs and highlighted its efforts in promoting their participation in United Nations activities in an orderly manner. He noted that NGOs applying for consultative status with the Council must comply with the provisions of resolution 1996/31. In that regard, he emphasized that the members of the Committee had a responsibility and obligation to examine NGOs applying for consultative status to ensure that they aligned with the provisions of the resolution. He stressed that members of the Committee should respect the working methods and established procedures of the Committee, in order to maintain its authority. He pointed out that there were currently over 6,000 organizations in consultative status with the Council, indicating that many

organizations were recommended for consultative status every year. He commended the Secretariat for overcoming the challenges related to its huge workload and limited resources and for effectively supporting the Committee to fulfil its mandate. He noted that the Committee had successfully reviewed all the applications before it in an efficient manner and had demonstrated that the existing working methods were practical and feasible. He emphasized that any change to the working methods of the Committee should be in accordance with the relevant resolutions and established procedures. He reaffirmed his delegation's commitment to safeguarding the authority of the Committee and facilitating the participation of non-governmental organizations in the work of the United Nations.

67. The representative of the European Union, in its capacity as observer, also on behalf of Albania, Georgia, Liechtenstein, Monaco, Montenegro, North Macedonia, the Republic of Moldova and Ukraine, recalled that Member States had pledged, during the commemoration of the seventy-fifth anniversary of the United Nations, to strengthen global governance for the sake of present and future generations. He stated that civil society was an indispensable partner, in that regard highlighting its work in reporting on situations on the ground, helping public actors find solutions to challenges faced by societies and encouraging efforts to implement agreed frameworks, including the 2030 Agenda for Sustainable Development, the Paris Agreement and other relevant human rights agreements. He emphasized that the Committee had a vital role to play in the United Nations system and stated that it could not be a place in which NGOs were treated arbitrarily or discriminated against or in which good faith applicants experienced prolonged and unjustified deferrals over many years.

68. The representative of the European Union, in its capacity as observer, further stated that the reform of the Committee was needed in order to allow for its more inclusive, effective, fair and transparent functioning, including through limits to deferrals and a process to reconsider arbitrary or erroneous decisions on deferral or denial. He pointed out that many NGOs had been waiting to be accredited for many years, despite having demonstrated that they fulfilled the criteria set by the Council in resolution 1996/31 and having engaged constructively with the Committee on their applications for consultative status. He stated that the Council had a responsibility to systematically review the decisions of the Committee and to reverse them when misjudgements were identified. In that regard, he noted the decision of the Council to grant special consultative status to six non-governmental organizations and stressed that it had previously exercised its final decision-making authority in cases in which the Committee had failed to fulfil its mandate. He stated that there was no justification to further delay consideration of applications that had been pending for a very long time, including the International Dalit Solidarity Network and Associazione Luca Coscioni per la Libertà di Ricerca Scientifica, and urged the Committee to recommend them for consultative status.

69. The observer for the United Kingdom of Great Britain and Northern Ireland emphasized the important role of the Committee and underscored the vital significance of civil society to the work of the United Nations. He noted that civil society contributed to enriching the Organization's information base and ensuring the impact of its work on the ground. He affirmed his delegation's commitment to championing civil society participation at the United Nations and expressed regret at the efforts of a small number of member States to stifle the voices of NGOs. In that regard, he noted the politicization of the Committee and the worrying increase in reprisals against organizations that sought to engage with the United Nations. He welcomed the motion by some delegations, at the regular session of the Committee, to bring the applications of several non-governmental organizations that had been deferred for many years to a vote before the Committee. He expressed disappointment

that the vote had been blocked by a no-action motion, but welcomed the decision by the Council to grant consultative status to the organizations. He reiterated that his delegation would work with other members to improve the working methods of the Committee by making it more transparent and less susceptible to arbitrary deferrals. He stressed that the role of the Committee was to facilitate and not to impede NGO access and urged the Committee to fulfil the collective commitment to inclusive multilateralism by addressing the backlog of deferred applications fairly and transparently and by promoting a safe and welcoming space for civil society to voice its views.

70. In her closing remarks, at the 27th meeting, on 7 September, the Vice-Chair of the Committee commended the Committee for its work and noted that the 2022 regular and resumed sessions were marked by several improvements in the Committee's working methods, including the early review of both new and deferred applications and their distribution in lists 1 and 2 well ahead of the sessions. She welcomed the discussions of the Committee during its informal meetings on the improvement of its working methods and on the mandated consultations with NGOs in consultative status with the Council pursuant to paragraph 61 (a) of resolution 1996/31.

71. At the same meeting, the Committee adopted the addendum to the report of the Committee on its 2022 regular session ([E/2022/32 \(Part II\)/Add.1](#)).

B. Attendance

72. The session was attended by 17 members of the Committee. Observers for other States Members of the United Nations and for non-member States and representatives of organizations of the United Nations system and NGOs also attended. The list of participants will be issued in document [E/C.2/2022/INF/2](#).

73. At its 2022 resumed session, the Committee heard five representatives of NGOs, who were given the opportunity to respond to questions raised by the Committee. The additional information provided by the representatives facilitated the debate and the work of the Committee in taking its decisions.

C. Election of officers

74. At its 15th meeting, on 29 August, the Committee took note of the resignation of Alejandro González Behmaras (Cuba) from his position as Vice-Chair.

75. The Bureau of the resumed session consisted of Mine Ozgul Bilman (Türkiye) as Vice-Chair.

78. At its 28th meeting, on 15 September, the Committee adopted the present report.
