Report of the United Nations Group of Experts on Geographical Names on its 2023 session

(New York, 1-5 May 2023)

Summary

The 2023 session of the United Nations Group of Experts on Geographical Names was held at United Nations Headquarters from 1 to 5 May 2023, in accordance with Economic and Social Council decision 2021/261.

The present report describes the activities during the session and presents the major findings of the Group of Experts, focusing primarily on the importance of its work to support Member States in the collection, standardization and dissemination of geographical names and the establishment of national geographical names authorities.

I. Matters calling for action by the Economic and Social Council or brought to its attention

A. Recommendations for adoption by the Council

1. The United Nations Group of Experts on Geographical Names recommends to the Economic and Social Council the adoption of the following:

Recommendation 1

The Economic and Social Council commends the achievements and the ongoing work of the United Nations Group of Experts on Geographical Names on the standardization of geographical names and its contribution to the management and monitoring of the Sustainable Development Goals and decides to support cooperation between the Group of Experts and United Nations Maps.

Recommendation 2

The Economic and Social Council decides that the appropriate working groups of the United Nations Group of Experts on Geographical Names, namely, the Working Groups on Geographical Names Data Management, on Geographical Names as Cultural Heritage and on Romanization Systems, shall work to populate the World Geographical Names Database in order to ensure that toponyms are accurately reflected across all languages, including those with non-Roman alphabets or scripts, to strengthen relationships, links and connections in geographical names standardization, and in this regard requests:

- (a) The mobilization of resources to support the integration of other toponymic datasets in the Database, including those pertaining to culture, heritage and identity;
- (b) A report that explores the role of semantic web technologies in the context of the World Geographical Names Database and provides recommendations, where appropriate, to the Group of Experts at its 2025 session for consideration;
- (c) The Statistics Division of the Department of Economic and Social Affairs and the Geospatial Information Section of the Office of Information and Communications Technology to work with the Group of Experts through its Bureau and working groups to review existing data within the World Geographical Names Database and work with Member States to resolve linguistic, geographical and other data quality issues.

Recommendation 3

The Economic and Social Council:

- (a) Takes note of the report of the United Nations Group of Experts on Geographical Names on its 2023 session (E/2023/84);
- (b) Decides that the 2025 session of the Group of Experts shall be held from 28 April to 2 May 2025;
 - (c) Approves the provisional agenda of the 2025 session (GEGN.2/2023/L.1).

B. Decisions brought to the attention of the Council

2. The following decisions adopted by the Group of Experts are brought to the attention of the Council:

Decision 3/2023/1 Report of the Chair

The Group of Experts:

- (a) Took note of the report of the Chair of the Group of Experts;
- (b) Appreciated the leadership of the Chair, the work of the Bureau and the working group conveners and the support from the Statistics Division in arranging and preparing for the 2023 session;
- (c) Encouraged the adoption of good practices of the Group of Experts in order to advance the integration of the Strategic Plan over the next six years, such as the prioritization of work products and recording of all the strategies and actions of the Group of Experts in the Strategic Plan and Programme of Work 2021–2029, grounding decisions in the principles of the United Nations and further mobilization of the linguistic/geographical divisions as well as all stakeholders.

Decision 3/2023/2 Report of the Secretariat

The Group of Experts:

- (a) Expressed appreciation for the report of the Secretariat and the call to strengthen the operations and work of the Group of Experts;
- (b) Noted that the Secretariat had suggested an approach to address the review of the working groups, and committed to further discussion on providing guidance on how that exercise might be efficiently conducted;
- (c) Welcomed the model national report submitted by the East Central and South-East Europe Division;
- (d) Called for the organization of an appropriate framework to support the strengthening or creation of national names authorities as well as a Group of Experts trust fund.

Decision 3/2023/3 National reports

The Group of Experts:

- (a) Took note of the reports submitted by 52 countries under this agenda item and expressed appreciation for the thematic consideration of those reports in the form of a national dialogue addressed throughout the session;
- (b) Noted that the reports covered themes including national names standardization processes, cultural aspects of geographical names such as Indigenous and minority names, technology and toponymic databases, promotion and training on geographical names and collaboration between two or more Member States and with academia, and that the presentations engendered wide-ranging discussion and concluded with a call to consider greater work emphasis on topics such as crowd sourcing and data validation;
- (c) Encouraged experts to refer to the full national reports to use as a guide to inform on topics of common interest in national geographical names standardization.

Decision 3/2023/4

Activities on the standardization of geographical names in Africa

The Group of Experts:

- (a) Took note of the report submitted by the Coordinator of the Task Team for Africa and expressed appreciation for the continued activity of the Task Team, despite the impacts of the coronavirus disease (COVID-19) pandemic;
- (b) Noted the holding of a well-attended meeting with lively debate, in Addis Ababa in October 2022, stressing the importance of the standardization of geographical names and expressing the desire to revitalize existing structures or to create new ones for countries that did not yet have them;
- (c) Recognized that the Task Team for Africa had decided to promote and elevate the already existing Sub-Working Group on Standardization of Geographical Names in Africa into a Working Group on the same level as the four existing Working Groups of the United Nations Global Geospatial Information Management Regional Committee for Africa;
- (d) Acknowledged the long history of the Task Team for Africa, and its regular meetings and active partnerships, while noting that many African countries still had to establish geographical names management structures;
- (e) Regretted the relatively small number of African States represented at the 2023 session of the Group of Experts.

Decision 3/2023/5

Monitoring and evaluation of the Strategic Plan and Programme of Work 2021–2029 and of the work of the Group of Experts

The Group of Experts:

- (a) Welcomed the report and the work of the Bureau and working group conveners on the implementation of the Strategic Plan and Programme of Work 2021–2029 during the two years since its adoption, affirming the need to continue to contribute to its implementation in order to ensure its success;
- (b) Reaffirmed that the Strategic Plan and Programme of Work 2021–2029 would continue to serve as a guiding framework for the Group of Experts and for geographical names standardization of Member States;
- (c) Supported the adoption of the amendments to action items 1-i-5, 2-i-5, 2-iii-10, 3-iii-10, 5-i-1 and 5-ii-3 in the Strategic Plan and Programme of Work 2021–2029 proposed by the Bureau;
- (d) Agreed to consider and express views on priorities to be decided in the implementation of the Strategic Plan and Programme of Work 2021–2029;
- (e) Encouraged Member States to align their standardization activities to the Strategic Plan and Programme of Work 2021–2029.

Decision 3/2023/6 Reports of the divisions

The Group of Experts:

(a) Took note of the report of the Bureau and the Secretariat of the Group of Experts and the reports submitted by divisions;

- (b) Acknowledged the need expressed by some divisions for more support from the Bureau and the Secretariat, including space on the website to archive divisional matters:
- (c) Adopted the guideline entitled "Responsibilities of Divisional Chairs and Executive Group";
- (d) Encouraged Member States to participate in divisional activities and to revitalize inactive divisions;
- (e) Encouraged the divisions to actively contribute to the implementation of the Strategic Plan and Programme of Work 2021–2029 on the strategies and related actions as outlined in table 4 entitled "Strategic Plan and Programme of Work work items relevant to Divisions" of the report of the Bureau and the Secretariat.

Decision 3/2023/7

National and international meetings and conferences

The Group of Experts took note of the two reports on national and international meetings and conferences and acknowledged the efforts demonstrated by those meetings and conferences.

Decision 3/2023/8

Cooperation and liaison with other international organizations

The Group of Experts:

- (a) Welcomed and noted the reports on liaison with other organizations;
- (b) Reaffirmed the importance of relationships between the Group of Experts and the organizations with which it maintains liaison;
- (c) Noted the invitation to the Group of Experts extended by the Joint International Cartographic Association/International Geographical Union Commission on Toponymy to join the Commission;
- (d) Called upon the International Council of Onomastic Sciences to report on the proceedings of its 2024 Congress;
- (e) Endorsed the International Principles and Procedures for Antarctic Place Names, noted with appreciation the contribution of experts of the United Nations Group of Experts on Geographical Names to that document, and encouraged the member countries of the Scientific Committee on Antarctic Research to use the principles and procedures;
- (f) Supported further cooperation with the United Nations Geospatial Network and United Nations Maps and in that regard urged:
 - (i) That the United Nations Group of Experts on Geographical Names explore collaboration with the United Nations Maps programme on geographical names, led by the Geospatial Information Section of the Office of Information and Communications Technology, as a means to operationalize the work and knowledge of the Group of Experts through the delivery of various mandates of the United Nations system;
 - (ii) That the United Nations Geospatial Network of the Committee of Experts on Global Geospatial Information Management and appropriate representatives of the United Nations Group of Experts on Geographical Names establish an appropriate mechanism to promote the work and importance of the Group of Experts and geographical names to the United Nations system, in particular by

highlighting the important role of the geographical names theme, one of the global fundamental geospatial data themes;

(g) Recognized the activities and progress that the International Hydrographic Organization had achieved in naming undersea and maritime features and encouraged national names authorities to submit proposals for undersea feature names to the International Hydrographic Organization/Intergovernmental Oceanographic Commission Subcommittee on Undersea Feature Names and to promote the work of undersea feature names standardization within their respective programmes of work.

Decision 3/2023/9

Cooperation and liaison with the Committee of Experts on Global Geospatial Information Management

The Group of Experts:

- (a) Took note of two reports on strengthening collaboration with the Committee of Experts on Global Geospatial Information Management;
- (b) Recognized that the Committee of Experts had acknowledged and supported the proposal to collaborate on the development of a compendium of institutional arrangements on shared good practices for geographical names standardization between national mapping and geospatial agencies and national names authorities, to increase cooperation, create synergies and share knowledge and good practices for the standardization of geographical names;
- (c) Welcomed the offer by Indonesia to assist with the development of a compendium of good practices of the Group of Experts and the Committee of Experts at the national level.

Decision 3/2023/10

National and international standardization of geographical names: names collection, office treatment, national authorities, features beyond a single sovereignty and international cooperation; toponymic guidelines for map and other editors for international use

The Group of Experts:

- (a) Took note of the reports and welcomed the interesting exploration of issues and achievements emerging in the range of national standardization programmes;
- (b) Encouraged experts to continue developments in naming principles and procedures relevant to their geographical context and report them to the Group of Experts;
- (c) Welcomed the recent updates to the inventory of toponymic guidelines and their dissemination through the website of the Group of Experts, recognizing the reference value of the guidelines to the Group of Experts;
- (d) Encouraged Member States to prepare new guidelines or update existing ones and report to the Group of Experts at its subsequent sessions.

Decision 3/2023/11

Social and economic benefits, supporting sustainable development, measures taken and proposed for the implementation of resolutions

The Group of Experts:

(a) Welcomed the reports and expressed appreciation for the breadth of information made available, such as benefits of names standardization in case of

disaster response, establishing naming and renaming principles, legislative requirements for public participation, and resolution of a disputed case;

- (b) Appreciated the progress made by the Working Group on Evaluation and Implementation on the Strategic Plan and Programme of Work 2021–2029, motivating the implementation of resolutions and recommendations and maintaining and updating the multilingual database for resolutions and recommendations with the technical support of the National Geographic Information Institute of the Republic of Korea:
- (c) Supported the proposed change from working group convener to a coordinator for the functions that continued to be needed;
- (d) Also supported the suggestion that the Bureau and the Statistics Division enable the collection of procedural guidelines for national naming authorities and that they publish guidelines that include approaches to geographical name changes.

Decision 3/2023/12

Issues of publicity for the Group of Experts and funding of Group projects

The Group of Experts:

- (a) Took note of the report and appreciated the work of the Working Group on Publicity and Funding during the intersessional period on raising awareness;
- (b) Welcomed the publication of themed issues of the United Nations Group of Experts on Geographical Names Information Bulletin and called for the continued identification of themes relevant to geographical names standardization;
- (c) Encouraged further exploration of creating a Group of Experts trust fund to be used to support the participation of developing countries and to conduct toponymic training events;
- (d) Noted with regret that the current working group convener had stepped down.

Decision 3/2023/13

Toponymic education

The Group of Experts:

- (a) Took note of the reports and welcomed the developments in online training courses in toponymy developed by the Group of Experts;
- (b) Noted the good practices of Member States supporting each other in geographical names standardization capacity-building and training initiatives at the regional, bilateral and national levels and encouraged the continuation of those efforts;
- (c) Supported efforts to restore, empower, promote and preserve geographical names of Indigenous heritage by making them available as spatial datasets;
- (d) Noted with interest the suggestion to explore with the Unicode Consortium adding missing characters to the Unicode character set;
- (e) Welcomed the upcoming training course on toponymy to be held in Bali, Indonesia, for the Asia South-East Division and encouraged Member States to submit requests for training to the Working Group on Training Courses in Toponymy.

Decision 3/2023/14 Toponymic terminology

The Group of Experts:

- (a) Took note of the reports, expressed appreciation for the preparation of glossaries of geographical terms and encouraged such reports in future sessions;
- (b) Requested Member States to continue to suggest, and the Working Group on Toponymic Terminology to address, proposals for additions, modifications and corrections to the database of toponymic terminology;
- (c) Endorsed the recommendations of the Working Group for additions and changes to the terminology database.

Decision 3/2023/15

Geographical names as culture, heritage and identity, including Indigenous, minority and regional languages and multilingual issues

The Group of Experts:

- (a) Took note of the reports and appreciated the wide range of topics shared, including map products, regulations, best practice for Indigenous naming, derogatory names, world heritage sites, Indigenous and minority language names, commercial and commemorative naming, legislation, policies and best practices;
- (b) Supported the continuation of the sharing of national experiences and engagement, especially noting the increased attention by the Group of Experts on the importance of all cultural heritage matters;
- (c) Acknowledged the collective increased awareness of the Group of Experts of the emotional and spiritual aspects of cultural heritage in geographical naming, which offer improved connection, identity and belonging, contributing to equitable recognition of Indigenous geographical names.

Decision 3/2023/16 Exonyms

The Group of Experts:

- (a) Took note of the reports and reaffirmed decision 2/2021/12 on exonyms taken at its 2021 session;
- (b) Decided that there was a need to issue a recommendation, for consideration at the 2025 session of the Group of Experts, that reconciles the resolutions of the United Nations Conference on the Standardization of Geographical Names on exonyms and its acknowledgement of exonyms as part of cultural heritage, and that the Working Group on Exonyms should continue further discussions towards achieving this;
- (c) Appreciated the work and deliberation on exonyms conducted by the experts during and subsequent to the meeting of the Working Group held in Ljubljana, Slovenia, in 2022.

Decision 3/2023/17

Report of the Secretariat - World Geographical Names Database

The Group of Experts:

(a) Welcomed the report of the Secretariat and commended the redevelopment of the World Geographical Names Database as a global repository of toponymic data

that would help to raise awareness and promote the use of national standardized names on maps and in documents;

- (b) Urged Member States to contribute to the Database to ensure that toponyms were accurately reflected across all languages, including those with non-Roman alphabets or scripts, to strengthen relationships, links and connections in geographical names standardization;
- (c) Welcomed the support of its Working Group on Geographical Names Data Management to consider an appropriate data governance mechanism with the Secretariat, and in that regard:
 - (i) Welcomed the concept of a unique and standardized identifier for cities and other geographical features within the Database;
 - (ii) Requested the Statistics Division, within available resources, to enhance the functionality of and data in the Database;
- (d) In recognition of the potential value of incorporating semantic web technologies to link the database to a broader data ecosystem, called for the relevant working groups and the Statistics Division to explore ways to further enhance the capabilities of the Database to support linked open data applications and advance the use of authoritative, multilingual geographical names across multiple data platforms;
- (e) Welcomed the offers of assistance in terms of data and support and in that regard urged greater mobilization of resources to support the integration of other toponymic datasets in the Database, including those pertaining to culture, heritage and identity.

Decision 3/2023/18

Geographical names data management

The Group of Experts:

- (a) Welcomed the information made available, the active participation and the efforts undertaken by Member States to inform about and enhance geographical names data management;
- (b) Took note of the reports and affirmed the support for strategy 1, Technical expertise, of the Strategic Plan and Programme of Work 2021–2029, outlined for the Working Group on Geographical Names Data Management for the period 2023–2025, and the willingness of Member States to participate and contribute to the action items identified within the Programme of Work;
- (c) Reaffirmed that linked data was another stage in the evolution of data management methodologies of the Group of Experts;
 - (d) Encouraged Member States:
 - (i) To consider linked data in their approaches to geographical names standardization:
 - (ii) To contribute further to the monitoring of the availability of free, easily accessible, and authorized data on digital geographical names;
- (e) Requested the Working Group to continue to facilitate collaboration and workshops on technical issues between national names authorities and practitioners in order to provide practical guidance on organizational and technical issues and processes;

- (f) Also requested the Working Group to further coordinate the monitoring of the availability of free, easily accessible and authorized data on digital geographical names:
- (g) Further requested the Working Group to take action on the publication of the content and invite standardization bodies to provide input and comments on the ideas presented on:
 - (i) Geospatial information-sharing, accessibility and dissemination-related standards:
 - (ii) Specific issues related to geographical names data modelling.

Decision 3/2023/19

Writing systems and pronunciation

The Group of Experts:

- (a) Welcomed the report, acknowledged the outstanding contribution of a Co-Convener during 25 years of service, and noted with regret his intention to step down from the convenership;
- (b) Agreed to continue to investigate innovative methods to be used for romanization;
- (c) Noted the work on transliteration between non-Roman script writing systems and encouraged Member States to continue such projects;
- (d) Encouraged all Member States to continue to share ongoing work with the Working Group on Romanization Systems towards further implementation of existing United Nations romanization systems and towards the adoption of new national systems.

Decision 3/2023/20

Other geographical names issues

The Group of Experts:

- (a) Took note of the reports and adopted the updated Group of Experts list of country names;
- (b) Decided to replace the Working Group on Country Names with a Coordinator to update the list of country names;
- (c) Noted that the current acting Chair of the Asia East Division (other than China) had stepped down and that his interest in establishing a language-based division in Asia (shared writing system of Chinese characters) would be passed on to his successor.

Decision 3/2023/21

Future of the Working Group on Publicity and Funding and the Working Group on Evaluation and Implementation

The Group of Experts:

- (a) Supported the disbanding of the Working Group on Publicity and Funding and of the Working Group on Evaluation and Implementation;
- (b) Welcomed the transfer of the work on publicity to the newly established Coordinator for Evaluation and Implementation, under the name Coordinator for Evaluation, Implementation and Publicity;

(c) Acknowledged the transfer of the work on funding to the Working Group on Training Courses in Toponymy.

Decision 3/2023/22

Strengthening relationships, links and connections

The Group of Experts:

- (a) Welcomed the theme of its 2023 session, "Strengthening relationships, links and connections in geographical names standardization and for sustainable development and pandemic recovery";
- (b) Also welcomed the convening of the panel discussion on the same theme, noting with appreciation the interests and diverse viewpoints expressed by five panellists;
- (c) Recognized that strengthening relationships, links and connections between the Group of Experts and other actors related to geographical names, including national naming authorities, bodies of the United Nations, scientific, technical and academic groups, and private map-makers or map users, would increase the capacity to achieve the Sustainable Development Goals and aid recovery from the pandemic, but also that there were restrictions and barriers;
- (d) Requested the Bureau and relevant working groups to take measures to find organized ways of sharing expertise on geographical names standardization and proper dissemination and correct use of standardized geographical names.

II. Items considered by the Group of Experts

A. Reports of the Chair and the Secretariat

- 3. The Group of Experts considered item 3 of its agenda at its 1st and 8th to 10th meetings, on 1, 4 and 5 May 2023. It had before it the report of the Chair (GEGN.2/2023/3), which was presented by the Chair of the Group of Experts, the report of the Secretariat (GEGN.2/2023/4/CRP.4) and the document entitled "World Geographical Names Database" (GEGN.2/2023/111/CRP.111), which were introduced by the representatives of the Secretariat.
- 4. At the 1st and 8th meetings, on 1 and 4 May, the Chair, representatives of the Norden Division, the United States of America/Canada Division, the United Kingdom Division, the Arabic Division, the Africa West Division, the Dutch- and Germanspeaking Division, the South-West Pacific Division, the China Division and the Asia South-East Division made comments and raised questions, to which the representatives of the Secretariat responded. The Chair and the representatives of the Secretariat made summary statements.

Action taken by the Group of Experts

5. At its 9th meeting, on 5 May, the Group of Experts adopted two draft decisions submitted by the Rapporteurs (see sect. I.B, decisions 3/2023/1 and 3/2023/2). At its 10th meeting, on 5 May, the Group of Experts adopted one draft decision submitted by the Rapporteurs, as orally revised (see sect. I.B, decision 3/2023/17).

B. Reports (national, divisional, activities on the standardization of geographical names in Africa and national and international meetings and conferences)

6. The Group of Experts considered item 4 (a) to (d) concerning national and divisional reports and reports on activities on the standardization of geographical names in Africa and national and international meetings and conferences, at its 1st, 2nd, 3rd, 5th, 7th, 9th and 10th meetings, from 1 to 5 May 2023.
