## **1. Al Mezan Center for Human Rights**

**Special, 2010**

### **Introduction**

Al Mezan Center for Human Rights (Al Mezan) is an independent non-profit human rights organization based in the Gaza Strip, State of Palestine.

### **Aims and purposes of the organization**

Al Mezan aims to promote the respect, protection and promotion of human rights and democracy in the State of Palestine to enable its population to enjoy the benefits of social justice and human rights through international law, the rule of law and good governance.

### **Significant changes in the organization**

Al Mezan joined the International Federation for Human Rights (FIDH) in 2013 and launched the Palestinian Human Rights Organizations' Council (PHROC) in 2010.

### **Contribution of the organization to the work of the United Nations**

The organization collaborated with the United Nations in Gaza, State of Palestine, through participation in the Protection Cluster, coordinated by the Office of the High Commissioner for Human Rights (OHCHR), and the 1612 Working Group led by the United Nations International Children's Fund (UNICEF), among others. It provided information, data and analysis to the OHCHR and the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA). It submitted 61 communications to Special Procedures of the OHCHR.

### **Participation in meetings of the United Nations**

Al Mezan participated in the 16th, 18th, 19th, 21st and 22nd Session of the United Nations Human Rights Council (HRC). The organization also submitted a "Letter from Human Rights Organisations to the United Nations Special Coordinator for the Middle East Peace Process", 6 April 2013, and delivered a joint oral intervention during the 99th Session of the Human Rights Committee, Israel's 3rd report review (ICCPR), Geneva, Switzerland, 13-14 July 2010.

### **Cooperation with United Nations bodies**

Al Mezan collaborated with the following United Nations bodies, among others:

- UNICEF: it organized 18 symposia on child rights and protection and HIV/AIDS; collaborated on children in conflict and juvenile justice issues; and trained 27 education-supervisors on child rights and protection, 2012;
- United Nations Educational, Scientific and Cultural Organization (UNESCO): it strengthened schools' documentation-reporting to protect education rights, 2011-2012; and

- United Nations Development Programme (UNDP): it provided legal advice on human rights violation victims; and launched juvenile justice and building materials campaigns in 2013.

### **Initiatives taken by the organization in support of the Millennium Development Goals**

The organization promoted democracy and human rights to create a stable government. It worked to alleviate poverty and extreme hunger. It monitored and reported on economic and social rights violations, with a women and child focus. It empowered women and promoted gender-equality by strengthening national capacities and conducting gender-focused legal interventions.

### **Additional information**

UNRWA awarded two children's human rights prizes to Al Mezan in 2010.

## **2. Association des états généraux des étudiants de l'Europe**

### **Special, 1998**

#### **Introduction**

Founded in 1985 in Paris, France, L'Association des états généraux des étudiants de l'Europe (AEGEE) is one of Europe's biggest interdisciplinary student organizations.

#### **Aims and purposes of the organization**

AEGEE strengthens mutual understanding among young Europeans and brings Europe closer to young people. It aims, through its activities, to empower students and young people in Europe to take an active role in society; create a space for dialogue and learning opportunities; and act as their representative towards decision-makers.

#### **Significant changes in the organization**

There have been no significant issues.

#### **Contribution of the organization to the work of the United Nations**

AEGEE conducts many activities that contribute to the work of the United Nations, including the following:

- The 25 Years of Summer University Project, which promotes European integration and cultural exchanges;
- Easter Partnership Project, to promote the idea of active citizenship; empower youth regarding citizens' rights and duties; and build mutual understanding and trust between people from the Eastern Partnership countries;
- Election observation team which organizes observation missions to democratic processes taking place in European countries;

- Youth Employment Working Group that supports youth in entering the job market; and
- Footprint project aiming at decreasing young European's ecological footprint.

### **Participation in meetings of the United Nations**

The organization attended TUNZA International Youth Conference of the United Nations Environment Organization (UNEP), with the goal to prepare recommendations for the Governing Council of UNEP and the Global Ministerial Environment Forum and launch the Global Environment Outlook-5 (GEO-5) for Youth, Nairobi, Kenya, 10-14 February 2013. AEGEE also attended the Regional Youth Forum organized by the United Nations Population Fund (UNFPA) and the United Nations Economic Commission for Europe (UNECE), Istanbul, Turkey, 29-31 May 2013.

### **Cooperation with United Nations bodies**

AEGEE cooperates with UNEP, the United Nations Educational, Scientific and Cultural Organization (UNESCO) and the United Nations Human Settlements Programme (UN-Habitat).

### **Initiatives taken by the organization in support of the Millennium Development Goals**

The organization's Environmental Working Group (EWG) supports the work of the United Nations on ensuring environmental sustainability. It also aims to integrate environmental issues into AEGEE's main fields of action; raise awareness on environmental issues within AEGEE and European youth; and facilitate discussions and provide information on the topic.

## **3. Building and Social Housing Foundation**

### **Special, 2006**

#### **Introduction**

The Building and Social Housing Foundation (BSHF) is an independent housing research organization that promotes sustainable development and innovation in housing. It is based in the United Kingdom of Great Britain and Northern Ireland and works nationally and internationally. It works with partners worldwide.

#### **Aims and purposes of the organization**

BSHF believes that everyone should have access to decent housing. It acts as a catalyst for change by identifying great housing ideas and best practice from around the world; transferring ideas and practices to places where they are needed most; and helping new ideas grow, so they benefit the people who need them.

#### **Significant changes in the organization**

There have been no significant changes.

**Contribution of the organization to the work of the United Nations**

BSHF financed eight international week-long knowledge transfer visits to staff members from United Nations organizations. BSHF has contributed case studies to the Civil Society Network web portal and the United Nations NGO Informal Regional Network Best Practice website. It provides information annually to all United Nations Information Centres worldwide, highlighting examples of innovative housing practice. BSHF organised four three-day consultations to address issues in the United Kingdom and beyond that relate to the Habitat Agenda.

**Participation in meetings of the United Nations**

BSHF attended the World Urban Forums and organized side events in Rio De Janeiro, Brazil, in 2010, and Naples, Italy, in 2012.

**Cooperation with United Nations bodies**

BSHF cooperates in a wide variety of ways with the United Nations Human Settlements Programme (UN-Habitat), including by partnering for the last 25 years in the organization of World Habitat Day and inviting United Nations representatives to attend its high-level annual housing policy meetings. BSHF also organizes the annual World Habitat Awards completion. The awards are presented at a UN-Habitat event each year by the organization's Director General.

**Initiatives taken by the organization in support of the Millennium Development Goals**

BSHF has contributed to MDG 7. BSHF is a partner in the Power House Europe projects funded by the European Union to encourage the sharing of good practice in environmental building technologies by social housing providers throughout Europe. BSHF helped support the development of the Green Mortgage Programme in Mexico and supported identification of good practice of the Global Community Champions programme in Canada, the Earth Roof for the Sahel project in Burkina Faso and the Renewable Energy for Farmers Programme in the People's Republic of China. BSHF has also supported the identification of good practice in terms of improving the living conditions of populations living in slums.

**4. Bundesarbeitsgemeinschaft der Senioren-Organisationen****Special, 1998****Introduction**

The German National Association of Senior Citizens Organisations (BAGSO) was founded in 1989. It acts at a national level as an umbrella organization of more than 100 senior citizens' associations, representing around 13 million German senior citizens.

**Aims and purposes of the organization**

BAGSO aims at promoting independence in old age and securing the necessary conditions. It wants senior citizens to have the opportunity to play an active role in society and create a more positive image of old age in public.

**Significant changes in the organization**

There have been no significant changes.

**Contribution of the organization to the work of the United Nations**

No contribution was specified.

**Participation in meetings of the United Nations**

Among other United Nations conferences, BAGSO attended the United Nations Economic Commission of Europe's (UNECE) Ministerial Conference on Ageing as part of the official German delegation, Vienna, Austria, 2012. BAGSO was also representative of civil society and one of the authors of the NGO declaration.

**Cooperation with United Nations bodies**

The organization collaborated with the UNECE.

**Initiatives taken by the organization in support of the Millennium Development Goals**

As member organization of European Older People's Platform AGE, BAGSO was actively involved as a project partner in transnational exchange projects, during which the participants exchanged experiences and good practices regarding participation in the consultation process on the National Action Plans on social inclusion at a national level.

**5. Catholic International Education Office****Introduction**

The Catholic International Education Office (OIEC) is a non-governmental organization that represents Catholic educators the world over. It brings together the national secretariats of Catholic education in each of the affiliated countries, and is represented in five regions: Africa, America, Europe, Asia and the Middle East, and North Africa.

**Aims and purposes of the organization**

Its main tasks are to promote education for all and educational freedom as a human right; to embody an active Church presence in the world and in the field of education in particular; to promote Catholic schools around the world as well as the training of their teachers as Christian educators; and to combat illiteracy.

**Significant changes in the organization**

There have been no significant changes.

**Contribution of the organization to the work of the United Nations**

OIEC mainly follows the work of the Human Rights Council in Geneva, Switzerland. It participates actively in HRC's Universal Periodic Reviews, regularly

submitting reports on the States examined during the cycle. These reports are prepared as part of the UPR platform organized by the International Catholic Centre of Geneva (CCIG). OIEC also participates in the “right to education” platform organized by the International Organization for the Right to Education and Freedom of Education (OIDEL). In that capacity it has participated in various parallel events in Geneva on the theme of the right to education. Finally, OIEC, in conjunction with OIDEL, attempts to carry on a constructive dialogue with the United Nations Special Rapporteur on the right to education.

### **Participation in meetings of the United Nations**

OIEC regularly follows the work of the Human Rights Council in Geneva, attending the Office’s various sessions. It has co-authored a number of oral and written statements with other NGOs.

### **Cooperation with United Nations bodies**

OIEC interacts with the United Nations Special Rapporteur on the right to education and supports his work.

### **Initiatives taken by the organization in support of the Millennium Development Goals**

The main focus of OIEC’s activities has been education; a secondary focus has been sustainable development.

## **6. International Association for Human Values**

### **Special, 2002**

#### **Introduction**

The International Association for Human Values (IAHV) is a charitable, educational organization committed to nurturing human values in society.

#### **Aims and purposes of the organization**

The IAHV aims to promote, support and carry out actions to raise public awareness of the key role of human values for social development; carry out and support research projects; and organize, promote and carry out national and international conferences and fora, including multi-cultural and multi-religious symposia.

#### **Significant changes in the organization**

There have been no significant changes.

#### **Contribution of the organization to the work of the United Nations**

The organization has provided volunteers to join hands with local aid troops, brought support in trauma relief, and empowered youth, women, and the rural population in the aftermath of the following natural disasters, among others: Uttarakhand flood, India, 22 June 2013, Hurricane Sandy, 5 November 2012, Haiti Earthquake, 2010, and Japan Earthquake, 2011. The IAHV undertook a project for



war veterans called “Project Welcome Home Troops”. It also works on crime prevention with its programme “Prison SMART”, which teaches prisoners how to manage their stress, aggression, and trauma. A total of around 9,500 inmates, correctional officers and law enforcement staff have benefited from this programme in 15 countries.

### **Participation in meetings of the United Nations**

The organization participated in the World Health Organization’s (WHO) Executive Board meetings and annual World Health Assembly, during which it organized side events. It also took part in the United Nations Department of Information (DPI)/NGO Conference, Melbourne, Australia, 30 August-1 September 2010.

### **Cooperation with United Nations bodies**

IAVH is a member of the NGO Forum for Health, Geneva, Switzerland, the Women’s United Nations Report Programme and Network (WURN), the NGO Committee on Spirituality, Values and Global Concerns at the United Nations in New York and Geneva, the NGO Committee on Freedom of Religion and Belief, Geneva, and the United Nations Global Compact.

### **Initiatives taken by the organization in support of the Millennium Development Goals**

The IAVH has worked towards the following goals:

- MDG 1: IAHV’s India’s 5H Program uplifts and transforms youth into leaders. 6, 024 leaders have been trained in 751 villages;
- MDG 2, the organization provides a free school education programme in cooperation with the Art of Living Foundation in India;
- MDG 3: The organization partnered with IAHV-Jordan and the University of Jordan to enhance the skills of 400 Iraqi women from the private sector banking, aviation and hospitality in Baghdad and Kurdistan, Iraq; and
- MDG 7: IAVH has promoted chemical free farming since 2006.

## **7. Israeli Committee against House Demolitions**

### **Special, 2010**

#### **Introduction**

The Israeli Committee Against House Demolitions (ICAHD), founded in 1997, is an Israeli peace and human rights organization dedicated to achieving a just peace between Israelis and Palestinians.

#### **Aims and purposes of the organization**

ICAHD’s aims to end the Israeli occupation, formulate the outlines of a just peace, and prepare the ground for reconciliation. It pursues this agenda by promoting human rights and the application of international humanitarian law to the Israeli-Palestinian conflict; focusing on and resisting Israel’s demolition of

Palestinian homes; preparing informational materials on the conflict; and conducting international campaigns.

### **Significant changes in the organization**

There have been no significant changes.

### **Contribution of the organization to the work of the United Nations**

ICAHD's main contribution is in the area of peacebuilding. In particular, ICAHD hosted a Diplomatic Briefing on Racial Discrimination in Israel and the State of Palestine at the Palais des Nations, Geneva, Switzerland.

### **Participation in meetings of the United Nations**

ICAHD participated in the following meetings:

- United Nations Committee on Economic, Social and Cultural Rights 47th Session, for which it presented a parallel report, 14-17 November 2011, Geneva, Switzerland;
- United Nations Committee on the Elimination of Racial Discrimination (CERD), to which it submitted a parallel report on Israel's house demolition policies, 30 January 2012, and a parallel report on displacement and house demolitions in East Jerusalem and the West Bank, State of Palestine, 14-15 February 2012, Geneva; and
- Human Rights Council 20th Session, during which it delivered a written and oral statement, and 22nd Session, during which it organized a side event, Geneva.

### **Cooperation with United Nations bodies**

Following a briefing by ICAHD and the visit of homes demolished by the Israeli authorities in January 2012, the United Nations Humanitarian Coordinator for the Occupied Palestinian Territory (UNHC), called for an immediate end to the demolition of Palestinian homes by Israel in the occupied West Bank. ICAHD cooperated with the United Nations Special Rapporteur for Adequate Housing and the Special Rapporteur for the Situation of Human Rights in the Palestinian Territories Occupied Since 1967. It took a leading role in the Displacement Working Group and Legal Task Force convened by the United Nations' Office for the Coordination of Humanitarian Affairs (OCHA).

### **Initiatives taken by the organization in support of the Millennium Development Goals**

ICAHD's agenda focuses on peacebuilding, which is a key issue at the United Nations Economic and Social Council.

## **8. Leadership for Environment and Development**

**Special, 2002**

### **Introduction**

LEAD International was founded in 1991 to develop and support a new generation of leaders who would be linked through their experience and careers in a global network focused on environmentally sound development. The network counts over 2400 leaders.

### **Aims and purposes of the organization**

LEAD aims to develop a new generation of outstanding leaders, from all sectors across the world, with the leadership skills and understanding of sustainable development to affect real change; build a global network of leaders who share information and work together to achieve change; and enable to deliver innovative projects and programmes that help to implement sustainable development.

### **Significant changes in the organization**

LEAD hired a new Chief Executive Officer to pursue opportunities as a social enterprise.

### **Contribution of the organization to the work of the United Nations**

LEAD International acts as a focal point for LEAD Fellows to engage in collaboration with United Nations bodies, including through official meetings, consultations or direct involvement in projects and programmes.

### **Participation in meetings of the United Nations**

LEAD Fellows regularly attended United Nations meetings, including the Commission on Sustainable Development (CSD) and the Conference of the Parties (COP) of the United Nations Framework Convention on Climate Change (UNFCCC). They also work on projects that support the MDGs, as well in the proceedings of the United Nations Population Fund (UNFPA).

### **Cooperation with United Nations bodies**

LEAD delivered a training course entitled “Putting People First: Building Sustainable Cities with Communities” during the United Nations Conference on Sustainable Development (Rio+20), as part of the Sustainable Development learning programme, Rio de Janeiro, Brazil, 20-22 June 2012. LEAD International is also member of the Climate and Development Knowledge Network Alliance since 2010, which has been collaborating with the United Nations Environment Programme (UNEP) and the United Nations Development Programme (UNDP) in providing support for research, advisory services and knowledge-sharing in support of locally-owned and managed policy processes.

**Initiatives taken by the organization in support of the Millennium Development Goals**

LEAD works in partnership with many individuals and organizations whose work aims to support the MDGs. During the reporting period, LEAD has worked in Pakistan, India and Indonesia with support from various governments. The LEAD Pan African Session 2012 saw the participation of 10 African countries. LEAD undertakes projects to equip communities, institutions and NGOs in these countries with the capacity to respond to climate change, enabling them to better anticipate and minimize impacts on the livelihoods of poor and vulnerable people.

**9. Pan-African Women's Organization****Special, 1990****Introduction**

The Pan-African Organization (PAWO) is a NGO created in 1962 that focuses on women empowerment by raising awareness on issues affecting African women. It counts five regional secretariats in North Africa, West Africa, East Africa, Central Africa and Southern Africa. Its headquarters are in Pretoria, South Africa.

**Aims and purposes of the organization**

In the past decade, PAWO has worked on ensuring women participation in social media, women empowerment and women inclusion in all aspects of the political dialogue. In order to achieve its objectives, PAWO organizes advocacy and outreach activities at the regional and continental level and ensures that African women voices are taken into account at the international level.

**Significant changes in the organization**

There have been no significant changes.

**Contribution of the organization to the work of the United Nations**

The main contribution of PAWO focused on peace and security. PAWO co-organized a Solidarity Mission to Guinea in 2010 in order to strengthen Guinean Women's advocacy, within the framework of the national electoral process. In 2012 and 2013, PAWO participated in two Solidarity missions in Mali, within the context of the jihadist attacks against the country.

**Participation in meetings of the United Nations**

As an observer to the African Union, PAWO participated in all Head of State and Government Summits and Gender is my Agenda Campaign (GIMAC) Pre-Summit Consultative Meetings on Gender Mainstreaming in the African Union organized by the African Union Commission. In December 2013, the President of PAWO participated as a speaker to the Global Forum on Media and Gender organized by the United Nations Educational, Scientific and Cultural Organization (UNESCO) in Bangkok, Thailand, 2-4 December 2013. PAWO also participated in the 54th, 55th, 56th, and 57th Session of the Commission on the Status of Women (CSW), New York.

**Cooperation with United Nations bodies**

PAWO has an official partnership with UNESCO.

**Initiatives taken by the organization in support of the Millennium Development Goals**

PAWO's work falls precisely within the framework of MDG 3.

**10. Ukrainian Non-Governmental Socio-Political Association-National Assembly of Persons with Disabilities****Special, 2010****Introduction**

The Ukrainian Non-Governmental Socio-Political Association-National Assembly of Persons with Disabilities (The Assembly) was established in 2001 and currently operates in all oblasts of Ukraine.

**Aims and purposes of the organization**

The organization aims to protect the rights of people with disabilities; raise the status of people with disabilities in society; facilitate their inclusion into society; and participate in the development of state social policy.

**Significant changes in the organization**

The organization has changed its name to The Ukrainian Public Association "National Assembly of People with Disabilities".

**Contribution of the organization to the work of the United Nations**

The Assembly held conferences and workshops and conducted awareness-raising campaigns, in support of the work of the United Nations Economic and Social Council and United Nations at large.

**Participation in meetings of the United Nations**

The Assembly provided an Alternative Report to the United Nations Convention on the Rights of Persons with Disabilities (CRPD) Committee on the implementation of the Convention. Also, the Assembly contributed to the Universal Period Review process.

**Cooperation with United Nations bodies**

The organization collaborates primarily with the United Nations Development Programme (UNDP) and the United Nations International Children's Fund (UNICEF). In particular, since 2012, the Assembly has been involved in UNDP's project "Mainstreaming Policies and Services for People with Disabilities in Ukraine", in collaboration with UNICEF, the World Health Organization (WHO) and the International Labour Organization (ILO).

### **Initiatives taken by the organization in support of the Millennium Development Goals**

The Assembly has carried out a number of projects in support of the MDGs, including:

- Promoting access to quality healthcare services and protecting reproductive rights of men and women with disabilities by making healthcare facilities physically accessible, procuring physically accessible medical equipment, and training medical professionals and people with disabilities;
- Ensuring access to education for children with disabilities: Training programmes were delivered for educators and parents; and
- The reduction of poverty levels among people with disabilities by facilitating employment and paid work for people with disabilities.

## **11. Vienna Institute for Development and Cooperation**

### **Special, 1974**

#### **Introduction**

The Vienna Institute for Development and Cooperation (VIDC) acts as think tank and agent for social and political change through the organization of conferences, panel discussions, workshops, trainings, cultural events, counselling and awareness raising campaigns.

#### **Aims and purposes of the organization**

VIDC aims to increase public awareness on human rights violations, international developments and politics, development policies, gender (in)equalities, cultural dialogue and racism in football.

#### **Significant changes in the organization**

There have been no significant changes.

#### **Contribution of the organization to the work of the United Nations**

In the area of gender justice, the organization held a conference on the 10th anniversary of United Nations Resolution 1325: “Women’s Participation and Leadership in Conflict Situation and Peace Building”, with the United Nations Special Rapporteur for Human Rights in Bosnia and Herzegovina, 20 October 2010. It held conferences with experts from the Global South/East on combating human trafficking in 2011, 2012 and 2013. On 20 June 2011, VIDC launched the European Football Refugee Day. It held the conference “Development through Football” with representatives from 26 different European and African countries on 23-24 April 2010.

#### **Participation in meetings of the United Nations**

March 2013: representative attended the 57th Session of the Commission on the Status of Women (CSW), 4-15 March 2013, New York.

### **Cooperation with United Nations bodies**

VIDC has cooperated extensively with tax justice movements worldwide and has supported the High-level Panel on Illicit Financial Flows from Africa and the United Nations Tax Committee since 2011. VIDC contributed to implementing the United Nations Educational, Scientific and Cultural Organization's (UNESCO) Convention on the Protection and Promotion of the Diversity of Cultural Expressions in Austria. It organized an exchange programme between West African countries and the European UNESCO Commission between 2009-2011.

### **Initiatives taken by the organization in support of the Millennium Development Goals**

VIDC has been hosting a working group on poverty reduction since 2007, towards MDG 1. On MDG 3, it led a project "Football for Equality — Tackling homophobia and racism with a focus on Central and Eastern Europe", 2009-2012. On MDG 4, it led a panel discussion on the special needs of children during war and conflict for the promotion of United Nations Convention on the Rights of the Child, 27 April 2010. Towards MDG 8, it organized a North-South Dialogue of Parliaments to establish the Austrian parliament as a discussion platform for development policy dialogue and strengthen the Mozambican Parliament in the fields of democratization and institution building, 2010-2012.

## **12. West Africa Network for Peacebuilding**

### **Special, 2006**

#### **Introduction**

West Africa Network for Peacebuilding (WANEP) is a leading regional peacebuilding organization founded in 1998 in response to civil wars in West Africa in the 1990s.

#### **Aims and purposes of the organization**

WANEP's mission is to enable and facilitate the development of mechanisms for cooperation among civil society-based peacebuilding practitioners and organizations in West Africa by promoting cooperative responses to violent conflicts; providing the structure for such cooperation; and promoting West Africa's social cultural values as resources for peacebuilding.

#### **Significant changes in the organization**

WANEP established new secretariats in Cape-Verde, Mali and Niger.

#### **Contribution of the organization to the work of the United Nations**

WANEP works in partnership with the Economic Community of West African States (ECOWAS) in the implementation of a regional early warning and response system (ECOWARN). WANEP is Chair of the thematic cluster on peace and security in the African Union-European Union Joint Strategic partnership.

WANEP organized a Regional Mediation Training Series for Women Leaders from civil society in West Africa. It appraised the national domestication of the

United Nations Security Council (UNSCR) 1325 in 15 ECOWAS countries and evaluated women's participation in peace processes. WANEP advocated for the commitment of governments to implement UNSCR 1325 and provided technical support to the Governments of five countries in the development of National Action Plans.

#### **Participation in meetings of the United Nations**

WANEP participated in regional conferences and trainings organized by the United Nations, including a meeting in consultation with civil society organizations to review the 1998 Report of the United Nations Secretary-General. WANEP participated in a Regional Seminar on the Parliament's role in Crisis Prevention and Recovery organized by the United Nations Development Programme (UNDP).

#### **Cooperation with United Nations bodies**

WANEP worked on building the capacity of Police and Electoral Commission Officers in Dialogue and Mediation in 2012 in partnership with UNDP Ghana. In 2012, WANEP cooperated with UNDP and Catholic University College (CUC) to monitor and mediate on the Ghana election results. In 2013, WANEP facilitated a Training workshop for Ethiopian State Officials on Dialogue and Mediation, in consultations with UNDP Ghana. An effective platform was established for exchange of learning and experience for the Ethiopian State Officials as they reflected on how to sustain and build peace in Ethiopia.

#### **Initiatives taken by the organization in support of the Millennium Development Goals**

WANEP commemorated the United Nations days in 15 ECOWAS countries.

### **13. WomenAid Collective**

#### **Special, 2010**

##### **Introduction**

Women Aid Collective (WACOL) was established in 1997 as an independent, non-political non-profit organization that focuses on gender and human rights, peace advocacy and conflict resolution, democracy and good governance, and reproductive health and rights.

##### **Aims and purposes of the organization**

The organization aims to promote the human rights of women and young people and enlighten the general public on these issues through sensitisation and enlightenment campaigns; advocacy to influence related laws and policies; network with civil society organizations nationally and internationally to share information and experience; conduct and promote research in the field; and act as a lobby for women issues.

##### **Significant changes in the organization**

There have been no significant changes.



### **Contribution of the organization to the work of the United Nations**

WACOL has participated in United Nations meetings, especially at the national level, and developed programmes that were jointly carried out by different United Nations agencies. At the global level, WACOL participated in several United Nations events and made required inputs, including statements in support of its work and calling on national governments to keep their commitments to United Nations goals.

### **Participation in meetings of the United Nations**

WACOL participated in the following meetings:

- General Assembly High-level meeting to appraise the Global Plan of Action on Trafficking of Persons, 13 May 2013;
- The African Ministerial Preparatory Meeting for the 57th Commission on the Status of Women (CSW), 14-16 January 2013, Addis Ababa, Ethiopia; and
- Human Rights Council's June sessions, 2010-2013, Geneva, Switzerland.

### **Cooperation with United Nations bodies**

Since its establishment, WACOL has cooperated and received funding from the following United Nations bodies: the United Nations Development Programme (UNDP), United Nations International Children's Fund (UNICEF), United Nations Population Fund (UNFPA), and United Nations Entity for Gender Equality and the Empowerment of Women (UN Women), among others.

### **Initiatives taken by the organization in support of the Millennium Development Goals**

MDG 3 is at the core of WACOL's organizational mandate. It advocates for governmental action towards realisation of that goal. WACOL was also involved in a series of Post-2015 discussions at the national and international level. It participated in local meetings convened by the United Nations country office in this regard. Additionally, it partnered with UNFPA in 2010-2011 to develop an information/leaflet and handbook on the MDGs, which was simplified and used in creating awareness, sensitising and mobilising the general public towards the MDGs.

## **14. Women in Law and Development in Africa**

### **Special consultative status: 1998**

#### **Introduction**

Women in Law and Development in Africa is a pan-African network advocating for women's rights as they relate to development.

#### **Aims and purposes of the organization**

The organization's purpose is to promote and strengthen strategies that link women's rights to development, to foster the emergence of an African culture in which women's rights are asserted and respected.

**Significant changes in the organization**

In October 2011 the organization's headquarters were transferred to Lomé, Togo.

**Contribution of the organization to the work of the United Nations**

The Organization has conducted and concluded the sub-regional project, launched in 2009 in five countries, to "Use the law as a tool for the empowerment of women": Benin, Burkina Faso, Côte d'Ivoire, Ghana and Togo. The Organization submitted alternative reports on the implementation of the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) for Burkina Faso in 2010 and Togo in 2013. It has advocated for women's participation in politics in Kenya and conducted a project to promote women's participation in decision-making bodies in decentralized northern Mali communities.

**Participation in meetings of the United Nations**

The organization participated in the United Nations meetings to evaluate implementation of the Beijing Platform and the programme of action of the Cairo International Conference on Population and Development. It also took part in the 54th and 57th sessions of the Commission on the Status of Women (CSW) and in discussions on the new sustainable development objectives and on financing for development.

**Cooperation with United Nations bodies**

Since 2010, the organization has been a member of Africa's UNITE to End Violence against Women Committee and the African Women's Rights Observatory created by the United Nations Economic Commission for Africa (UNECA). In 2011 it attended a regional meeting on women's access to legal and judicial services in sub-Saharan Africa with several partners, including UNECA, the United Nations Population Fund (UNFPA) and the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women). In addition, it participated in consultative forums held by regional women's rights organizations and networks at the behest of the UN Women liaison office for the African Union and UNECA.

**Initiatives taken by the organization in support of the Millennium Development Goals**

The Organization's programmes are relevant to Millennium Development Goal (MDG) 3. The organization is also involved in the process of evaluation of MDG implementation and the post-2015 Development Agenda.

**15. Women's Legal Education and Action Fund****Special, 2010****Introduction**

The Women's Legal Education and Action Fund (LEAF) was founded in 1985 to promote and protect the equality rights of women and girls in Canada.

**Aims and purposes of the organization**

LEAF was created to defend the equality rights of women and girls as enshrined in the Canadian Charter of Rights and Freedoms. LEAF intervenes in many significant legal decisions, organizes workshops, gives lectures and leads women's rights projects, all related to gender and women's equality.

**Significant changes in the organization**

The organization underwent a severe cut in its financial resources that has prevented it to conduct a lot of its legal and litigation work.

**Contribution of the organization to the work of the United Nations**

LEAF submits reports to various United Nations bodies.

**Participation in meetings of the United Nations**

No participation was specified.

**Cooperation with United Nations bodies**

LEAF monitors United Nations activities and is involved in many projects and legal cases, which are in line with United Nations bodies' mandates, including but not limited to gender equality, protection of human rights, eradicating violence against women and protection of refugees, including access to health care by refugees in Canada.

**Initiatives taken by the organization in support of the Millennium Development Goals**

LEAF's work supports the promotion of gender equality, empowerment of women and improvement of maternal health. LEAF engages in influencing policy reform across the health, social and justice systems. LEAF's research and analysis is used by legislators, policy makers and organizations as a catalyst for change for substantive equality rights for women. LEAF is a member of the Legal Strategy Coalition on Violence Against Indigenous Women (LSC), which engages in legal advocacy and research to address the violence and discrimination against Indigenous women and girls, specifically the critical issue of missing and murdered Indigenous women. In 2012, LEAF intervened in the Coalition with the Disabled Women's Network Canada to address access to justice for women with mental disabilities and in particular for sexual assault complainants with intellectual and other disabilities.
