## 1. Agence pour le développement intégré au Congo

## Special, 2012

## Introduction

The Agence pour le développement intégré au Congo (ADIC) is a non-governmental organization created to reduce poverty and address pandemic health threats.

## Aims and purposes of the organization

The organization's main tasks are to provide social support to vulnerable persons, including women and children; to combat poverty by facilitating access to food and housing; to promote education in sustainable management of the environment; to preserve and protect biodiversity, including through erosion and pollution control, reforestation and environmental sanitation; and to help finance cooperative associations through development projects for young people.

## Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

This organization has done considerable development work in the province of Lubumbashi, including the construction of paediatric health centres and elementary and middle schools; training for unemployed youth in agriculture and stockbreeding; provision of assistance to vulnerable persons; training for members in income-generating activities; and training for girls in garment-making.

## Participation in meetings of the United Nations

No participation was specified.

## **Cooperation with United Nations bodies**

No cooperation was specified.

## Initiatives taken by the organization in support of the Millennium Development Goals

ADIC contributed to the achievement of Millennium Development Goals 1, 2, 4 and 6, including through the production and distribution of agricultural and fish products; programmes for 1,030 students in two schools; health care for 8,253 children under the age of 5 years in paediatric centres; psychosocial support for 2,669 persons with or affected by HIV/AIDS; and participation in the observance of International Women's Day in 2014 and 2015, in which thousands of women took part.

## 2. Al Zubair Charity Foundation

## Special, 2008

## Introduction

Established in 1998, Al Zubair Charitable Foundation (AZCF) is a non-governmental organization based in Sudan.

## Aims and purposes of the organization

ACZF aims to support communities in need, including women and children by: providing relief aid to people affected by crises; promoting sustainable livelihoods; advocating with policy makers to improve the capacity of communities to manage their natural resources; and promoting the culture of peace, peace building and conflict resolution.

## Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

In coordination with the United Nations Population Fund (UNFPA), AZCF organized an awareness workshop on social violence in the Blue Nile State which was attended by 260 participants representing 20 localities, civil society organizations, women and youth unions, child rights organizations and community leaders. ZCF coordinated with the United Nations High Commissioner for Refugees (UNHCR) to distribute clothes in a refugee camp in Khartoum State.

## Participation in meetings of the United Nations

ZCF regularly attended sessions of the United Nations Human Rights Council in Geneva as well as meetings of the Commission on the Status of Women in New York.

## **Cooperation with United Nations bodies**

No cooperation was specified.

## Initiatives taken by the organization in support of the Millennium Development Goals

ZCF established a clinic to provide free medical services in North Khartoum and organized an awareness workshop on nutrition and early detection of breast cancer. ZCF also organized a voluntary work day to combat smoking and drug use in partnership with the Hayat Life Center for treatment and psychological rehabilitation.

## 3. Association pour le développement de la société civile angolaise

## Special, 2012

## Introduction

The Association pour le développement de la société civile angolaise (ADSCA) is a non-profit organization that works to promote human rights and build community capacity through development projects.

## Aims and purposes of the organization

The organization seeks to inform and raise awareness in communities about civic education and the promotion of human rights through campaigns and the translation of treaties and through discussions with public and private officials, traditional authorities and national organizations.

## Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

ADSCA has conducted civic education and human rights campaigns, advocacy for the elimination of all forms of discrimination and community capacity-building activities. In addition, the organization has provided the necessary support to refugee detention and reception centres.

## Participation in meetings of the United Nations

No participation was specified.

## **Cooperation with United Nations bodies**

ADSCA has observer status with the World Intellectual Property Organization (WIPO).

# Initiatives taken by the organization in support of the Millennium Development Goals

ADSCA has focused its activities mainly on supporting the development programme through awareness-raising and promotion. The organization regularly observes Human Rights Day, the International Day for the Elimination of Violence against Women and World Refugee Day.

## 4. Captive Daughters

## Special, 2012

## Introduction

Captive Daughters (CD) is California's first anti-sex trafficking non-profit organization and actively conducts programs, events and publishes books on human and sex trafficking.

#### Aims and purposes of the organization

CD considers that trafficking educational outreach is best attained through creative media such as, YouTube, documentaries and feature films on human rights subjects and accordingly modified its mission statement to "activism through creative media", which extends its purview to human rights.

## Significant changes in the organization

Between 2013 and 2014 the organization reorganized itself as Captive Daughters Films.

## Contribution of the organization to the work of the United Nations

From 2010 to 2013 the organization featured a United Nations website dealing with trafficking and widows. Since 2013 the organization has produced YouTube situation reports on countries affected by trafficking and is currently developing a feature film on human trafficking in Nepal and a documentary on the cluster bombs in Laos following the Viet Nam War.

## Participation in meetings of the United Nations

Captive Daughters attended the 57th Session of the Commission on the Status of Women held on April 15, 2013 in New York.

## **Cooperation with United Nations bodies**

No cooperation was specified.

## Initiatives taken by the organization in support of the Millennium Development Goals

No activities were specified.

## 5. Carter Center

## Special, 2008

## Introduction

The Carter Center (TCC), in partnership with Emory University, is committed to advancing human rights and alleviating human suffering around the world.

#### Aims and purposes of the organization

TCC wages peace, fights disease and builds hope by engaging with governments and working with often forgotten people.

#### Significant changes in the organization

There have been no significant changes.

### Contribution of the organization to the work of the United Nations

TCC submitted election observation reports to the United Nations Treaty Bodies in 2014 and 2015. A part of the ACE Project Steering Board committee, TCC to the ACE Electoral Knowledge Network, a collaborative including the United Nations Development Programme(UNDP) and the United Nations Electoral Assistance Division. TCC also worked with the United Nations Department of Political Affairs, Office of Special Envoy, and the Office for the Coordination of Humanitarian Affairs (OCHA) on governance and constitutional options for Syria. Led by TCC, a coalition including the Centers for Disease Control and Prevention, United Nations Children's Emergency Fund (UNICEF), and the World Health Organization (WHO) provided technical and financial assistance to national Guinea Worm Eradication Programs in Chad, Ethiopia, Mali, Sudan and South Sudan. TCC's Mental Health Program in Liberia trains national workforce and healthcare providers on the WHO's Mental Health Gap Action Programme.

## Participation in meetings of the United Nations

In 2015, TCC submitted its Annual Human Rights Defenders Forum report as input for the Global Study on the Implementation of United Nations Security Council Resolution 1325. In the same year, TCC also participated in the WHO's meeting on mental health and psychosocial support stakeholders in Liberia.

## **Cooperation with United Nations bodies**

In 2014 and 2015, TCC co-sponsored events on due diligence, discrimination against women and women's rights along with the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women) Regional Office for Asia and the Pacific, Bangkok and the Office of the High Commissioner of Human Rights (OHCHR) convening election practitioners and human rights experts. TCC also collaborated with United Nations Electoral Assistance Division to promote endorsement of the Declaration of Principles for International Election Observation. It supported the United Nations Mission in Liberia's Justice Office and the Ministry of Justice to develop a national legal aid policy and partnered with UNICEF, the government, and stakeholders to mobilize the chieftaincy network to combat Ebola and measles.

# Initiatives taken by the organization in support of the Millennium Development Goals

The Trachoma Control Program strategy of Surgery, Antibiotics, Facial Cleanliness and Environmental Improvement (SAFE) impacted the overall

achievement of the MDGs. TCC's Guinea Worm Eradication Program contributed to goals 1, 2, 6 and 7 of the MDGs due to the global reduction of the number of new cases by 96% from 542 cases reported in 2012 to only 22 reported in 2015. TCC's Lymphatic Filariasis Program addressed goal 1 in Ethiopia and Nigeria by directly treating soil-transmitted helminths. TCC promoted goal 8 by forging partnership with established companies such as Merck KGaA and Pfizer Inc.

## 6. Children International

## Special, 2008

## Introduction

Children International (CI) is a non-governmental humanitarian organization focused on ending poverty by helping children and youth. CI works in Colombia, Dominican Republic, Ecuador, Guatemala, Honduras, India, Mexico, Philippines, the United States of America and Zambia.

## Aims and purposes of the organization

CI's vision is that every child graduates from its programme healthy, educated, employed and empowered to break the cycle of poverty. The vision is achieved by focusing on developing healthy habits and connecting children with services, sponsoring the schooling of students by providing fees, uniforms, supplies, tutoring and scholarships, and educating teens with life skills including leadership, conflict resolution and technical skills.

### Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

In the framework of the post-2015 Development Agenda, CI facilitated the "World We Want E-Consultation with Children" and also worked UNICEF on a policy paper titled "Child sensitive accountability and the post-2015 agenda." This paper was presented at multiple United Nations' conferences, posted on several United Nations-affiliated websites and shared with the Transparency, Accountability and Participation network (TAP).

## Participation in meetings of the United Nations

CI regularly raises awareness on United Nations observances through press releases, social media and commemorates the International Women's Day, International Day of the Girl Child, World Water Day, International Youth Day, and International Day for the Eradication of Poverty. Additionally, CI was represented at the Children and Youth Finance International (CYFI) Youth Meeting held at the United Nations Headquarters from 21 to 23 May 2014 in New York.

## **Cooperation with United Nations bodies**

CI has been active in the post-2015 Development Agenda by attending weekly conference calls as part of the Policy Strategy Group (PSG) and liaising with the Secretary-General's Envoy on Youth. After Typhoon Haiyan hit the Philippines in 2013, CI supported UNICEF to man the Child Protection Processing Center at the Villamor Airbase and assisted in the recovery process. Additionally, CI invested in UNICEF's approach of child-friendly spaces working with schools and communities to provide safe spaces for children.

## Initiatives taken by the organization in support of the Millennium Development Goals

CI's programmes primarily focus on helping children and youth become healthy, educated, empowered and eventually employed. In support of the MDGs, CI launched various initiatives to promote gender equality and community clean-up initiatives towards environmental sustainability and disease prevention.

## 7. China Association for Science and Technology

## Special, 2004

## Introduction

China Association for Science and Technology (CAST) is an umbrella organization based in China, composed of various academic and professional societies in the field of science and technology.

#### Aims and purposes of the organization

CAST aims to serve economic and social development by convening international exchanges fostering innovation in sciences and technology; disseminating knowledge and promoting scientific thinking and methods; encouraging participation in the formulation of national policies on science and technology; and promoting international cooperation.

#### Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

A CAST representative was selected as a member of the United Nations Secretary-General Science Advisory Board and provided scientific inputs to the Post-2015 Development Agenda discussion.

## Participation in meetings of the United Nations

Between 2012 and 2015, CAST convened side events/workshops on various themes covering internet governance, big data initiatives, green economy, climate change and resilience. Representatives actively attend various meetings organized by the United Nations including the Conference on Parties (COP) on climate change and the Annual Internet Government Forum (IGF). Additionally CAST participated in the following meetings:

- XIX international AIDS conference hosted by the World Health Organization (WHO) Washington DC, July 22t to 27 2012;
- 13th World Congress on Public Health, Addis Ababa, Ethiopia, 23 to 27 April 2012;
- 11th International Congress on AIDS in Asia and the Pacific in Bangkok, Thailand from 18 to 22 November 2013; and
- 20th International AIDS Conference in Melbourne, Australia, 20 to 25 July 2014.

## **Cooperation with United Nations bodies**

Between 2012 and 2015, CAST collaborated with the United Nations Children's Emergency Fund (UNICEF) in the adolescents and non-formal education program assisting female adolescents adjust to workplace and urban life. It also collaborated with the United Nations Global Alliance for ICT and Development (UNGAID) to host the conference titled "Open Knowledge Environment for Improving the Delivering of Public Services — Joint Efforts from Scientific Communities and Local Governments" held in Beijing in September 2013. CAST collaborated with the Department of Economic and Social Affairs (DESA) to convene a side event during the General Assembly High-level Meeting on the overall review of the implementation of the outcomes of the World Summit on the Information Society (WSIS+10) in New York on 14 December 2015.

## Initiatives taken by the organization in support of the Millennium Development Goals

CAST launched various programs that contribute to the MDGs as listed below:

MDG 1: Program to target poverty alleviation via science and technology in 2015 targeting millions of impoverished people;

MDG 2: National Action Plan of Scientific Literacy for Chinese citizens to provide comprehensive impetus to the improvement of scientific literacy which benefited over 280 million individuals by end of 2014;

MDG 6: Program on AIDS prevention and control which involves more than 460 NGOs implementing over 760 projects in 30 provinces nationwide.

## 8. Ecumenical Federation of Constantinopolitans

## Special, 2012

### Introduction

The Ecumenical Federation of Constantinopolitans (EFC) is an association aimed to safeguard the autochthonous Greek Orthodox Community of Istanbul, Turkey. This minority international status is based on the Lausanne Treaty signed in 23 July 1923 under the auspices of League of Nations.

## Aims and purposes of the organization

EFC aims to contribute to the survival of the Greek Orthodox Community of Istanbul. It also supports initiatives towards sustainable peace, prosperity and respect of human rights in Eastern Europe, Balkans and the Middle East.

#### Significant changes in the organization

There have been no significant changes.

### Contribution of the organization to the work of the United Nations

Pursuant to the United Nations General Assembly Resolution 60/147, EFC promotes the development and implementation of the reparation measures following the consequences of human rights violations incurred to minority communities.

## Participation in meetings of the United Nations

EFC has participated in all minority forums held in Geneva between 2012 and 2015 and has contributed to the adherence of human and minority rights' issues through oral and written statements. In November 2015, EFC organized a side event at United Nations Headquarters during the 60th anniversary of the 6 and 7 September 1955 pogrom in Istanbul.

## **Cooperation with United Nations bodies**

EFC has established close cooperation with the Office of the High Commissioner for Human Rights (OHCHR) in Geneva, Switzerland.

## Initiatives taken by the organization in support of the Millennium Development Goals

EFC developed an internet based distant education learning system for all courses of elementary schools in the Greek language, with plans to extend to English and Turkish. EFC also features an extensive scholarship program to support students enrolled in secondary schools and universities which include sensitizing them to the principles of the Millennium Development Goals (MDGs).

## 9. Institute of International Social Development

## Special, 2000

#### Introduction

The Institute of International Social Development (IISD) implements projects to empower people in rural, tribal and urban environments in India on all aspects of the Millennium Development Goals (MDGs). In addition to its head office in Kolkata, India, IISD also has branches in New York, Paris and Geneva.

### Aims and purposes of the organization

The aims and purposes of IISD are to 'Build a Better World' through the awareness and implementation of the guiding principles of the United Nations. Its

slogan is "One Earth One Family" and its projects and programmes are geared towards the fulfilment of that ideal.

## Significant changes in the organization

There have been no significant changes.

#### Contribution of the organization to the work of the United Nations

Under its literacy program, titled "Project Sushiksha", IISD distributed scholarships to support the education of eligible students and providing stationary supplies. IISD also conducted a healthcare program titled "Project Suswasthya" that provides healthcare to more than 5,000 families in the West Bengal province and facilitates potable water access, sanitation and environmental awareness initiatives. Additionally, IISD supported poor farmers by providing agricultural equipment and aided poverty struck families by installing roofs in their homes.

## Participation in meetings of the United Nations

IISD actively participates in meetings of the United Nations and provided statements to the 57th, 58th and the 59th session of the Commission on the Status of Women. Representatives also attended the 50th, 51st, 52nd and 53rd Session of the Commission for Social Development along with the 12th and 13th Session of the Permanent Forum on Indigenous Issues. Additionally, IISD attended the following meetings in New York:

- High-level meeting of the General Assembly on the 25th anniversary of the adoption of the Convention on the Rights of the Child, 20 November 2014;
- High-level event on the Millennium Development Goals and Post-2015 Development Agenda, 25 September 2013;
- Sixth session of the Conference of States Parties to the Convention on the Rights of Persons with Disabilities, 17 to 19 July 2013 ; and
- International Migration and Development: High-Level dialogue on 3 and 4 October 2013 and Informal Interactive Hearings on 15 July 2013.

## **Cooperation with United Nations bodies**

The organization partners with Global Compact of the United Nations.

## Initiatives taken by the organization in support of the Millennium Development Goals

All the projects and programmes are geared to support and fulfil the Millennium Development Goals.

## 10. Intercambios Asociación Civil

## Special, 2012

## Introduction

Intercambios Asociación Civil (IAC) is an organization in Argentina that promotes the health and human rights of drug users through evidence-based programs.

## Aims and purposes of the organization

IAC's main objectives are to:

- Develop interdisciplinary studies related to drug use from scientific and ethical perspectives;
- Disseminate information about legal and illegal drugs to steer public opinion toward a more reflective and responsible vision of drug use;
- Develop resources to drug using communities, professional outreach workers and peer educators;
- Design, implement, and evaluate prevention programs and community interventions;
- Develop a network of social services and resources that provide integrated services to drug affected people; and
- Develop the infrastructure for collaboration and cooperation between institutions, investigators and social activists.

#### Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

IAC contributed the work of the United Nations by publishing various studies to address the following issues in Argentina and Latin America: health policy on drugs; social and health care initiatives for people with drug related problems; HIV and Treponema pallidum prevalence in vulnerable populations; illicit drug users and State responses; and drugs laws and deprivation of liberty. Intercambios also developed drug use prevention programs in schools and poverty-stricken neighbourhoods in the Buenos Aires Metropolitan Area and held a media campaign and training project on reducing stigma and discrimination among drug users. IAC conducted on-line and residential courses and provided inputs to the comprehensive plans of action on drug problems along with convening four national conferences in Argentina and two conferences on drug policy in Colombia (2012) and Costa Rica (2014). IAC also annually commemorates the International Day against Drug Abuse and World AIDS Day.

## Participation in meetings of the United Nations

In addition to regularly attending the Commission on Narcotic Drugs and UNODC hosted Informal Consultations to Civil Society on Drug Use and HIV between 2013 and 2015, IAC representatives attended the following meetings:

- UNODC hosted Global Technical Meeting on Stimulants Use and HIV, Sao Paulo, Brazil, 25 to 27 January 2012;
- Southern Cone Regional Consultation on the UNAIDS Strategy 2016-2021, Buenos Aires, Argentina, 18 March 2015;
- High-level Thematic Debate in support of the 2016 Special Session of the General Assembly on the World Drug Problem, New York, 7 May 2015; and
- Regional Dialogue on Drug Use and HIV, Sao Paulo, Brazil, 22-23 June 2015.

## **Cooperation with United Nations bodies**

Between 2014 and 2015, IAC collaborated with UNODC to improve drugs users' access to health care services in nine Argentine cities. Its representatives met with the United Nations Special Rapporteur on the right of everyone to the enjoyment of the highest attainable standard of physical and mental health, on violence and right to health of adolescents in Latin America and the Caribbean. In 2015, IAC was selected to be part of the Civil Society Task Force for the United Nations General Assembly Special Session 2016 representing Latin America and the Caribbean.

## Initiatives taken by the organization in support of the Millennium Development Goals

No activities were specified.

## 11. International Association of Penal Law

## Special, 1948

## Introduction

The International Association of Penal Law (IAPL) seeks to promote the development of legislation and institutions towards a more humane and efficient administration of justice.

#### Aims and purposes of the organization

IAPL is guided by the principles established by the United Nations Charter and the Universal Declaration of Human Rights. IAPL's studies and reforms are aimed at all principal systems of law, including codified laws and those under the jurisdiction of the common law as well as substantive and procedural international criminal law.

## Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

The Association orients its program according to the most crucial challenges in the field of penal law and contributes through scientific events furthering the aims of ECOSOC and in particular the United Nations Office on Drugs and Crime (UNODC) in the areas of organized crime, prevention of terrorism and money laundering. AIDP organized the following meetings to advance on the agenda of the United Nations Congress on Crime Prevention and Criminal Justice:

- Information Technology and Criminal Policy This meeting discussed findings of the Congress of the International Association of Penal Law in Rio de Janeiro, Brazil, which was held on 30 August to 7 September 2014;
- Mutual Legal Assistance Discussions were focused on the loopholes in existing legal frameworks and conventions; and
- Corruption This session underlined important linkages between the criminal phenomenon and the systemic issue of institutional fraud bearing transnational effects.

## Participation in meetings of the United Nations

IAPL participated at the 13th United Nations Congress on Crime Prevention and Criminal Justice held in Doha, Qatar from 12 to 19 April 2015. Its representatives also attended the 24th Session of the Commission of Crime Prevention and Criminal Justice convened in Vienna, Austria from 18 to 22 May 2015 where proposals included establishment of a working group to discuss international cooperation on criminal matters.

#### **Cooperation with United Nations bodies**

No cooperation was specified.

## Initiatives taken by the organization in support of the Millennium Development Goals

No activities were specified.

## 12. International Circle of Faith Chaplaincy Corps

#### Special, 2012

#### Introduction

The International Circle of Faith Chaplaincy Corps (ICFCC) is a grass-roots project implementation and religious organization that has 16 offices across Nigeria and presence in other African countries.

## Aims and purposes of the organization

ICFCC focuses on: emergency relief assistance; education and material support to the needy; awareness creation on diseases and epidemics; community capacity enhancement for leadership and self-employment; psychological support to

families, widows, orphans and physically disadvantaged people; and peacebuilding via dialogue using Alternative Dispute Resolution (ADR) mechanisms.

## Significant changes in the organization

Since gaining consultative status with ECOSOC, ICFCC has expanded its objectives to cover maternal and infant mortality, gender equality, ending discrimination against women, environmental sustainability, provision of potable water and poverty reduction.

### Contribution of the organization to the work of the United Nations

ICFCC hosted training in leadership and capacity building on 15 June 2014 in Adamawa State of Nigeria which gathered thousands of participants including security personnel and religious leaders and resulted in an outcome document titled the "Dynamic of Peace with ways to nip conflict in the bud". During hostilities caused by insurgents during the November 2014 crisis in the same region, ICFCC helped transport individuals to internally displaced person (IDP) camps along with provision of relief materials for inmates. ICFCC also supported the rights of the indigenous people by discussing the effects of colonization and post-independence government during a visit to a senior care facility in Abuja on 26 June 2015.

#### Participation in meetings of the United Nations

ICFCC actively keeps abreast of the outcome of meetings organized by the United Nations including the Permanent Forum on Indigenous Issues, Open-ended Working Group on Ageing (OEWGA) and the Commission for Social Development, although it was not able to attend these meetings due to funding constraints.

## **Cooperation with United Nations bodies**

No cooperation was specified.

## Initiatives taken by the organization in support of the Millennium Development Goals

On 15 June, 2014, ICFCC completed a water borehole project in the Adamawa state of Nigeria where unsatisfactory sanitation conditions resulted in the high mortality rate of women and children. ICFCC also provided free medical and eye care facilities to hundreds of mothers and children.

## 13. International NGO Forum on Indonesian Development

#### Special, 2004

#### Introduction

International NGO Forum on Indonesian Development (INFID) is an association with 70 member organizations based in Indonesia, focused on gender equality, environmental sustainability, human rights and democracy, peacebuilding, children's rights and diversity.

## Aims and purposes of the organization

INFID aims to promote democracy, well-being, equality, social justice and peace to guarantee the realization of human rights at the national and international levels through:

- Conducting public awareness on the values of human rights, democracy, equality, social justice and peace through education;
- Engaging in studies, policy reviews and dialogues to buttress policies that guarantee the fulfilment of human rights; and
- Cooperating with partners to build social solidarity at the national and international levels.

## Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

In support of the MDGs and the 2030 Agenda for Sustainable Development, INFID published various reports addressing social equality and civil society contribution to national development. INFID also convened a side event during the United Nations General Assembly on 23 September 2015, and held a series of discussions with civil society and government representatives in preparation of the background paper for the Third United Nations Conference on Financing for Development.

### Participation in meetings of the United Nations

Along with actively pursuing and providing interactive hearings on the post-2015 Development Agenda, representatives attended the following meetings:

- 24th and 30th Session of the Human Rights Council, Geneva, Switzerland, 20 to 27 September 2013 and 16 to 24 September 2015;
- 68th United Nations General Assembly in New York, 19 to 29 September 2013;
- 108th Session of the Human Rights Committee, Office of the High Commissioner for Human Rights, Geneva, Switzerland, 23 May 2014;
- 52nd Session of the Committee of Economic Social and Cultural Rights (CESCR) Geneva, Switzerland, 26 April to May 3, 2014.

### **Cooperation with United Nations bodies**

In 2012, INFID signed a memorandum of understanding with the United Nations Office on Drugs and Crime (UNODC) to counter illegal logging and linkages between forest crime and corruption.

## Initiatives taken by the organization in support of the Millennium Development Goals

INFID hosted a global civil society organizations' preparatory meeting and stakeholder outreach for the post-2015 Development Agenda supported by United Nations Development Programme (UNDP) convened in Bali, Indonesia from 23 to 25 March 2013. Also in 2013, INFID provided inputs to the national and local government addressing the maternal mortality rate and civil society contribution to the achievement of the MDGs.

## 14. International Organization for Victim Assistance

## Introduction

The International Organization for Victim Assistance (IOVA) was established to enhance national and international actions for victims of crime, violence and natural disaster. It was established in Oregon, United States of America with a worldwide mission.

## Aims and purposes of the organization

IOVA's mission is to improve rights and services for victims of crime, violence and natural disaster as well as the prevention of victimization. It focuses on implementation of standards and resolutions emanating from the United Nations General Assembly Resolution 40/34 (1985) on Basic Principles of Justice for Victims of Crime and Abuse of Power. It acts as a catalyst for change using IOVA's expertise to promote effective policies, protocols and programmes through advocacy and action; develop education and training to make actions more trauma-informed, victim centred and culturally appropriate; collaborate on capacity building initiatives; provide direct emotional and psychological interventions; and encourage monitoring and evaluation of results.

## Significant changes in the organization

There have been no significant changes.

#### Contribution of the organization to the work of the United Nations

IOVA provided inputs to the draft of the United Nations Office on Drugs and Crime Handbook on Victims of Crime and Abuse of Power. It also encourages interest in a cogent draft for a convention to enhance the implementation of the United Nations General Assembly Resolution 40/34 (1985).

### Participation in meetings of the United Nations

IOVA was represented at the 13th United Nations Congress on Crime Prevention and Criminal Justice organized in Doha, Qatar from 12 to 19 April 2015. Its president chaired the high level event titled "Why do victims matter: 30 years anniversary of the Declaration of the Basic Principles of Justice for Victims of Crime" attended by the United Nations Commission on Human Rights (UNCHR), the United Nations Development Programme (UNDP), United Nations Office on Drugs and Crime (UNODC), the World Health Organization (WHO), the International Criminal Court (ICC), as well as member states and non-governmental organizations.

## **Cooperation with United Nations bodies**

IOVA is a member of the Violence Prevention Alliance for the World Health Organization (WHO) which is a network comprised of member states, international agencies and civil society organizations working to prevent violence. The most recent meeting attended was on violence prevention and the 2030 agenda for sustainable development held at the World Health Organization (WHO) Headquarters in Geneva, Switzerland from 19 to 21 September 2015. IOVA also co-organized major side-events on reparative justice during the 13th and 14th annual meetings of the International Criminal Court's (ICC) Assembly of State Parties' held on 12 December 2014 at the United Nations Headquarters in New York and on 21 November 2015 at the World Forum in The Hague, the Netherlands.

## Initiatives taken by the organization in support of the Millennium Development Goals

IOVA has significantly engaged in the 2030 Agenda for Sustainable Development and the Millennium Development Goals (SDGs) by conducting activities to address violence against women and girls and improving access to justice. It is also promoting the importance of implementation through investments, partnerships and measurement of outcomes.

## 15. International Presentation Association

## Introduction

The International Presentation Association (IPA) is a network that collaborates to address the root causes of poverty and conducts activities in 23 countries across five continents.

## Aims and purposes of the organization

IPA seeks to collaborate on partnership for global justice while addressing issues pertaining to indigenous peoples, women and children, human rights and environmentally sound and sustainable living conditions. IPA members respond to local needs through traditional schools, alternative education for children and adults, programs aimed at empowerment of people especially women and girls, migrants, nutritional programs, health care and promoting the use of green energy.

## Significant changes in the organization

The organization has undergone a change of name from International Presentation Association of Sisters of the Presentation of the Blessed Virgin Mary to International Presentation Association, Inc.

## Contribution of the organization to the work of the United Nations

IPA contributes towards advocacy of the United Nations as a member of the Non-Governmental Committee on Social Development, Financing for Development, Migration, and other key bodies. It conducted grassroots consultations on migration and published its findings titled "Empowering Migrants: A Win-Win Situation" along with related surveys and follow-ups. IPA sponsored participants from Australia, India, and Zambia to attend United Nations meetings including the First World Conference on Indigenous Peoples in 2014 and the 59th Commission on the Status of Women (CSW) in 2015.

## Participation in meetings of the United Nations

Between 2012 and 2015, IPA representatives regularly participated in various high level events on migration and sustainable development including the United Nations Conference on Sustainable Development in 2012 and the Workshop on Mainstreaming Sustainable Development into National Development Strategies organized by the Department of Economic and Social Affairs (DESA) in 2013. Additionally, IPA members regularly attended and provided statements to the Commissions on Social Development, Commissions on Status of Women, Forums on Indigenous Peoples and the Commission of Social Development and Annual Ministerial Review.

### **Cooperation with United Nations bodies**

IPA has collaborated with United Nations bodies to organize side events during major conferences to include the 50th and 51st Session of the Commission for Social Development and 56th session of the Commission on the Status of Women. IPA submitted a report to the Office of the United Nations High Commissioner for Human Rights (OHCHR) on the Peruvian migrant situation in 2015 and a Universal Periodic Report (UPR) on the situation of women and girls in Papua New Guinea. Furthermore, IPA contributed USD \$14,265.42 to a refugee program led by the United Nations High Commissioner for Refugees (UNHCR) in 2015.

## Initiatives taken by the organization in support of the Millennium Development Goals

IPA contributed to the implementation of MDGs in the following countries: Australia, Bolivia, Canada, Ecuador, India, Ireland, New Zealand, Pakistan, the Philippines, Thailand, United States of America, United Kingdom of Great Britain and Northern Ireland, Zambia and Zimbabwe influencing a large constituency through awareness and advocacy programmes on MDGs, training in leadership, income generation, skills training, sustainable agriculture and microcredit techniques.
