# 1. Fondation Afrique développement international

### Special, 2018

#### Introduction

Fondation Afrique développement international was established on 28 November 2013, although it has been carrying out its activities to support human development since 2012. Pursuant to Order No. 0155/MATDCL-CAB of 10 September 2014, the Foundation is under the supervision of the Ministry of Local Administration, Decentralization and Local Authorities. It has held special consultative status with the Economic and Social Council since 2018.

# Aims and purposes of the organization

The purpose of the Foundation is to improve the living conditions of populations at the grassroots level by promoting their development and well-being through protection of the ecological, socio-cultural, educational and health environment. Its overall objective is to promote the concept of human security in Africa in all its health, environmental and social dimensions.

# Significant changes in the organization

In 2018, the Foundation embarked on a self-evaluation process. After four years in the field, it was time for the Foundation to review its activities and understand its strengths and weaknesses so that it could consolidate its achievements and prepare a new outlook. On the basis of that exercise, a four-year action plan for 2018–2021 was developed.

The evaluation was beneficial in many ways; it served to clarify the organization's missions as well as its aims and issues. The evaluation also revealed the shortfalls in human, material and financial resources, which make it impossible to take effective action throughout the territory.

Emphasis has therefore been placed on technical capacity-building. Activities and measures are carried out to increase capacity in the areas of analysis, planning and monitoring/evaluation. Ad hoc technical support is provided in addition to targeted training to increase skills. It has been recognized that the well-being and inclusion of vulnerable groups must be improved, and it will be necessary to develop effectively a community sanitation and rainwater drainage network and promote reforestation.

# Contribution of the organization to the work of the United Nations

At the high-level political forum on sustainable development in 2019, Michelle Bachelet, United Nations High Commissioner for Human Rights, said that "the 2030 Agenda is a once in a lifetime opportunity to bring human rights – and hope – to millions of people who today are left behind". In 2021, through a sustainable and resilient post-pandemic recovery that promises the economic, social and environmental dimensions of sustainable development, the forum addressed the integrated, indivisible and interdependent nature of development goals relating to the organization of communities that share a common geographic space.

# Participation in meetings of the United Nations

Since 2019, the sessions of the high-level political forum for development under the auspices of the Economic and Social Council have been held virtually. The exceptional context of the health crisis caused by the coronavirus disease (COVID-19) pandemic and its impact on the work of the United Nations inspired the theme

"Confronting COVID-19 through effective multilateral action". As a result, United Nations entities have responded to the call for an integrated approach to mitigating the negative impact on communities. In this context, the Council adopted a resolution on ensuring livelihoods, well-being and dignity for all.

# **Cooperation with United Nations bodies**

No cooperation was specified.

# Initiatives taken by the organization in support of the Sustainable Development Goals

The impact of the pandemic and the measures taken to mitigate it have had consequences that have exacerbated the vulnerability of communities. The Foundation has undertaken specific activities, taking into consideration local conditions and knowledge, to boost progress towards certain targets of the Sustainable Development Goals. In support of the efforts of the United Nations Development Programme and the Government of Togo to promote peace, the Foundation has incorporated a celebration of World Peace Day into its programme. This action responds to Sustainable Development Goal 16, which calls on States to promote peaceful and inclusive societies.

Similarly, the Association des Techniciens Radiodiffusion du Togo, in collaboration with the Foundation, has expanded its online presence beyond social media and has set up a website, www.atrt-togo.com.

# 2. ACSA

## Special, 2018

### Introduction

The Association camerounaise pour la santé des adolescents (ACSA) is a non-profit Cameroonian civil society organization established in March 1995 in Ngaoundere, a city in the northern part of Cameroon. It works in the field of public health in Cameroon. ACSA has implemented several health projects with technical support from the Ministry of Public Health of Cameroon.

# Aims and purposes of the organization

- To make adolescents aware of the importance of health and to encourage them to take responsibility for their own health and that of their community through their effective participation in tackling problems related to their general and long-term well-being
- To raise public awareness nationally regarding the specific nature of adolescent health problems
- To create an active network of members (health and non-health professionals) in order to promote the health of adolescents and encourage their effective participation in activities that will improve their quality of life
- To improve members' health-related behaviours and knowledge through information, education and communication
- To foster a new type of partnership between adolescents and various professions and organizations committed to improving the well-being of young people
- To encourage research in the field of adolescent health and the preservation and improvement of the environment in relation to good health

# 3. Action aides aux familles démunies

## Special, 2002

## Introduction

It is our inescapable duty as civil society actors to protect the vulnerable against contempt for humanitarian rights and to place human values at the heart of socioeconomic development policy. As supporters of and believers in solidarity and humanitarian aid, we decided to join forces and form an association called Action aides aux familles démunies (AAFD).

### Aims and purposes of the organization

The organization's main aim is to promote training activities in the field of development for the poorest groups, that is, awareness-raising, education and assistance for poor families to combat all forms of violence against women and girls including sexual slavery, female genital mutilation and domestic violence. It also aims to promote empowerment, by creating income-generating activities for women and girls, and to promote reproductive health.

## Significant changes in the organization

In practical terms, there have been changes due to the coronavirus disease (COVID-19) pandemic, since the organization participated in an awareness-raising campaign on the COVID-19 virus in rural and urban areas. It has also participated in the peace support programme, organizing forums in collaboration with the United Nations Multidimensional Integrated Stabilization Mission in Mali.

## Contribution of the organization to the work of the United Nations

Despite limited resources, AAFD has organized sessions to raise awareness of the COVID-19 virus. From 2019 until now, the meetings were held virtually because the participants could not travel in person, so only video conferences and webinars were possible.

# Participation in meetings of the United Nations

AAFD participates every year in all the meetings at United Nations Headquarters in New York, including the Commission on the Status of Women and the Commission on Social Development.

# **Cooperation with United Nations bodies**

AAFD is in good standing with all United Nations agencies.

# Initiatives taken by the organization in support of the Sustainable Development Goals

Within the framework of the Sustainable Development Goals, the organization has led training events for young people and has supervised the training of women and girls in all areas in order to empower them.

# 4. Agir ensemble pour les droits de l'homme

# Special, 1998

#### Introduction

Founded in 1992, Agir ensemble pour les droits de l'homme is a French non-governmental organization based in Lyon that has been working for more than 30 years to defend fundamental rights and freedoms around the world. Its action covers three areas:

- 1. Providing financial and technical support to small organizations working to defend human rights in countries where they are violated.
- 2. Providing emergency protection for human rights defenders whose safety is under threat.
- 3. Conducting advocacy with public authorities and international organizations. Our function is to join forces with civil society actors engaged in their

fields to combat human rights violations. Our actions contribute to strengthening their capacities and supporting their emergence.

# Aims and purposes of the organization

We foster the growth and development of organizations around the world that are working to protect and promote civil and political rights as well as economic, social and cultural rights. Our partnership with local organizations is part of an institutional relationship that is based on equality, trust, exchange, respect and reciprocity. Each stakeholder is independent and has agreed to pool its efforts in order to achieve a common goal.

## Significant changes in the organization

In 2018, Philippe Morié became the new Executive Director. In 2020, the Board of Directors voted to change the organization's name from "Agir Ensemble pour les Droits de l'Homme" to "Agir ensemble pour les droits humains (Agir ensemble)". This linguistic change was born of a genuine desire to actively support greater inclusiveness within the non-governmental organization and its activities. The name change was accompanied by a new visual identity.

## Contribution of the organization to the work of the United Nations

The organization serves as a relay between the United Nations and local associations, which are often small and isolated. The year 2020 and the coronavirus disease (COVID-19) pandemic greatly disrupted our working practices and we quickly developed expertise in online advocacy. Nevertheless, this affected our participation in the Geneva sessions and the submission of reports since it became very difficult to collect information on the ground with our partners.

## Participation in meetings of the United Nations

Together with Trésor Nzila Kendet, Director of the Congolese Observatory for Human Rights, we participated in the pre-session of the universal periodic review for the Congo held in Geneva in October 2018. The Observatory called on the international community to address the persistent use of arbitrary detention, torture and cruel, inhuman and degrading treatment in the Congo. Recommendations were then made to the Government of the Congo. On the margins of that meeting, contact was made with Jean-Claude Pongault Elongo, Director of Coeur Arc-en-Ciel, an association that defends the rights of sexual and gender minorities in the Congo.

# **Cooperation with United Nations bodies**

We have collaborated with human rights offices in Central Africa and the Sahel, where we are implementing projects, and with Michel Forst and subsequently Mary Lawlor, the Special Rapporteur on the situation of human rights defenders, facilitating online meetings with human rights defenders in the Congo and the Niger in 2021. As part of its support for the development of Tournons La Page, the organization has worked extensively with the Office of the United Nations High Commissioner for Human Rights, with the special rapporteurs Michel Forst and Mary Lawlor, Clément Voule and Irene Khan. The Agir ensemble-Tournons La Page project manager helped organize a virtual meeting between Mary Lawlor and human rights defenders of the Niger in June 2021 as well as the visit conducted to the Niger in December 2021 by Clément Voule, Special Rapporteur on the rights to freedom of peaceful assembly and of association. The latter greatly assisted in securing the release of the project manager, who was arrested during his visit.

# Initiatives taken by the organization in support of the Sustainable Development Goals

Sustainable Development Goal 5 is supported through projects that uphold women's rights (Buenaventura, DEFI 3 and Citoyennes engagées) and the rights of sexual and gender minorities (DEFI 3). Sustainable Development Goal 10 is supported through the implementation of projects that relate to access to rights for Indigenous Peoples (PEUPLE) and women (Citoyennes engagées). Sustainable Development Goal 16 is promoted by combating impunity for human rights violations or violence against human rights defenders. Lastly, Sustainable Development Goal 17 is at the heart of our relationships with partner organizations, since we work horizontally with them.

# 5. Alliance Vita

### Special, 2018

#### Introduction

Alliance Vita was founded in late 1993 to undertake general and assistance activities in the field of bioethics that promote respect for the life and dignity of all human beings at all stages of life, especially the most vulnerable.

# Aims and purposes of the organization

The mission of Alliance Vita is to promote solidarity with vulnerable people in France, Europe and the world. Its services comprise listening to and helping people facing life's trials; raising political and social awareness of measures to support the most vulnerable people; and providing training on bioethical issues at the national and international level.

### Significant changes in the organization

There have been no significant changes.

# Contribution of the organization to the work of the United Nations

Alliance Vita is developing expertise in supporting society and individuals by providing counselling services at the beginning and end of life and by raising public awareness of the issues of equality and development at all stages of life ("Change your perspective" campaign in 2022). Since 2020, the organization has been especially spurred to action by the impact of the coronavirus disease (COVID-19) pandemic: it has developed an platform providing information on measures to combat loneliness and economic insecurity; young people from the organization have developed an original initiative to forge intergenerational links with older persons every summer; it has disseminated information on maternity benefits; and it has collaborated with a French-speaking platform that provides grief support. The organization works actively to defend human rights by producing discussion papers concerning scientific choices in the areas of gene editing and human-animal chimerism.

#### Participation in meetings of the United Nations

A representative attended the fifth-seventh session of the Commission for Social Development, which was held from 11 to 21 February 2019. He made a statement on balancing family and professional life at a meeting on the theme "The value of unpaid care and domestic work. Is target 5.4 a utopia?", which was jointly organized by the Permanent Missions of Qatar and Hungary, the Division for Inclusive Social Development of the United Nations and the International Federation for Family

Development. The organization also submitted a report in June 2020 in the context of monitoring the implementation by France of the Convention on the Rights of the Child.

The organization submitted a written contribution in August 2021 in response to the call for comments and proposals from civil society on the draft convention on the right to development (Office of the United Nations High Commissioner for Human Rights (OHCHR)). A representative attended the twenty-second session of the Working Group on the Right to Development, held from 22 to 26 November 2021 in Geneva under the auspices of OHCHR.

# Cooperation with United Nations bodies

No direct cooperation.

# Initiatives taken by the organization in support of the Sustainable Development Goals

Alliance Vita has contributed in particular to Goals 1, 3, 5 and 16. Concerning Goal 3, which relates to good health and well-being, Alliance Vita has raised awareness in France and internationally through the 2019 campaign "Vulnerable generations" concerning maternity, which is also aimed at persons with disabilities and older or dependent persons. Assisting and supporting women and couples involved in pregnancy and motherhood, especially women facing financial poverty (link with Goal 1); providing support and raising public awareness, in France and internationally, and fostering intergenerational solidarity to combat loneliness and abandonment of older persons, and promoting support at the end of life; training and raising awareness among young people regarding the inclusion of persons with disabilities.

Concerning Goals 5 and 16, which relate to gender equality and the promotion of peace and justice, respectively, Alliance Vita has undertaken activities focused on protecting women and children from new forms of exploitation, on reproductive health education, and on raising awareness of other forms of violence, particularly sexual violence, or aimed at older persons. It has also conducted awareness-raising activities, in France and internationally, with the aim of combating trafficking in relation to pregnancy and children, in particular the practice of surrogacy. It has also run annual training programmes in France and in around 20 foreign countries on respect for human rights and equality between men and women in bioethical matters (procreation, end of life and disability).

## 6. Amis d'Afrique francophone Bénin

## Special, 2018

#### Introduction

Amis d'Afrique francophone Bénin is a development organization whose mission is to help address the socioeconomic and environmental problems faced by Beninese nationals in general and the most vulnerable in particular. Through awareness-raising and education, the organization aims to encourage the public to adopt a social and environmental value system that boosts sustainability in the country. That includes empowering communities, in this case women, increasing local sovereignty and promoting sustainable family farming to ensure food and nutritional security, recovering the lost environmental balance and improving living conditions.

## Aims and purposes of the organization

The organization was established in response to the United Nations International Conference on Environment and Development held in Rio de Janeiro in 1992 and the

Social Development Summit held in New York in 2000. It was created to promote appropriate ways of recognizing the social and economic rights of disadvantaged and vulnerable communities, and to promote environmental protection and improved living conditions. Its primary function is to find ways and means for people to participate in environmental protection and the sustainable management of natural resources, in particular forests, wetland ecosystems and biodiversity, and in the wellbeing of the communities dependent on those resources.

For the past four years, the organization has worked primarily to promote sustainable economic and social development in Benin. Its actions are principally focused on the environment, climate, energy, agriculture/apiculture and gender equality, in particular promoting the social and economic rights of women and youth, which includes young girls in rural areas.

By working closely with Beninese communities under stress, the organization has developed expertise in the agricultural, economic, social and environmental issues they face on a daily basis. Working with the Government of Benin, through the Ministry of Living Environment and Sustainable Development and the Ministry of Agriculture, on the redesign of a new strategy for boosting climate action and family farming, the organization has implemented and been involved in the implementation of several climate and agricultural projects in Benin.

# Significant changes in the organization

There have been no significant changes.

## Contribution of the organization to the work of the United Nations

Owing to financial constraints and the restrictions imposed by the United Nations in connection with the coronavirus disease (COVID-19) pandemic, our organization has not been able to contribute to the work of the United Nations for the past four years, since most of the work has taken place at United Nations Headquarters in New York.

# Participation in meetings of the United Nations

Owing to the COVID-19 pandemic and other reasons, our organization has experienced difficulties in mobilizing resources to participate in United Nations meetings and in their work for the past four years.

## **Cooperation with United Nations bodies**

The organization has collaborated with the United Nations Development Programme (Global Environment Facility Small Grants Programme) in Benin to support and promote the conservation of sacred forests and other traditionally conserved sites and the maintenance of the livelihoods of Indigenous Peoples and local communities, within the framework of the Global Support Initiative programme (Global Support Initiative for Indigenous Peoples and Community-Conserved Territories and Areas).

# Initiatives taken by the organization in support of the Sustainable Development Goals

Our organization has contributed to progress towards the achievement of Goal 4 in Benin by launching a project that supports the national education system by strengthening the capacities of primary school teachers. The project provides qualified training for nursery school and primary school teachers and thus improves the quality of education in Benin. The organization has also contributed to progress towards Goals

2, 8, 13 and 15 in Benin by launching a project to strengthen farmers' associations for development of the apiculture value chain in the commune of Bassila from 2018 to 2019. Thanks to the project, 120 beekeepers in the commune of Bassila have been trained in the best beekeeping techniques and in the organizational management of beekeeping. In addition, a large area of forest that had been degraded by melliferous plant species was restored. Other activities are focused on supporting the broader development agenda through awareness-raising, education, mobilization and advocacy.

# 7. Architectes de l'urgence

## Special, 2006

#### Introduction

The humanitarian organization Architectes de l'urgence was founded in 2001 and has been recognized as an entity operating in the public interest since 2007. It operates in the field on all continents and works to assist populations struggling in the aftermath of natural disasters or technological or human catastrophes. Since 2001, the organization has carried out more than 125 assistance and/or reconstruction and development projects in 41 countries, with architects and engineers taking part in its field activities.

# Aims and purposes of the organization

- To use the expertise of architects to help affected populations by providing appropriate support at each stage of a crisis: during damage assessment (ensuring safety), and the initial emergency phase.
- To help rebuild decent, sustainable housing and critical infrastructure (schools, hospitals and roads) for a return to normalcy.
- To help restart economic life by giving priority to the use of local materials, in line with sustainable development.
- To preserve and promote the world's architectural, historical and cultural heritage and respect the environment by combating the widespread use of wood.
- To support and foster humanitarian engagement among architects in France and elsewhere in the world, and thus contribute to the furtherance of architecture and encourage the training of local actors, from masons to architects.

The main challenge is to combine the urgency of disaster situations with the durability of sustainable, decent and quality constructions.

## Significant changes in the organization

There have been no significant changes.

# Contribution of the organization to the work of the United Nations

During its missions, the organization's priority is respect for its values and for the development objectives set by the Economic and Social Council. The emphasis is on economic and social integration, with a view to revitalizing a struggling local economy. This translates into the use of local materials and know-how, the employment of properly paid workers and the contracting of local small and medium-sized enterprises. The organization also provides training for local populations and authorities in earthquake- and/or hurricane-resistant construction techniques as needed. Once missions have ended, the tools and technologies used are transferred to the populations. At the same time, since the development of the youngest children is

a priority, the organization has invested in the construction and refurbishment of nearly 30 schools, nurseries and day-care facilities. The organization supports and implements projects in the health-care sector by providing technical assistance to other non-governmental organizations for building or renovating hospital infrastructure, as in Haiti, for example. It emphasizes social equity among the various beneficiary populations and ensures gender equality. Revitalizing local economies is also a way to combat poverty and stem the exodus from rural areas. By offering jobs and housing, the organization aims to reduce overall poverty. The projects implemented were designed with sustainable development in mind: local materials were used, including certified wood to limit deforestation, available energy sources were optimized and buildings were constructed to resist natural disasters.

## Participation in meetings of the United Nations

No participation was specified.

## **Cooperation with United Nations bodies**

The organization conducted a field analysis project in Pakistan with the United Nations Satellite Centre. It subsequently collaborated with the United Nations Human Settlements Programme (UN-Habitat) on a large scale in Haiti and created a methodology for assessing land and buildings in a disaster context. It also participated in the programme of the United Nations Office for Project Services following the earthquake in Haiti.

# Initiatives taken by the organization in support of the Sustainable Development Goals

2018: Reconstruction of four schools in Dominica. Reconstruction of two schools in Haiti. Reconstruction of two schools and training of 600 people in Nepal. Assessment missions to Mayotte, Guyana, the Philippines and Bangladesh.

2019: Production of a technical document of recommendations in Mayotte. Renovation of a school in Haiti. Renovation of a school in Madagascar. Emergency assistance following Cyclone Idai in Mozambique.

2020: Distribution of equipment during the health crisis in Amiens, France. Expert and training missions to Montreuil and Alpes-Maritimes in France. Assistance in the renovation of schools in Madagascar. Emergency assistance and renovation of housing for victims of the Beirut explosions in Lebanon.

2021: Conducting expert missions, ensuring safety, shipping equipment and implementing school reconstruction projects after the earthquake in Haiti in August. Shipping equipment to support reconstruction in the conflict area in Armenia. Continuation of reconstruction activity in Lebanon. Expert missions for buildings affected by floods Belgium.

# 8. Association apprentissage sans frontières

## Special, 2010

#### Introduction

The Association apprentissage sans frontières was founded in 2005 and is a non-governmental organization (NGO) that has held consultative status with the Economic and Social Council since 2010. The organization is active in promoting human rights and attaches particular importance to the right to education and lifelong learning, in keeping with the Sustainable Development Goals.

# Aims and purposes of the organization

The main aim of the organization is to promote human rights by fostering the right to education through apprenticeship. The organization contributes to the implementation of projects and to the organization of conferences and symposiums, in addition to carrying out public and private mandates in the area of education and human rights. Its purpose is to publicize the apprenticeship system as a means of combating youth unemployment by combining theory and practice in the workplace in developing countries.

### Significant changes in the organization

There have been no significant changes.

### Contribution of the organization to the work of the United Nations

The organization participates in and organizes various activities at the United Nations Office at Geneva in collaboration with Permanent Missions and international, bilateral and multilateral institutions.

### Participation in meetings of the United Nations

The organization has delivered several oral statements during annual sessions of the Human Rights Council:

- Oral statement on the importance of the involvement of NGOs in the implementation of the right to education, forty-first session, Geneva, 24 June– 12 July 2019

- Oral statement on the topic "COVID-19, an opportunity to strengthen cultural rights in Africa", forty-seventh session, Geneva, 21 June-14 July 2021
- Oral statement on the topic "Human rights training that is accessible to minorities and vulnerable persons without discrimination", forty-eighth session, Geneva, 13 September-11 October 2021

# **Cooperation with United Nations bodies**

The organization has cooperated with United Nations bodies by participating in the following activities:

It promotes agricultural activities and rural entrepreneurship for Indigenous Peoples and local communities to enable them to develop their skills and support themselves. It continues to combat poverty, HIV/AIDS and sexually transmitted diseases, to promote human rights, democracy and good governance, to promote a culture of peace and non-violence in the departments affected by armed conflicts caused by dictatorial regimes, to participate in the holding of free, transparent and peaceful elections, and to address racism and racial discrimination.

# Initiatives taken by the organization in support of the Sustainable Development Goals

From 2018 to the present day, it has carried out awareness-raising and capacitybuilding activities for young people and rural women and girls in keeping with the 17 Sustainable Development Goals in order to relay information to the wider public as well as to other stakeholders. The report also provides an opportunity to set out the slow progress made by the Cameroonian State towards achievement of the Sustainable Development Goals, especially in the areas of health, education and gender equality. In addition, the report

Celebration of special days dedicated to LGBTI persons in Cameroon. We also commemorate World AIDS Day every year on 1 December, by organizing a candlelight vigil in memory of the those who have died from AIDS.

# 15. Association solidarité internationale pour l'Afrique (SIA)

# Special, 2014

#### Introduction

The Association solidarité internationale pour l'Afrique (SIA) is an association under Malian law (Act No. 204), whose members are all natural or legal persons that are interested in its field of action. It is organized around its general assembly, which brings together all its members, its board of directors, which ensures the smooth running of the organization, and its secretariat, which implements its activities. It is a national non-governmental organization for the relief and development of rural and urban poor communities that is apolitical, secular and non-profit and is accredited to United Nations entities.

# Aims and purposes of the organization

The organization's mission is to promote the active and responsible participation of rural communities in their own development process.

Its aim is to contribute in a participatory way to the economic, social and cultural development of rural populations in all regions of Mali.

#### Significant changes in the organization

Yes. As of today, Mariyathas Mohanraj, Kulandaisamy Arokiyasamy no longer represents SIA at the United Nations Office at Geneva.

# Contribution of the organization to the work of the United Nations

In 2020, the human rights conference was disrupted by the coronavirus disease (COVID-19) crisis and all nations were called upon to unite in the fight against this pandemic. SIA contributed to this fight through conference debates.

On 18 October 2021, SIA participated on a virtual basis in the symposium: "Human rights in the digital sphere".

Every year, we organize Human Rights Week, during which women's rights are defended. We have also contributed to various sessions of the Human Rights Council.

Given that SIA is present in seven regions of Mali, where 45 villages have renounced violence against women and girls, where early or forced marriage has been renounced in all villages and where women are beginning to join decision-making bodies in the communes, we can say that we are contributing to the achievement of the objectives set by the United Nations.

## Participation in meetings of the United Nations

The organization has participated in sessions of the Human Rights Council since March 2015. All sessions were attended by Mariyathas Mohanraj, who will no longer represent our organization as of today. SIA has participated regularly in meetings on the human rights to peace, to education on the right to peace and to education on the culture of peace.

## **Cooperation with United Nations bodies**

No, we have not had any financial cooperation with the United Nations.

# Initiatives taken by the organization in support of the Sustainable Development Goals

- 1. Primary health care: promote reproductive health and child survival, and combat HIV/AIDS, female genital mutilation and diarrheal disease.
- 2. Drinking water: contribute to the installation of drinking water stations in villages, where needed, and promote sanitation and public hygiene.
- 3. Promotion of children and youth: reintegration of children in difficult situations, combat child labour and trafficking, and promote schooling for children in rural areas.
- 4. Promotion of women in rural areas: improve the socioeconomic and cultural living conditions of women; promote the participation of rural women in the economy, through the development of micro-enterprises; civic education (democratization and decentralization); support all women's initiatives in rural areas; promote women's literacy; safeguard women's rights.
- 5. Protection and safeguarding of the environment: protect and safeguard natural resources; promote reforestation in rural areas; promote sanitation and public hygiene; and protect and construct water infrastructure.
- 6. Promotion of centres for educational development: build school infrastructure, literacy centres and centres for educational development; encourage the enrolment of girls in school; train school management committees; provide schools and centres for educational development with teaching manuals; and upgrade school infrastructure.
