# 3. Recommendations of the working group to the special session of the United Nations Forum on Forests

In its resolution 2015/33, the Economic and Social Council established the working group of the Forum and mandated it to submit its proposals on the matters referred to in paragraph 44 of the same resolution for consideration by the Forum at its special session. Accordingly, the working group shall develop its proposals on: (a) replacement of the reference to the Millennium Development Goals in paragraph 1 (b) of the non-legally binding instrument on all types of forests (United Nations forest instrument) with an appropriate reference to the Sustainable Development Goals and targets and; (b) the strategic plan for the period 2017-2030 and the quadrennial programme of work for the period 2017-2020, consistent with section XI of resolution 2015/33. In developing its proposals, the working group shall take into account paragraphs 13 (b), 37, 38, 39 and 40 of the same resolution, the outcomes of the first and second meetings of the Open-ended intergovernmental ad hoc expert group established pursuant to paragraph 48 of Council resolution 2015/33, as well as the Addis Ababa Action Agenda of the Third International Conference on Financing for Development, the 2030 Agenda for Sustainable Development and the Paris Agreement on Climate Change.
