
Nomination of members of the Board of the United Nations Research Institute for Social Development

Note by the Secretary-General

- 1. The functions of the Board of the United Nations Research Institute for Social Development, which are set out in paragraph 3 of document ST/SGB/126 of 1 August 1963 and in its addenda, are:
- (a) To lay down general rules governing the action of the Institute in matters entrusted to it;
- (b) To review and approve work programmes and the relevant budgets of the Institute;
- (c) To submit regularly to the Commission for Social Development a progress report on the work of the Institute.
- 2. The present composition of the Board is:
 - (a) A Chair, appointed by the Secretary-General;
- (b) Ten members nominated by the Commission for Social Development and confirmed by the Economic and Social Council;
 - (c) A representative of the Secretary-General;
- (d) Representatives of selected United Nations specialized agencies, departments and regional entities who participate as observers;
- (e) The Director of the United Nations Research Institute for Social Development, ex officio.
- 3. The term of office of the members of the Board referred to in subparagraph 2 (b) above is four years, renewable once for a further period of two years. ¹

¹ In its resolution 10 (XXV), the Commission decided that the term of office of each nominated member of the Board should not exceed a total of six years.

- 7. At its fifty-third session, the Commission will be called upon to extend the terms of office of the two members referred to in paragraph 5 above for an additional two-year term expiring on 30 June 2017.
- 8. In view of the current financial circumstances of the Institute and its reduced staff numbers as a result of resource constraints, the Commission is requested to consider nominating only one new member to the Board at the fifty-third session. As such, as of July 2015, the Board would have eight members and two seats would be left vacant.
- 9. Should the Commission agree to this proposal, it will be called upon to nominate one new member for a four-year term expiring on 30 June 2019. The biographical information of the proposed candidate is contained in the annex to the present note.
