# Organization of the session

## A. Opening and duration of the session

1. The Commission for Social Development held its fifty-sixth session at United Nations Headquarters on 10 February 2017 and from 29 January to 7 February 2018. The Commission held [] meetings (1st to []).

- 4. At its 1st meeting, on 10 February 2017, the Commission elected, by acclamation, Yao Shaojun (China) and Bruno Ríos Sánchez (Mexico) as Vice-Chairs of the fifty-sixth session.





- 5. At its 2nd meeting, on 29 January 2018, the Commission elected, by acclamation, Nikulás Hannigan (Iceland) as Chair of the fifty-sixth session of the Commission.
- 6. At the same meeting, the Commission elected, by acclamation, Lot Thauzeni Pansipadana Dzonzi (Malawi) and Mihaela Mecea (Romania) as Vice-Chairs of the fifty-sixth session of the Commission.
- 7. Also at the same meeting, the Commission designated the Vice-Chair of the Commission, Mihaela Mecea (Romania), as Rapporteur of the fifty-sixth session.
