## **Draft proposed programme plan and performance information for 2020**\*\*\*

## Note by the Secretariat

1. Pursuant to the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation (ST/SGB/2018/3), the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice have before them, for their information, an advance, unedited version of the draft proposed programme plan and performance information for 2020 on international drug control, crime and terrorism prevention and criminal justice.

2. The draft was shared with the commissions at their reconvened sessions in December 2018 in a conference room paper (E/CN.7/2018/CRP.11-E/CN.15/2018/CRP.8) under the title "Draft annual programme implementation plan for 2020 for the United Nations Office on Drugs and Crime".<sup>1</sup>

3. The draft was based upon and incorporated comments made by Member States during the various sessions of the open-ended intergovernmental working group on
