Action taken by the subsidiary bodies of the Commission on Narcotic Drugs

Report of the Secretariat

I. Introduction

1. The subsidiary bodies of the Commission on Narcotic Drugs held extraordinary online sessions from 20 to 24 September 2021, ¹ organized from the seat of the Commission in Vienna, as follows: the Meeting of Heads of National Drug Law Enforcement Agencies, Europe, on 20 September; the Meeting of Heads of National Drug Law Enforcement Agencies, Africa, on 21 September; the Subcommission on Illicit Drug Traffic and Related Matters in the Near and Middle East, on 22 September; the Meeting of Heads of National Drug Law Enforcement Agencies, Asia and the Pacific, on 23 September; and the Meeting of Heads of National Drug Law Enforcement Agencies, Latin America and the Caribbean, on 24 September 2021.

2. In the light of the continuing coronavirus disease (COVID-19) pandemic, the Commission had agreed in May 2021, by the silence procedure, that the meetings of the subsidiary bodies of the Commission to be held in 2021 would be held in an online format, as extraordinary sessions, with one day scheduled for each subsidiary body.

3. Each of the subsidiary bodies discussed the impact of the COVID-19 pandemic in its region with regard to the topics to be discussed by the Commission at the thematic discussions² to be held in October 2021.

4. In total, 660 participants from 99 countries and 40 observers from 11 organizations participated in the online extraordinary sessions of the subsidiary bodies of the Commission on Narcotic Drugs.

II. Meetings of the subsidiary bodies of the Commission on Narcotic Drugs

A. Meeting of Heads of National Drug Law Enforcement Agencies, Europe

5. Three meetings of the extraordinary session of the Meeting of Heads of National Drug Law Enforcement Agencies, Europe, were held on 20 September 2021. The extraordinary session was chaired by the Permanent Representative of Malta to the United Nations (Vienna), who provided opening remarks. A statement (pre-recorded video) was made at the opening of the meeting by the Executive Director of the United Nations Office on Drugs and Crime (UNODC). A statement (pre-recorded video) was also made by the Chair of the Commission on Narcotic Drugs.

6. The Secretary of the Commission on Narcotic Drugs gave a presentation on the work of the Commission.

7. Representatives of Albania, Andorra, Armenia, Austria, Azerbaijan, Belarus, Belgium, Bulgaria, Canada, Cyprus, Denmark, France, Georgia, Germany, Hungary, Ireland, Israel, Italy, Latvia, Lithuania, Malta, Norway, Poland, Portugal, the Republic of Moldova, the Russian Federation, Slovakia, Slovenia, Spain, Sweden, Turkey, Ukraine and the United States of America attended the meeting. The European Monitoring Centre for Drugs and Drug Addiction, the European Union, the International Narcotics Control Board, the International Criminal Police Organization (INTERPOL), the Organization for Security and Cooperation in Europe (OSCE), the Southeast European Law Enforcement Center and the World Customs Organization (WCO) were also represented by an observer.

Observers for the Russian Federation also attended the meeting. The Economic Commission for Latin America and the Caribbean, the International Narcotic Control Board, INTERPOL, the Organization of American States, OSCE and WCO were also represented by an observer.
