PROVISIONAL AGENDA FOR THE THIRTIETH SESSION OF THE COMMISSION

Note by the Secretariat

1. In accordance with Economic and Social Council resolution 1894 (LVII), the following draft provisional agenda for the thirtieth session of the Commission has been prepared on the basis of existing legislative authority. It will be completed at the present session in the light of resolutions and decisions adopted by the Commission and will be submitted to the Economic and Social Council for review, in accordance with Council resolution 1979/41.

2. According to the topic-oriented and prioritized multi-year work programme of the Commission, which was endorsed by the Economic and Social Council in its resolution 1995/55, the theme for 1997 is international migration, with special emphasis on the linkages between migration and development and on gender issues and the family.

- 3. General debate on national experience in population matters.
- 4. Follow-up actions to the recommendations of the International Conference on Population and Development: international migration, with special emphasis on the linkages between migration and development and on gender issues and the family.
