Non-governmental organizations considered for accreditation to the forty-seventh session of the Commission on Population and Development

Note by the Secretariat

1. In its resolution [65/234](#), the General Assembly decided to convene a special session on the follow-up to the International Conference on Population and Development beyond 2014. Recalling that resolution, in which the Assembly stressed the need for the effective participation and contribution of relevant actors of civil society, particularly non-governmental organizations, in the preparations for the special session, the Assembly, in its resolution [67/250](#), also stressed the need for the effective participation, as appropriate, of actors of civil society, particularly non-governmental organizations, in the forty-seventh session of the Commission on Population and Development, taking into account the practice and experience gained from the 1994 International Conference on Population and Development.
2. At its meeting on 12 March 2014, the Bureau of the forty-seventh session of the Commission requested the Secretariat to provide for the accreditation of civil society organizations not in consultative status with the Economic and Social Council. Subsequently, the Population Division, with the support of the Office for Economic and Social Council Support and Coordination, invited civil society organizations not in consultative status to apply for accreditation through the website of the Commission, observing the noon deadline on 28 March 2014.
3. The Population Division reviewed each application that had been received by the deadline on the basis of the provisions set out in the annex of Council resolution 1993/4. The list of civil society organizations not in consultative status with the Council recommended by the Population Division for accreditation to the forty-seventh session of the Commission is contained in the annex to the present document.
