## Organization of the session

## A. Opening and duration of the session

- 1. The Commission on Population and Development held its fifty-fifth session at Headquarters on 23 April 2021 and from 25 to 29 April 2022. The Commission held [\_\_\_] meetings (1st to [\_\_\_]).
- 2. The Commission, pursuant to the organization of work adopted at its 2nd meeting, held on 25 April 2022, and taking into account the impact of the prevailing conditions relating to the coronavirus disease (COVID-19) pandemic on the working arrangements for its fifty-fifth session and the available technological and procedural solutions for the interim period, also convened [\_\_] virtual informal meetings to hold three interactive panel discussions, comprising one multi-stakeholder panel, one expert panel and one panel of national experts. Also at its 2nd meeting, on the proposal of its Bureau, the Commission decided, without setting a precedent for its future sessions, that Member States, observer States and intergovernmental organizations, as well as specialized agencies, related organizations and civil society organizations, might submit a pre-recorded statement, which would be played in the conference room during the general discussion under agenda item 3.
- 3. At the 2nd meeting, the session was opened by the Chair of the Commission, Enrique A. Manalo (Philippines), who also made a statement.
- 4. At the same meeting, the Deputy Secretary-General, the Executive Director of the United Nations Population Fund, the Under-Secretary-General for Economic and Social Affairs of the Department of Economic and Social Affairs and the Secretary-General of the United Nations Conference on Trade and Development addressed the Commission.





5. Also at the same meeting, a keynote statement was made by the Professor in the Department of Economics of the University of Massachusetts at Amherst, Jayati Ghosh.

#### B. Attendance

6. The session was attended by representatives of [\_\_\_] States members of the Commission.
