The election will take place on 13 January 2015.

### Strengthening predictability of the UNICEF response to humanitarian crises: Proposal to increase the Emergency Programme Fund ceiling

The Executive Board will be updated on the unprecedented humanitarian crises children faced in 2014 and the steps that have been taken to further enhance UNICEF role as a predictable and efficient humanitarian partner through the Strengthening Humanitarian Action initiative.
