Financial report

I. Introduction

1. The present financial report is submitted pursuant to the request by the States parties to the Treaty on the Non-Proliferation of Nuclear Weapons.
2. To promote greater financial transparency and accountability, and taking into account the practice of multilateral and other organizations, the Preparatory Committee for the 2010 Review Conference of the Parties to the Treaty on the Non-Proliferation of Nuclear Weapons, at the 12th plenary meeting, on 6 May 2008, of its second session, adopted a decision in which it requested the Secretary-General of the United Nations to provide a financial report to the Review Conference and each session of its Preparatory Committee, to be circulated as an official document.
3. Recalling that the costs associated with the preparation and holding of the Review Conference and the sessions of its Preparatory Committee would be borne by the States parties to the Treaty and that there would be no financial implications for the regular budget of the United Nations, the Committee agreed, at the same meeting, that assessed and outstanding dues must be paid in proper time.

II. Observations

4. While most States parties are meeting their financial obligations, in some cases amounts outstanding since 1995 remain unpaid.

III. Financial status

5. The following table provides information, as at 12 April 2018, on the amounts owed by the States parties for each Review Conference cycle since 1995.
