EMERGENCY REGULATIONS FOR THE PREVENTION

OF TERRORISM ISSUED BY THE DEFENCE

For the information of the Security Council:

PROVISIONAL GOVERNMENT OF ISRAEL HAS COMMUNICATED TO ME FULL TEXT OF LAW AND ALMINISTRATION ORDINANCE 5708 - 1948 TITLED "EMERGENCY REGULATIONS FOR THE PREVENTION OF TERRORISM", ISSUED BY THE DEFENCE MINISTER, AND WHICH ARE SUMMARIZED HEREWITH.

ONE, A TERRORIST ORGANIZATION MEANS A BODY OF PERSONS WHICH IN ITS OPERATIONS MAKES USE OF ACTS OF VIOLENCE WHICH ARE LIABLE TO CAUSE THE DEATH OF A PERSON OR TO INJURE THEM. OR THREATS OF SUCH ACTS OF VIOLENCE. TWO, A PERSON WHO TAKES PART IN THE MANAGEMENT OF A TERRORIST ORGANIZATION OR PARTICIPATES IN THE DELIBERATIONS OF A TERRORIST ORGANIZATION SHALL BE LIABLE TO IMPRISONMENT FROM FIVE TO TWENTY YEARS, OR WHO IS A MEMBER OF A TERRORIST ORGANIZATION SHALL BE LIABLE TO IMPRISONMENT FROM ONE TO FIVE YEARS, OR WEO SUPPORTS A TERRORIST ORGANIZATION BY WORD OR DEED SHALL BE LIABLE TO IMPRISONMENT UP TO THREE YEARS, OR A FINE UP TO ONE THOUSAND POUNDS OR TO BOTH SUCE PENALTIES. THREE, ALL PROPERTY BELONGING TO OR SERVING A TERRORIST ORGANIZATION SHALL BE FORFEITED TO THE STATE. THE TYPE OF EVIDENCE NECESSARY TO PROVE OTFENCES UNDER THESE REGULATIONS EFFECTIVE ONLY AFTER 14 MAY 1948, SUCH EVIDENCE BEING LESS STRICT THAN EVIDENCE REQUIRED UNDER GENERAL RULES OF EVIDENCE. FIVE, ALL CASES BROUGHT UNDER THESE REGULATIONS SHALL BE TRIED BY A MILITARY COURT APPOINTED BY THE CHIEF OF THE GENERAL STAFF. SIX, THE ARGUMENT OF THE COURT SHALL BE SUBJECT TO REVIEW BY THE DEFENCE MINISTER. SEVEN, THESE REGULATIONS SHALL NOT DERCGATE FROM THE CRIMINAL RESPONSIBILITY OF A PERSON WHO COMMITS AN OFFENCE CONTRARY TO ANY OTHER LAW.
