Annex**Letter dated 11 April 2001 from the Secretary-General of the North Atlantic Treaty Organization to the Secretary-General**

I am writing to inform you that the North Atlantic Council agreed to authorize the Commander of the Kosovo Force (KFOR) to allow the return of Federal Republic of Yugoslavia/Serbian forces to sector D of the Ground Safety Zone, corresponding to the municipality of Medvedja, subject to the agreement of the Federal Republic of Yugoslavia/Serbian authorities and to specific conditions stipulated by the KFOR Commander. This decision will be effective as from Thursday, 12 April.

With regard to the controlled entry of the Federal Republic of Yugoslavia/Serbian forces into sector B of the Ground Safety Zone, the Council will consider the situation at a later stage, taking into account the security implications and the appropriate timing for such entry.

In taking the decision to allow the return of the Federal Republic of Yugoslavia/Serbian forces to sector D, the Council took into consideration the security implementations of such return, as well as the report of my Personal Representative, Mr. Feith, on his recent visits to the region together with Mr. Lehne, the Personal Representative of the European Union High Representative, Javier Solana. The Council welcomed the steps taken by the Federal Republic of Yugoslavia and Serbian authorities, in particular the start of the dialogue with representatives of the ethnic Albanian community, the efforts of the Deputy Prime Minister of Serbia, Nebojsa Covic, to establish increased control over the actions of the Serbian police, his agreement to discuss the return of ethnic Albanian displaced persons to Medvedja and his agreement in principle to the establishment of a multi-ethnic police force.

While these steps are certainly encouraging, more visible progress needs to be made on both confidence-building measures and the dialogue before the Council considers the return of Federal Republic of Yugoslavia/Serbian forces to sector B. I have written to both Mr. Covic and the Federal Minister for Foreign Affairs, Goran Svilanovic, recalling the expectations of the international community in general, and NATO in particular, that there should be more rapid and substantial progress in the implementation of confidence-building measures. I have made clear that, in its consideration of additional decisions, the Council will wish to see concrete progress in the dialogue, the granting of amnesty, the setting up of a multi-ethnic police force and the return of ethnic Albanian displaced persons to Medvedja. The Council will expect Mr. Covic and Mr. Svilanovic to address these issues when they visit NATO headquarters on 25 April.

The Council's decisions constitute another step in the determination of NATO to contribute to the peaceful resolution of the problems in southern Serbia. The return of Federal Republic of Yugoslavia/Serbian forces to sector D represents an important test case for future decisions regarding sector B, as the Medvedja municipality is an area with a mixed population. Therefore, NATO and KFOR will be closely monitoring the returning Federal Republic of Yugoslavia/Serbian forces. In this context, we expect that individuals who were involved in Kosovo in 1998 and 1999 will not be part of the returning forces.

The Council will also wish to see steps taken by the ethnic Albanian community, in particular towards the demilitarization of armed groups. I hope that the process of the dialogue will address this and other relevant issues.

I will keep you informed of further Council decisions as they are taken.
