

Annex

Monthly report to the United Nations on the operations of the Kosovo Force

- 1. Over the reporting period (1-30 September 2002) there were almost 32,400 troops of the Kosovo Force (KFOR) in theatre.
- 2. The overall situation in Kosovo during the month of September remained generally stable.

Security

- 3. During the period under review there were no direct attacks on KFOR personnel. Isolated, non-related, inter-ethnic incidents of violence were reported. On 10 September, an explosion occurred in a Kosovo Albanian house in Donja Godance (10 km south-west of Lipljan). On the same day, a hand grenade exploded in a house in Gnjilane, injuring a Roma woman. On 11 September, a hand grenade exploded in a Kosovo Serb yard in Kololec (5 km east of Kamenica), following which Kosovo Serbs blocked the road and allegedly beat some Kosovo Albanians. On 15 September, a hand grenade exploded in a Kosovo Albanian shop in Glogovac, and on 16 September a grenade was thrown against a Kosovo Protection Corps (KPC) building in Mitrovica South.
- 4. Demonstrations to protest against attempts to arrest Milan Ivanovic (a member of the Kosovo Assembly and leader of the Serb National Council for Northern Kosovo)^a were held, but did not give rise to any violence. The frequency of these demonstrations diminished by the end of the month.
- 5. The situation in Mitrovica remained relatively calm, although there were some incidents reported. For example, on 1 September an explosion occurred in Mitrovica North close to a Kosovo Serb house, and on 9 September a hand grenade exploded in front of a Kosovo Albanian house. No one was injured and no arrests were made.
- 6. KFOR continued to carry out Kosovo-wide search operations in its campaign against weapons smuggling and any activity of ethnic Albanian armed groups. Weapons and ammunition were seized on a daily basis. Items confiscated during the month included 149 assorted weapons, 7,478 grenades and mines, and 9,882 rounds of ammunition.

Border/boundary security

7. The number of illegal border crossing incidents increased slightly in September, with 24 reported incidents. Most of these occurred on the border with Albania and most of those arrested were ethnic Albanians.

a Milan Ivanovic eventually gave himself up on 9 October at gate 1 of Multinational Brigade (North). He was subsequently taken by UNMIK police to the Mitrovica North court house where he was charged by an international judge with leading a violent demonstration and related offences. After pleading not guilty to the charges, he was released on bail of €10,000.

Cooperation and compliance by the parties

- 8. Security forces of the Federal Republic of Yugoslavia remain in compliance with the terms and conditions of the Military Technical Agreement.
- 9. The strength of the Kosovo Protection Corps is currently 3,101 active members. The priority of the KFOR Commander remains the strict control and supervision of KPC and, to that end, he has introduced more liaison officers at the Regional Task Group and detachment levels.
- 10. With regard to non-compliance, 12 cases were reported during the period under review, and 35 cases remained open at the end of September.
- 11. Four meetings of the KPC Infrastructure Working Group were held during the month of September to discuss a revised policy paper on KPC infrastructure, and draft plans for the rationalization of KPC sites. Although general agreement was reached on the policy paper, there was no consensus on the draft plans for KPC sites.
- 12. As previously reported, following the agreement between the Special Representative of the Secretary-General, Michael Steiner, and Nebojsa Covic on the integration of Kosovo Serbs into the Kosovo Police Service (KPS), Kosovo Serb KPS trainees undertook patrols for the first time in Mitrovica North from 24 to 27 September. Plans are in place for the cadets to conduct three more one-week periods of duty in Mitrovica.

Cooperation with international organizations

- 13. On 6 and 7 September, KFOR supported UNMIK during a search operation to identify illegally owned, high-value vehicles stolen in Western Europe.
- 14. On 27 September, KFOR conducted a joint exercise with UNMIK police and KPC to improve coordination of agencies that might be involved in responding to civil emergencies. KFOR reported that the aims and objectives of the exercise had been met.

Outlook

15. The security situation in Kosovo is expected to remain stable. The risk of tension arising following the municipal elections to be held in October is estimated to be low.
