Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

During the week ending 26 June 2004, the Security Council took action on the following items:

Role of civil society in post-conflict peace-building

The Security Council met to consider the item at its 4993rd meeting, held on 22 June 2004 in accordance with the understanding reached in its prior consultations, having before it a letter dated 1 June 2004 from the Permanent Representative of the Philippines to the United Nations addressed to the Secretary-General (S/2004/442). There was one suspension and one resumption of the meeting.

The President, with the consent of the Council, invited the representatives of Australia, Bangladesh, Canada, Egypt, Ireland, Japan, Nepal, Peru, the Republic of Korea, Senegal, Sierra Leone, South Africa and Uganda, at their request, to participate in the discussion without the right to vote.

In accordance with the understanding reached in the Council's prior consultations, the President, with the consent of the Council, extended invitations under rule 39 of the Council's provisional rules of procedure to Marjatta Rasi, President of the Economic and Social Council, Denis Caillaux, Secretary-General of CARE International, and Ian Martin, Vice-President of the International Center for Transitional Justice.
