### Summary statement by the Secretary-General on matters of which the Security Council is seized and on the stage reached in their consideration

#### Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, and in accordance with paragraph 7 of the note by the President dated 19 December 2007 (S/2007/749), the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council was seized as at 5 July 2008 is contained in document S/2008/10/Add.26 of 10 July 2008.

The present addendum lists the items on which the Security Council took action during the week ending 26 July 2008. The dates given for each item indicate when the item was first taken up by the Council at a formal meeting, and the most recent formal meeting of the Council held on that item.

#### The situation in Georgia (8 October 1992; 21 July 2008)

The Security Council resumed its consideration of the item at its 5939th meeting, held in private on 21 July 2008. At the close of the meeting, in accordance with rule 55 of the provisional rules of procedure of the Security Council, a communiqué was issued through the Secretary-General in place of a verbatim record (S/PV.5939).

## The situation in the Middle East, including the Palestinian question (3 October 2000; 22 July 2008)

The Security Council resumed its consideration of the item at its 5940th meeting, held on 22 July 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representatives of Argentina, Cuba, the Islamic Republic of Iran, Israel, Japan, Jordan, Lebanon, Malaysia, Qatar and the Syrian Arab Republic, at their request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended an invitation to B. Lynn Pascoe, Under-Secretary-General for Political Affairs.

In response to the request contained in a letter dated 18 July 2008 from the Permanent Observer of Palestine to the United Nations addressed to the President of the Security Council (S/2008/473), the President, in accordance with the rules of



procedure and the previous practice in this regard, invited the Chargé d'affaires a.i. of the Permanent Observer Mission of Palestine to participate in the meeting.

## Letter dated 22 November 2006 from the Secretary-General addressed to the President of the Security Council (S/2006/920) (1 December 2006; 23 July 2008)

The Security Council resumed its consideration of the item at its 5941st meeting, held on 23 July 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Nepal, at his request, to participate in the consideration of the item without the right to vote. The Council proceeded to vote on draft resolution S/2008/472, submitted by the United Kingdom of Great Britain and Northern Ireland, and adopted it unanimously as resolution 1825 (2008).

### The situation in Somalia (17 March 1992; 23 July 2008)

The Security Council resumed its consideration of the item at its 5942nd meeting, held on 23 July 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Somalia, at his request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended invitations to Ahmedou Ould Abdallah, Special Representative of the Secretary-General for Somalia, and Ramtame Lamamra, Commissioner for Peace and Security of the African Union.

### Meeting of the Security Council with the troop-contributing countries pursuant to resolution 1353 (2001), annex II, sections A and B (10 September 2001; 24 July 2008)

### **United Nations Operation in Côte d'Ivoire**

The Security Council resumed its consideration of the item at its 5943rd meeting, held in private on 24 July 2008. At the close of the meeting, in accordance with rule 55 of the provisional rules of procedure of the Security Council, a communiqué was issued through the Secretary-General in place of a verbatim record (S/PV.5943).

# Security Council resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) (5 November 1999; 25 July 2008)

The Security Council resumed its consideration of the item at its 5944th meeting, held on 25 July 2008. The Council, under rule 37 of its provisional rules of procedure, invited the representative of Serbia, at his request, to participate in the consideration of the item without the right to vote. Under rule 39 of its provisional rules of procedure, the Council extended invitations to Lamberto Zannier, Special Representative of the Secretary-General and Head of the United Nations Interim Administration Mission in Kosovo, and to Skender Hyseni.
