Letter dated 23 January 2008 from the Secretary-General to the President of the Security Council

I have the honour to refer to my letter dated 7 December 2007 (S/2007/725) to which was attached a note wherein I outlined the progress made with respect to the termination of operations of the United Nations Iraq Account under Security Council resolution 1483 (2003).

In that note, I informed the Council that the Government of Iraq and the Secretariat had agreed to set up a working group to minimize the number of unpaid letters of credit. In this respect, I should like to inform the Council that a meeting of the Working Group was held from 7 to 17 January 2008 in Amman. The Working Group was composed of representatives of the Ministry of Foreign Affairs of Iraq, the Central Bank of Iraq and the United Nations Secretariat.

The Working Group met with the concerned ministries of the Government of Iraq to address and resolve issues arising from the claims of suppliers that were enumerated in my note. In this respect, I transmit herewith the full report of the Working Group outlining the progress made with respect to the issues involved (see annex).

In addition, I indicated in my note my intention to transfer approximately \$161 million of unencumbered funds to the Development Fund for Iraq. That amount was subsequently transferred to the Development Fund for Iraq, on 27 December 2007. It is my intention to continue to transfer unencumbered funds to the Development Fund for Iraq consistent with Security Council resolution of 1483 (2003) as the process of termination of the programme continues. At the same time, the reserve of \$187 million and the balance of \$225 million referred to in paragraph 1 of my note would be retained until all remaining issues have been resolved.

The Security Council may wish to take into account the foregoing information when addressing the proposals referred to in paragraph 67 of the note contained in document S/2007/725. Particular attention may be paid to the recommendation in paragraph 67 (f) of the note regarding the establishment of a mechanism to handle any issues that remain unresolved after the completion of the work of the Working Group. In this regard the Council may wish to note that the Working Group expects to meet again in mid-March to review progress achieved in the interim. The Council will be informed of the outcome of the meeting.

Annex**Meeting of the Working Group regarding the termination of operations relating to letters of credit under the oil-for-food programme****Amman, 7-17 January 2008**

1. The Secretary-General has kept the Security Council apprised of operations related to letters of credit opened under the oil-for-food programme, including concerns raised by suppliers. In various letters to the Security Council, the Secretary-General advised that:

(a) The responsible authorities in Iraq be urged to process authentication documents promptly so that payments could be made according to the terms and conditions of the letter of credit;

(b) The processing of authentication documents not be delayed on account of commercial disputes, which should instead be handled in accordance with commercial dispute resolution practices. The Secretary-General also noted that while the normal practice was to close a letter of credit 90 days after its expiry, the difficulties encountered in the processing of authentication documents required that funding be retained in the United Nations Iraq Account for expired letters of credit. To provide for the termination of the oil-for-food programme in an orderly manner, it was proposed in a meeting held in November 2007 of the representatives of the Government of Iraq and the Secretariat that a working group be set up, composed of members of the Secretariat, the Central Bank of Iraq and the relevant ministries of the Government of Iraq, in order to minimize the number of unpaid letters of credit as at 31 December 2007 for which claims of delivery had been made. On 7 December 2007 the Secretary-General transmitted to the President of the Security Council a note (S/2007/725), which is under consideration by the Council, outlining the proposals to address unresolved issues, including the establishment of mechanisms to deal with such issues.

2. Against this background, a meeting was held from 7 to 17 January 2008 in Amman of the Working Group, which was composed of representatives of the Ministry of Foreign Affairs of Iraq, the Central Bank of Iraq and the United Nations Secretariat in order to minimize the number of letters of credit unpaid as at 31 December 2007 for which there were known claims of delivery. The Working Group met with the concerned ministries of the Government of Iraq to address and resolve issues arising from 179 outstanding letters of credit that were enumerated in the note by the Secretary-General. The Working Group reviewed all outstanding claims of delivery so that the concerned ministries could confirm the delivery and issue and transmit the necessary documents as soon as possible following the session of the Working Group.

Status of the programme and developments since the November 2007 meeting

3. The Working Group was briefed on the current status of processing of active letters of credit as at 31 December 2007. It was noted that the number of letters of credit had decreased from 215 at the end of November to 210 at the end of December. However, it was also noted that the unpaid letters of credit that were pending with BNP Paribas had not been significantly reduced.

4. As a result of the comprehensive and intensive review of each letter of credit outstanding as at the effective termination date of 31 December 2007, the Working Group was able to agree on the categorization of all 210 outstanding letters of credit summarized in table 2 (see table 3).

^d Concerned ministries have indicated that there are commercial disputes with the sellers of goods concerning quality and/or shortages and that the buyer and seller are negotiating to resolve those issues; the buyers in Iraq believe that the disputes will be resolved under normal commercial practices before 31 March 2008 and the confirmations of arrival will be forthcoming before that date (see annex II).

- (iv) Belief of buyers that sellers have shipped in full or in part.

The Working Group discussed those 17 letters of credit in greater detail and was briefed on the Security Council's request to the Secretariat to issue all necessary documentation to BNP Paribas for early settlement of the related payments associated with them. The Working Group also noted that the Secretary-General, in his note to the President of the Security Council, had indicated that the Secretariat had issued all the necessary documentation to BNP Paribas for the settlement of the 17 letters of credit referred to in the letter dated 25 July 2007 from the Secretary-General to the President of the Security Council (S/2007/476).

Confirmation of arrival of goods in Iraq

5. As a result of its activities and discussions, the Working Group recognized the following:

(a) Despite the continued calls from the Security Council and the Secretariat, the issuance of confirmations of arrival has been slow and at times not forthcoming;

(b) Under the existing procedures pursuant to Security Council resolutions 986 (1995) and 1546 (2004), payments cannot (absent an express exception by the Security Council) be made to suppliers who deliver goods and services to Iraq without the issuance of confirmations of arrival by the Central Bank of Iraq, which is the institution designated by the Government of Iraq to issue them;

(c) The Central Bank of Iraq was unable to issue the confirmations of arrival to the Secretariat as a result of the buyers' failure to provide a written confirmation of the arrival of goods from the respective warehouses of the buyers or the respective ministries of the Government of Iraq.

Agreement reached on the confirmation of arrival of goods in Iraq

6. The concerned ministries that participated in the activities of the Working Group have agreed to the following:

(a) On the claims that have been outstanding between 2004 and 2007, the confirmations of arrival would be delivered by the buyers in Iraq on an immediate and urgent basis to the Central Bank of Iraq, which in turn would be delivered to the Secretariat so that they can be paid without further delay;

(b) On the claims that are outstanding and on which there are commercial disputes between the buyer and the seller, the negotiations will conclude and the confirmations of arrival will be delivered to the Central Bank of Iraq, which in turn will be delivered to the Secretariat before 31 March 2008.

Commercial disputes between buyer and seller

7. On the claims from the buyers against the sellers of goods for shipments that have already been paid, the ministries that participated in this Working Group agreed that such commercial disputes would be settled outside the oil-for-food programme and should be pursued in accordance with the normal commercial procedures, namely, replacement of goods that do not meet the specifications, making additional shipments in the case of shortages, refunding payments made, returning the goods to the seller or instructing the seller to pick up the goods. The Secretariat will assist in providing any required information and documentation on these issues. However, it cannot be involved in settling the commercial disputes of buyers and sellers.

Letters of credit to be cancelled and release of "cash collateral" from the United Nations Iraq Account

8. To maximize the number of letters of credit cancelled by 31 March 2008, it was agreed that there were currently 57 letters of credit (see annex IV) with an approximate value of \$184 million that are targeted for cancellation. Among them are 25 letters of credit with an approximate value of \$166 million that have no

documents pending with the Bank. They would be cancelled immediately after verification by the Secretariat that they had no claims of delivery.

9. The Secretariat agreed to review the 32 letters of credit with an approximate value \$17 million for which there are documents pending with the Bank to determine whether they could be cancelled and whether the associated cash collateral could be released from the collateral portion to the non-collateral portion of the United Nations Iraq Account.

10. Once this review has been completed by the Secretariat, the funds related to the 57 letters of credit will in principle be available for transfer to the Development Fund for Iraq in accordance with Security Council resolution 1483 (2003).

Claims against letters of credit that have been cancelled

11. The Working Group recognized that in certain situations, claims of delivery were communicated or discovered after the letters of credit had been cancelled. The Working Group agreed that they would be reviewed on a case-by-case basis for final resolution of the claim as long as the shipment was valid in the context of the related letter of credit.

Transfer of funds to the Development Fund for Iraq

12. In relation to the issue of the transfer of funds to the Development Fund for Iraq and the establishment of the claims settlement mechanism, the Government of Iraq has again expressed its reservations with respect to the establishment of a claims settlement mechanism. The Central Bank of Iraq proposed setting up a sub-account of the Fund where the funds for cancelled letters of credit could be transferred and that could be used for the settlement of claims from sellers of goods and services under the programme, as well as any shipment made after 31 December 2007. The Secretariat indicated that it lacked authority to agree to such an arrangement, which would require the express approval of the Security Council.

Steps agreed upon

13. The Working Group agreed that for any shipment made after 31 December 2007, the suppliers would be informed that the commercial channels would be readily available for those companies previously involved in the programme and wishing to do business or complete their shipments with Iraq.

14. On those claims for which there are no commercial disputes, the concerned ministries will confirm delivery and issue and transmit the necessary confirmations of arrival to the Central Bank of Iraq as soon as possible following the session of the Working Group.

15. On those claims for which there are commercial disputes, the concerned ministries agreed to resolve the commercial issues with the seller and confirm delivery, and accordingly the Central Bank of Iraq would issue and transmit the necessary confirmation of arrival by 31 March 2008.

16. On those claims for which there are commercial disputes that cannot be resolved by 31 March, the funds will be retained in the United Nations Iraq Account until the issues have been resolved under the streamlined claims settlement mechanism to bring the programme to an orderly and timely close.

17. For those claims that the concerned ministries have against suppliers who have been paid in accordance with the terms and conditions of the letter of credit, the ministries agreed to pursue such issues under normal commercial practices outside the programme. The Secretariat is ready to assist in this endeavour.

18. The Working Group agreed that if the concerned ministries do not provide the necessary confirmation for the delivered goods that are related to the letters of credit for which the confirmations are in process by 31 March 2008, any residual letters of credit will be part of the unresolved issues arising from the termination of the oil-for-food programme, and that would fall under the streamlined claims settlement mechanism proposed by the Secretary-General (S/2007/725), which is currently under consideration by the Security Council.

19. If the confirmation of arrival of goods for the 114 letters of credit with an approximate value of \$385 million (see annex I) is not received by 31 March 2008, those funds will be retained in the United Nations Iraq Account until the issues have been resolved by the streamlined mechanism. Therefore, the Working Group agreed that it would be in the best interest of the concerned ministries to resolve outstanding claims before 31 March.

20. With respect to the planned cancellations (see table 3), the Working Group agreed that it would be necessary to follow up with BNP Paribas on an expedited basis for the cancellation of the letters of credit listed in annex IV by March 2008.

21. The Working Group agreed to meet in mid-March 2008 to further review the progress made.
