## Annex

### **Letter dated 9 September 2010 from the Chairman of the Unified Communist Party of Nepal (Maoist) addressed to the Secretary-General**

1. First of all, it is apparent that the UNMIN has been accomplishing its role from the beginning of the peace process to now within the mandate assigned to it. Our party, the Unified Communist Party of Nepal (Maoist), appreciates UNMIN's role and thinks that it is necessary until the successful conclusion of the peace process.
2. The letter that Madhav Kumar Nepal, the Prime Minister of the caretaker Government of Nepal, had written on 6 September 2010 to the Secretary-General of the United Nations has seriously drawn our attention. The part of the said letter: "It is for these reasons that we would like to see that the mandate of UNMIN focuses itself on the monitoring of management of the Maoist combatants and their arms until the Special Committee takes responsibility of this task. We wish, therefore, to seek the extension of the term of UNMIN to do the above-mentioned task for the next four months from 15 September 2010" means that the role of UNMIN has been limited to monitor the Maoist Army only by bringing to an end its role of monitoring both Nepali Army and Maoist Army. It is a direct violation of the Comprehensive Peace Agreement, Interim Constitution and the entire agreements reached in the past regarding the peace process. There has not been any kind of agreement of the aforesaid type with the present caretaker Prime Minister. Our party seriously disagrees with that letter.
3. In the peace process of Nepal, there is a section of elements which are always against peace, constitution and agreement. This section has been making ill-efforts to defame UNMIN and bring its role in an unnecessary debate. We strongly urge that Government should not fall under the influence of those elements.
4. Our party thinks that the previous mandate of UNMIN must be continued until the peace process reaches its conclusion. We are cautious that there should not be any dispute between Nepali Army and the Maoist Army combatant. We are ready to resolve the disputes through mutual understanding.
5. Our party demands that the tenure of UNMIN should be extended for six months from 15 September 2010.
