

Report

Under paragraph 18 of Security Council resolution 2100 (2013), France is required to report to the Security Council on the implementation of its mandate in support of MINUSMA.

Since 1 July 2013, the date of inception of MINUSMA, no combat operations "under imminent and serious threat" have been reported, nor has the Secretary-General made any requests of France in this regard.

Nevertheless, it should be noted that some fifteen joint operations have been carried out by Operation Serval with MINUSMA, reflecting the relationship of trust between the two forces. This relationship of trust also allows the two forces to provide each other with reliable and consistent support through the pooling of their chronically scarce resources.

The Liaison and Support Detachments carry out permanent and joint actions or operations with the MINUSMA battalions with which they are deployed. Since 1 July they have carried out approximately 70 joint patrols.

Moreover, the daily work of the French Liaison and Support Detachments deployed among the MINUSMA battalions should be highlighted. Each day, these units advise, coordinate and support their MINUSMA counterparts during their patrol and regional-control missions.
