**Ceasefire agreement****1. Parties**

The parties listed below have entered into a ceasefire agreement:

- Government of the Republic of Mali
- Mouvement national de libération de l'Azawad, Haut Conseil pour l'unité de l'Azawad and Mouvement arabe de l'Azawad

**2. Ceasefire**

The parties agree to the cessation of hostilities throughout the national territory upon signature of the agreement by all parties.

The parties agree to return to the Ouagadougou preliminary agreement and to resume talks immediately with the support of the United Nations and its regional and international partners.

The parties agree to the prompt release of prisoners.

The parties agree to facilitate the humanitarian operations of the United Nations and other humanitarian partners and to respect the existing principles of humanitarian law.

In accordance with the preliminary agreement, the parties agree to the establishment of an international commission of inquiry into the events that occurred, starting with those in Kidal.
