Letter dated 9 March 2022 from the Chair of the Security Council Committee pursuant to resolutions [1267 \(1999\)](#), [1989 \(2011\)](#) and [2253 \(2015\)](#) concerning Islamic State in Iraq and the Levant (Da'esh), Al-Qaida and associated individuals, groups, undertakings and entities addressed to the President of the Security Council

Recommendations of the Analytical Support and Sanctions Monitoring Team contained in its twenty-ninth report

1. On 22 December 2021, the twenty-ninth report of the Analytical Support and Sanctions Monitoring Team ([S/2022/83](#)) was submitted to the Committee pursuant to paragraph (a) of annex I to Security Council resolution [2610 \(2021\)](#). A table of recommendations based on the report was also circulated to the Committee on 28 December 2021, and the Committee deliberated on the recommendations on 2 February 2022. The Committee would like to express its gratitude to the Monitoring Team for the exemplary work undertaken in the fulfilment of its mandate.
2. Since December 2005, when it established the practice, the Committee has responded to each of the reports submitted to it by the Monitoring Team and has brought to the attention of the Security Council and the public the Committee's position on the recommendations contained in those reports.

Position of the Committee on the recommendations contained in the twenty-ninth report of the Analytical Support and Sanctions Monitoring Team

1	The Monitoring Team recommends that the Committee request the Secretariat to provide a continuously updated accounting of all changes made to the ISIL (Da'esh) and Al-Qaida sanctions list, both substantive and technical, as they occur, and have them accessible in a single location. As a further step to supporting the timely implementation of United Nations sanctions measures, consideration should be given to doing this by means of the United Nations Security Council Consolidated List.	93	The Committee agreed to request that the Secretariat and the Monitoring Team work on a solution within existing resources, with an update on progress to be provided in the Monitoring Team's thirtieth report. The Secretariat will appoint a dedicated contact point for Committee members to seek updates on changes made to the ISIL (Da'esh) and Al-Qaida sanctions list.
2	The Monitoring Team further recommends that the Committee encourage Member States to propose new listings and amendments, in order to ensure that the sanctions list accurately reflects the terrorism threat.	96	The Committee agreed that the Chair, on behalf of the Committee, would write to Member States, calling attention to paragraph 14 of resolution 2610 (2021) , encouraging Member States to submit to the Committee listing requests of individuals and entities supporting ISIL, Al-Qaida and associated individuals, groups, undertakings and entities, and also encouraging Member States to review the amount of information provided by proposing States and improve information-sharing between proposing States and members of the Committee.
Annual review			
3	The Monitoring Team recommends that the Committee encourage Member States to respond to annual review requests in a timely manner and that it request that the Secretariat work with the Monitoring Team to propose revisions to the Committee's guidelines, with the aim of simplifying and consolidating the annual review process. Such revisions could include changes to the process through which new information on listings is collected and communicated to Member States, as well as to when and how the Monitoring Team's recommendations for the annual review are proposed.	95	The Committee agreed to request that the Secretariat and the Monitoring Team propose updates to the Committee's guidelines regarding the annual review process, to be subsequently submitted to the Committee for its consideration. The Committee recalled that any updates were subject to its approval by consensus.
