SUMMARY **STATEMENT** BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN THEIR CONSIDERATION

### Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

At its 2895th meeting, held on 29 November 1989, the Security Council resumed its consideration of the item, having before it the report of the Secretary-General on the United Rations Disengagement Observer Force (UNDOF) for the period 23 May to 21 November 1989 (S/20976 and Corr.1).

The President drew attention to the draft resolution before the Council (S/20996), which had been prepared in the course of the Council's consultations.

The Security Council then voted on draft resolution S/20996 and adopted it unanimously as resolution 645 (1989).

Resolution 645 (1989) reads as follows:

# The Security Council,

<u>Havina considered</u> the report of the Secretary-General on the United Nations Disengagement Observer Force,  $\mathbf{l}'$ 

## Decides:

- (a) To call upon the parties concerned to implement immediately Security Council resolution 338 (1973) of 22 October 1973;
- (b) To renew the mandate of the United Nations Disengagement Observer Force for another period of six months, that is, until 31 May 1990:
- (c) To request the Secretary-General to submit, at the end of this period, a report on the developments in the situation and the measures taken to implement Security Council resolution 338 (1973).

Following the voting, the President of the Security Council stated that, in connection with the resolution just adopted on the renewal of the mandate of the United Nations Disengagement Observer Force, he had been authorised to make the following complementtry statement (S/20998) on behalf of the Security Council:

"As is known. the report of the Secretary-General on the United Nations Disengagement Observer Force states, in paragraph 24: 'Despite the present quiet in the Israel-Syria sector, the situation in the Middle East as a whole continues to be potentially dangerous and is likely to remain so, unless and until a comprehensive settlement covering all aspects of the Middle East problem can be reached.' That statement of the Secretary-General reflects the view of the Security Council."

In a letter dated 27 November 1989 addressed to the President of the Security Council (S/20991), the Permanent Representative of El Salvador to the United Nations requested that a meeting of the Security Council be convened, as a matter of urgency, to consider actions by the Nicaraguan Government which constituted breaches of the regional agreements concluded by the Central American Presidents, specifically the Procedures for the establishment of a firm and lasting peace in Central America (Esquipulas II agreement), the Joint Declaration of the Central American Presidents (Tesoro Beach agreement) and the recent Tela agreement.

In a letter dated 28 November 1989 addressed to the President of the Security Council (S/20999), the Permanent Representative of Nicaragua to the United Nations stated that, mindful of the request that had been made by El Salvador, he was requesting that the scope of the urgent meeting of the Security Council be expanded to include consideration of the grave repercussions which the serious deterioration of the situation in El Salvador was having on the peace process in Central America.

The Security Council met to consider the item at its 2896th meeting, held on 30 November 1989, on the basis of the above requests.

The President, with the consent of the Council, invited the representatives of El Salvador and Nicaragua, at their request, to participate in the discussion without the right to vote.
