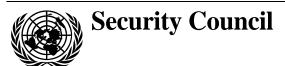

Report of the Government of the Republic of Serbia: measures taken to implement United Nations Security Council resolution 1952 (2010)

- Prevents the direct or indirect supply, sale or transfer from its territory of arms and any related materiel and the provision of any technical and financial assistance and training related to military activities to all non-governmental entities in the Democratic Republic of the Congo;
- Pursuant to paragraph 5 of Security Council resolution 1807 (2008), notifies in advance to the Committee any shipment of arms and related material for the Democratic Republic of the Congo or any provision of training assistance,

- ensuring that such notifications contain relevant information regarding the end-user, the proposed date of delivery and the itinerary of shipments;
- Prevents the entry into and transit through its territory of persons designated by the Committee pursuant to the criteria established in paragraph 13 of Security Council resolution 1807 (2008) and paragraph 4 of Security Council resolution 1857 (2008);
- Ensures that no funds, other financial assets and economic resources are made available to persons and entities designated by the Committee pursuant to the criteria established in paragraph 13 of Security Council resolution 1807 (2008) and paragraph 4 of Security Council resolution 1857 (2008), including to its own nationals and other persons who could act in its territory for the benefit of such persons;
- Takes appropriate measures aimed at raising the awareness and implementing the guidelines and recommendations of the Group of Experts on the Democratic Republic of the Congo for importers, processors and users of minerals from the Democratic Republic of the Congo, as defined in paragraphs 356 and 369 of its final report (S/2010/596).
