Please find enclosed herewith the first national report, in the form of a matrix, on the measures taken by Honduras with respect to the implementation of United Nations Security Council resolution 1540 (2004), which, among other things, decides that all States should adopt and enforce appropriate effective laws which prohibit any non-State actor to manufacture, acquire, possess, develop, transport, transfer or use nuclear, chemical or biological weapons and their means of delivery.
