1	General statement on non-possession of WMD		Côte d'Ivoire regards the proliferation of weapons of mass destruction (biological, chemical, nuclear - WMD) to be a serious threat to international peace and security. It therefore intends to take action and join with the international community in effectively countering this phenomenon.		
2	General statement on commitment to disarmament and non-proliferation		Côte d'Ivoire affirms its commitment to the multilateral treaties aimed at eliminating and preventing the proliferation of WMD. It believes that the best way of combating proliferation of such weapons is to achieve their total elimination from everywhere on the planet.		
3	General statement on non-provision of WMD and related materials to non-State actors		Côte d'Ivoire is neither a producer nor an exporter of WMD. Accordingly, it undertakes not to take any action which might be interpreted as in any way supporting or assisting non-State actors.

The matrices are not a tool for measuring compliance of States in their non-proliferation obligations but for facilitating the implementation of Security Council Resolutions 1540 and 1673. They do not reflect or prejudice any ongoing discussions outside of the Committee, in the Security Council or any of its organs, of a State's compliance with its non-proliferation or any other obligations
