مذكرة شفوية مؤرخة ١٤ كانون الأول/ديسمبر ٢٠١٦ وموجهة إلى رئيس اللجنة من البعثة الدائمة لسلوفاكيا لدى الأمم المتحدة

هَدي البعثة الدائمة لسلوفاكيا لدى الأمم المتحدة تحياها إلى رئيس لجنة مجلس الأمن المنشأة عملاً بالقرار ١٥٤٠ (٢٠٠٤) وتتشرف بأن تحيل طيه التقرير الوطني المستكمل المقدم من سلوفاكيا لعام ٢٠١٦ عملا بالفقرة ٤ من القرار ١٥٤٠ (٢٠٠٤) (انظر المرفق الأول). وستنشر المصفوفة التفصيلية المستكملة على الموقع الشبكي للجنة * (انظر المرفق الثاني).

التقرير المستكمل لسلوفاكيا لعام ١٦٠٦ عن تنفيذ قرار مجلس الأمن ١٥٤٠ (٢٠٠٤)

يعد قرار مجلس الأمن ١٥٤٠ (٢٠٠٤) أداة هامة في التعامل مع التحدي المتمثل في انتشار أسلحة الدمار الشامل ومنع هذا الانتشار إلى الجهات الفاعلة من غير الدول. وقد رحبت سلوفاكيا باتخاذ القرار بالإجماع وأعربت عن دعمها القاطع لسياستها الطويلة الأمد لمكافحة انتشار أسلحة الدمار الشامل ووسائل إيصالها. ومن الناحية العملية، فقد ترجمت هذه السياسة إلى تشريعات وطنية وتنفيذية وتدابير للإنفاذ.

وهذا التقرير هو نسخة محدثة من التقرير الوطني المقدم من سلوفاكيا في عام ٢٠٠٤ عملا بالفقرة ٤ من القرار ١٥٤٠ (٢٠٠٤). وهو يعكس الحالة الراهنة للتدابير التشريعية والتنفيذية وتدابير الإنفاذ وغيرها من التدابير المتعلقة بأحكام محددة أوردها القرار بعبارات عامة. وتشكل المصفوفة المستكملة جزءا لا يتجزأ من التقرير، وهي تحدد بمزيد من التفصيل كيفية تنفيذ القرار.

وتلتزم سلوفاكيا التزاما راسخا بتنفيذ القرار ١٥٤٠ (٢٠٠٤)، وهي على استعداد للتعاون الكامل مع اللجنة.

الالتزام بالصكوك الدولية

على اعتبار أن سلوفاكيا هي الدولة الخلف للجمهورية الاتحادية التشيكية والسلوفاكية، فقد أصبحت، منذ إنشائها في أول كانون الثاني/يناير ١٩٩٣، طرفا في الصكوك الدولية التالية المتصلة بحظر استخدام أو عدم انتشار أسلحة الدمار الشامل:

- (أ) معاهدة عدم انتشار الأسلحة النووية؟
- (ب) اتفاقية الحماية المادية للمواد النووية (فيينا، ١٩٧٩) والتعديل المدخل عليها (فيينا، ٢٠٠٥)؛
 - (ج) معاهدة أنتار كتيكا؛
- (د) معاهدة المبادئ المنظمة لأنشطة الدول في ميدان استكشاف واستخدام الفضاء الخارجي، بما في ذلك القمر والأجرام السماوية الأحرى؛

- (هـ) معاهدة حظر وضع الأسلحة النووية وغيرها من أسلحة التدمير الشامل على قاع البحار والمحيطات وفي باطن أرضها؟
- (و) معاهدة حظر تجارب الأسلحة النووية في الجو وفي الفضاء الخارجي وتحت سطح الماء؛
 - (ز) معاهدة الحظر الشامل للتجارب النووية؛
- (ح) اتفاقية حظر استحداث وإنتاج وتكديس واستخدام الأسلحة الكيميائية وتدمير تلك الأسلحة (اتفاقية الأسلحة الكيميائية)؛
- (ط) اتفاقية حظر استحداث وإنتاج وتخزين الأسلحة البكتريولوجية (البيولوجية) والتكسينية، وتدمير تلك الأسلحة;
- (ي) بروتوكول حظر الاستعمال الحربي للغازات الخانقة أو السامة أو ما شابهها ولوسائل الحرب البكتريولوجية.

وقد وقع الاتفاق المبرم بين تشيكوسلوفاكيا والوكالة الدولية للطاقة الذرية بغرض تطبيق الضمانات في إطار معاهدة عدم انتشار الأسلحة النووية الموقع في عام ١٩٧٢ بغرض منع تحويل الطاقة النووية من الاستخدام السلمي للاستخدام في الأسلحة النووية أو المرافق المتفجرة النووية الأخرى (انظر INFCIRC/173). وفي عام ٢٠٠٥ كان لانضمام سلوفاكيا للاتفاق المبرم بين ألمانيا، وأيرلند وإيطاليا وبلجيكا والدانمرك ولكسمبرغ وهولندا والجماعة الأوروبية للطاقة الذرية والوكالة الدولية للطاقة الذرية وبعد انضمام سلوفاكيا إلى الاتفاق المبرم بين بلجيكا والدانمرك وألمانيا وأيرلندا وإيطاليا ولكسمبرغ وهولندا والجماعة الأوروبية للطاقة الذرية والوكالة الدولية للطاقة الذرية في تنفيذ المادة الثالثة (١) و (٤) من المعاهدة (والبروتوكول الملحق هما) (انظر INFCIRC/193)، دخل اتفاق ضمانات الوكالة الدولية للطاقة الذرية والبروتوكول الإضافي الملحق به حيز النفاذ بالنسبة لسلوفاكيا.

وسلوفاكيا أيضا عضو في جميع أنظمة مراقبة الصادرات تقريبا - مجموعة أستراليا، وترتيب فاسنار بشأن ضوابط تصدير الأسلحة التقليدية والبضائع والتكنولوجيات ذات الاستخدام المزدوج، ومجموعة الموردين النوويين ولجنة زانغر - وهي تسعى بنشاط لأن تكون عضوا في نظام مراقبة تكنولوجيا القذائف، الذي تطبق سلوفاكيا المبادئ التوجيهية الخاصة به كجزء من ضوابط التصدير الوطنية الخاصة بها. وبالإضافة إلى ذلك، انضمت سلوفاكيا إلى مدونة لاهاي لقواعد السلوك لمنع انتشار القذائف التسيارية. وتسهم هذه الهياكل الدولية إسهاما مهما في ميدان مراقبة الصادرات من المواد والتكنولوجيات التي يمكن

استخدامها في أسلحة الدمار الشامل ووسائل إيصالها بمدف تعزيز نظام عدم الانتشار ومنع الإرهابيين من الحصول على هذه المواد الحساسة.

وانضمت سلوفاكيا أيضا إلى مجموعة أوسع نطاقا من الدول الشريكة التي تدعم المبادرة الأمنية لمكافحة الانتشار ومبادئها. وتحدف هذه المبادرة إلى وقف الاتجار بأسلحة الدمار الشامل ومنظومات إيصالها والمواد المتصلة بها مع الدول والجهات الفاعلة من غير المدول التي تثير شواغل تتعلق بالانتشار. وسلوفاكيا عضو في المبادرة العالمية لمكافحة الإرهاب النووي، التي أنشئت في عام ٢٠٠٦، بهدف تعزيز القدرة على منع الإرهاب النووي وكشفه والتصدي له. وهي ملتزمة بتنفيذ إعلان المبادئ في إطار المبادرة العالمية، التي تتمشى مع أحكام القرار ١٥٤٠ (٢٠٠٤).

التدابير التشريعية

استحدثت سلوفاكيا في تشريعاها الوطنية طائفة واسعة من التدابير الرامية إلى منع انتشار أسلحة الدمار الشامل، يما في ذلك انتشارها من قبل الجهات الفاعلة من غير الدول.

والوثائق التشريعية الوطنية الرئيسية ذات الصلة بالقرار ١٥٤٠ (٢٠٠٤) هي كالتالي: القانون رقم ٢٠٠٤/٥٤١ بشأن الاستخدام السلمي للطاقة النووية (قانون الطاقة الذرية)، والقانون رقم ١٩٩٨/١٢٩ بشأن حظر الأسلحة الكيميائية (قانون حظر الأسلحة الكيميائية)، والقانون رقم ٢٠١٧/٢١٨ بشأن حظر الأسلحة البيولوجية، بصيغته المعدلة (قانون حظر الأسلحة البيولوجية). ويكمل هذه التشريعات القانون رقم ١١١/٣٩ بشأن الماجد الستخدام المزدوج، والقانون رقم ٢٠١١/٣٩ بشأن الاتجار بمنتجات الصناعات الدفاعية. وتفرض القوانين المذكورة أعلاه، وقوانين أحرى، علاوة على القانون الجنائي (القانون رقم ٢٠١٥/٥٠)، عقوبات في حالة انتهاك أحكامها.

ولقد أدت أحدث التطورات في مجال علم الأحياء إلى اعتماد القانون رقم المزايا ٢٠١٥/٢٦٣ الذي يتعلق بأحكام وشروط التعامل مع المواد الجينية والاستفادة من المزايا الناجمة عن استخدامها.

التدابير التنفيذية

على المستوى التنفيذي، تقوم على تنفيذ الالتزامات والتدابير المتعلقة بعدم الانتشار مؤسسات شتى، يما في ذلك وزارة الاقتصاد، ووزارة الصحة، ووزارة البيئة، والهيئة التنظيمية النووية.

ووزارة الخارجية والشؤون الأوروبية هي جهة الاتصال فيما يتعلق بالتنفيذ وتقديم المساعدة بشأن تنفيذ القرار ١٥٤٠ (٢٠٠٤) وتقوم بدور المنسق من أجل إعداد التقرير الوطنى الذي يقدم إلى اللجنة.

وتقوم وزارة الاقتصاد بدور الهيئة الوطنية لاتفاقية الأسلحة الكيميائية، وهي مسؤولة عن تنسيق المهام المتصلة بضوابط تصدير المنتجات الصناعية الدفاعية والمواد ذات الاستخدام المزدوج. وفيما يتعلق بنظام الرقابة على الصادرات، فإن وزارة الخارجية والشؤون الأوروبية وهيئة المعلومات السلوفاكية تحظيان بتأثير حاسم (حيث تتمتعان بسلطة النقض) كما أن مواقفهما ملزمة فيما يتعلق بالقرارات بشأن تراخيص التصدير.

وتقوم وزارة الصحة، بالاشتراك مع هيئتها الفرعية المنفذة، وهي الهيئة الإقليمية للصحة العامة في بانسكا بيستريكا، بدور السلطة الوطنية لاتفاقية حظر استحداث وإنتاج وتكديس الأسلحة البكتريولوجية (البيولوجية) والتكسينية وتدمير تلك الأسلحة.

وعملا بالقانون رقم ٢٠١٥/٢٦٣، فإن وزارة البيئة هي الهيئة التنظيمية الوطنية المتعلقة باستخدام الموارد الجينية.

وتمارس الهيئة التنظيمية النووية الإشراف الحكومي على الأمان النووي للمنشآت النووية، بما في ذلك إدارة النفايات المشعة، وإدارة الوقود المستنفد والمراحل الأخرى من دورة الوقود، فيما يتعلق بالمواد النووية، بما في ذلك التفتيش والتسجيل، وبالحماية المادية للمنشآت النووية والمواد النووية. وهي الهيئة الرئيسية المسؤولة عن ضمان تنفيذ الالتزامات في مجال السلامة النووية والأمن الناجمة عن التزامات و تعهدات دولية.

وفي إطار ممارسة وزارة البيئة لمسؤولياتها بوصفها الهيئة التنظيمية المتعلقة باستخدام الموارد الجينية، فإنها تتعاون مع وزارة الاقتصاد ووكالات أحرى، ومع المعهد المركزي للمراقبة والاختبار في مجال الزراعة (التابع لوزارة الزراعة والتنمية الريفية)، والمعهد الحكومي لمراقبة المواد الحيوية والأدوية البيطرية، وهيئة الصحة العامة للجمهورية السلوفاكية (وزارة الصحة).

تدابير الإنفاذ

تقع تدابير الإنفاذ في المقام الأول ضمن احتصاص وزارة الاقتصاد، والهيئة التنظيمية النووية، ووزارة الداخلية، ووزارة المالية، ووكالات إنفاذ القانون الأخرى.

وتقوم وزارة الاقتصاد بوضع الضوابط المتعلقة بالتجارة في السلع الحساسة. وتقوم الهيئة التنظيمية النووية بالإشراف على أي نقل للأسلحة النووية والمواد ذات الصلة. وفي إطار وزارة الداخلية، يتولى مكتب الشرطة الجنائية التابع لرئاسة الشرطة مسؤولية التحقيق في الأنشطة الإجرامية المتصلة بالمواد الخطرة. وفي إطار وزارة المالية، يتولى مكتب التحقيقات الجنائية مسؤولية الإنفاذ العملي للمبادئ المتعلقة بتصدير أو نقل السلع الخاضعة للمراقبة. وتحت تصرف الإدارات المذكورة أعلاه المعلومات ذات الصلة التي توفرها هيئة المعلومات السلوفاكية.

تدابير لدعم التشجيع على الامتثال

تشكل أنشطة تشجيع الامتثال جزءا كبيرا من أنشطة التوعية الحكومية الموجهة إلى الصناعة. ويجري تدريجيا توسيع نطاق محط التركيز الرئيسي للأنشطة بحيث يتعدى الأشكال الأساسية للتفاعل بين الوزارات والوكالات ذات الصلة، والمسؤولة قانونا عن سياسة عدم الانتشار، وضوابط التصدير، والصناعة، إلى التدابير التي تتوخى الأحذ بنهج أكثر اتساما بالطابع العملي.

وضمن الأنشطة الحكومية الرامية إلى تشجيع الامتثال تلك الأنشطة المتعلقة بالتعاون مع غرفة التجارة والصناعة في سلوفاكيا (من قبيل تنظيم حلقة دراسية بشأن سياسة وإحراءات الترخيص للمصدرين نظمتها وزارة الشؤون الخارجية والأوروبية بالتعاون مع وزارة الاقتصاد في عام ٢٠١٥) وإحراء مشاورات مخصصة مع المصدرين في مسائل خاصة بالتصدير.

الأنشطة المضطلع بما في إطار الاتحاد الأوروبي

منذ انضمام سلوفاكيا إلى الاتحاد الأوروبي، عملت على الإسهام بنشاط في أنشطة مكافحة انتشار أسلحة الدمار الشامل ووسائل إيصالها وعلى تنفيذ استراتيجية الاتحاد الأوروبي لمكافحة انتشار أسلحة الدمار الشامل.

وأيدت سلوفاكيا على نحو منتظم وثائق الاتحاد الأوروبي المتعلقة بتنفيذ الاستراتيجية في مختلف المختلفة (النووية والكيميائية والبيولوجية)، يما في ذلك مقررات مجلس الاتحاد الأوروبي دعما للقرار ١٥٤٠ (٢٠٠٤).

تقديم المساعدة إلى الدول الأعضاء

اعتمدت سلوفاكيا، في حدود قدراتها، موقفا فاعلا بشأن مسألة المساعدة الدولية في محال عدم الانتشار. وتم الاضطلاع بالجزء الأكبر من أنشطة المساعدة وتوفير معظم مواردها عن طريق المؤسسات الدولية ذات الصلة، يما في ذلك الاتحاد الأوروبي والوكالة الدولية للطاقة الذرية (من خلال الهيئة التنظيمية النووية) ومنظمة حظر الأسلحة الكيميائية (وزارة الاقتصاد/الهيئة الوطنية لاتفاقية الأسلحة الكيميائية).

وتقر سلوفاكيا بما ارتآه مجلس الأمن من أن بعض الدول قد تحتاج إلى المساعدة في تنفيذ أحكام القرار ١٥٤٠ (٢٠٠٤)، وهي على استعداد للنظر في أي طلب محدد للحصول على هذه المساعدة.

The information in the matrices originates primarily from national reports and is complemented by official government information, including that made available to intergovernmental organizations. The matrices are prepared under the direction of the 1540 Committee.

The 1540 Committee intends to use the matrices as a reference tool for facilitating technical assistance and to enable the Committee to continue to enhance its dialogue with States on their implementation of Security Council resolution 1540.

The matrices are not a tool for measuring compliance of States in their non-proliferation obligations but for facilitating the implementation of Security Council resolutions 1540 (2004), 1673 (2006), 1810 (2008) and 1977 (2011). They do not reflect or prejudice any ongoing discussions outside of the Committee, in the Security Council or any of its organs, of a State's compliance with its non-proliferation or any other obligations. Information on voluntary commitments is for reporting purpose only and does not constitute in any way a legal obligation arising from resolution 1540 or its successive resolutions.
