Постоянное представительство Словакии при Организации Объединенных Наций свидетельствует свое уважение Председателю Комитета Совета Безопасности, учрежденного резолюцией 1540 (2004), и имеет честь настоящим препроводить обновленный национальный доклад Словакии за 2016 год, представляемый во исполнение пункта 4 резолюции 1540 (2004) (см. приложение I) и подробную обновленную таблицу для размещения на веб-сайте Комитета (см. приложение II).

Обновленный доклад Словакии об осуществлении резолюции 1540 (2004) за 2016 год

Резолюция Совета Безопасности 1540 (2004 год) является важным инструментом для борьбы с распространением оружия массового уничтожения и предотвращения его распространения среди негосударственных субъектов. Словакия приветствует единогласное принятие резолюции и безоговорочно ее поддерживает, поскольку ее положения соответствуют политике борьбы с распространением оружия массового уничтожения и средств его доставки, которой уже давно придерживается страна. В практическом плане эта политика постоянно находит себе выражение в национальном законодательстве, а также на уровне исполнительных и правоприменительных мер.

Настоящий доклад представляет собой обновленный вариант национального доклада Словакии, который был представлен в 2004 году в соответствии с пунктом 4 резолюции 1540 (2004). В нем представлена общая информация о нынешнем положении дел в том, что касается законодательных, исполнительных, правоприменительных и других мер, связанных с конкретными положениями резолюции. Неотъемлемой частью доклада является обновленная таблица, в которой говорится об осуществлении этой резолюции более подробно.

Словакия твердо привержена осуществлению резолюции 1540 (2004) и готова в полной мере сотрудничать с Комитетом.

Приверженность осуществлению международных документов

Как государство-правопреемник Чехословацкой Федеративной Республики Словакия со времени своего создания 1 января 1993 года была или стала стороной следующих международных документов, касающихся запрета на применение или нераспространение оружия массового уничтожения:

- а) Договора о нераспространении ядерного оружия;
- b) Конвенции о физической защите ядерного материала и Поправки 2005 года к ней;
 - с) Договора об Антарктике;
- d) Договора о принципах деятельности государств по исследованию и использованию космического пространства, включая Луну и другие небесные тела;
- е) Договора о запрещении размещения на дне морей и океанов и в его недрах ядерного оружия и других видов оружия массового уничтожения;
- f) Договора о запрещении испытаний ядерного оружия в атмосфере, в космическом пространстве и под водой;

- договора о всеобъемлющем запрещении ядерных испытаний;
- h) Конвенции о запрещении разработки, производства, накопления и применения химического оружия и о его уничтожении (Конвенции по химическому оружию);
- i) Конвенции о запрещении разработки, производства и накопления запасов бактериологического (биологического) и токсинного оружия и об их уничтожении;
- j) Протокола о запрещении применения на войне удушливых, ядовитых или других подобных газов и бактериологических средств.

Соглашение между Чехословакией и Международным агентством по атомной энергии (МАГАТЭ) о применении гарантий в связи с Договором о нераспространении ядерного оружия было подписано в 1972 году в целях предотвращения отклонения от мирного использования ядерной энергии и перехода к ее использованию в ядерном оружии или в других ядерных взрывных установках (см. INFCIRC/173). В 2005 году после присоединения Словакии к Соглашению между Бельгией, Данией, Германией, Ирландией, Италией, Люксембургом, Нидерландами, Европейским сообществом по атомной энергии и МАГАТЭ об осуществлении статьи III (1) и (4) Договора (и Протокола к нему) (см. INFCIRC/193), Соглашение о гарантиях МАГАТЭ и Дополнительный протокол к нему вступили в силу для Словакии.

Кроме того, Словакия участвует практически во всех режимах экспортного контроля — Австралийской группе, Вассенаарских договоренностях по экспортному контролю за обычными вооружениями, товарами и технологиями двойного назначения, Группе ядерных поставщиков и Комитете Цангера — и активно стремится стать участником Режима контроля за ракетными технологиями, руководящие принципы которого Словакия применяет в рамках своих национальных механизмов экспортного контроля. Помимо этого, Словакия подписала Гаагский кодекс поведения по предотвращению распространения баллистических ракет. Эти международные структуры и документы вносят важный вклад в дело контроля за экспортом материалов и технологий, пригодных для использования в оружии массового уничтожения и средств его доста вки, в целях укрепления режима нераспространения и предотвращения приобретения террористами таких чувствительных материалов.

Словакия также присоединилась к более широкой группе государствпартнеров, которые поддерживают Инициативу по безопасности в борьбе с
распространением и ее принципы. Эта инициатива направлена на то, чтобы
остановить незаконный оборот оружия массового уничтожения, систем его доставки и связанных с ним материалов с передачей их тем государствам и теми
государствами, а также тем негосударственным субъектам и теми негосударственными субъектами, которые вызывают обеспокоенность в плане распространения. Кроме того, Словакия является участником Глобальной инициативы
по борьбе с актами ядерного терроризма, нацеленной на укрепление глобального потенциала в области предотвращения и выявления актов ядерного терроризма и принятия ответных мер в связи с ними. Словакия привержена осуществлению заявления о принципах, сделанного в рамках Глобальной инициативы, что соответствует резолюции 1540 (2004).

Законодательные меры

Словакия включила в национальное законодательство целый ряд мер, направленных на предотвращение распространения оружия массового уничтожения, включая его распространение со стороны негосударственных субъектов.

Основными национальными законодательными актами, имеющими отношение к резолюции 1540 (2004), являются следующие: Закон № 541/2004 об использовании ядерной энергии в мирных целях (Закон об атомной энергии), Закон № 129/1998 о запрещении химического оружия (Закон о запрещении химического оружия) и Закон № 218/2007 о запрещении биологического оружия с внесенными в него поправками (Закон о запрещении биологического оружия). Эти законы дополняют Закон № 39/2011 о товарах двойного назначения и Закон № 392/2011 о торговле продукцией оборонной промышленности. В упомянутых выше законах, как и в других законах, а также в Уголовном кодексе (Закон № 300/2005) предусматривается наказание за нарушения их положений.

Самые последние события в области биологии привели к принятию Закона № 263/2015, которым регулируются условия предоставления доступа к генетическим ресурсам и получение выгод от их использования.

Исполнительные меры

На уровне исполнительной власти выполнение обязательств и мер по нераспространению координируют различные учреждения, включая Министерство экономики, Министерство здравоохранения, Министерство охраны окружающей среды и Управление по ядерному регулированию.

Министерство иностранных дел и европейских дел является контактным центром по вопросам осуществления и помощи в связи с резолюцией 1540 (2004) и координирует подготовку национального доклада Комитету.

Министерство экономики выполняет функции национального органа по смыслу Конвенции по химическому оружию и отвечает за координацию решения задач, касающихся контроля за экспортом оборонной промышленности товаров и товаров двойного назначения. Что касается режима экспортного контроля, то Министерство иностранных и европейских дел и Словацкая информационная служба обладают решающим влиянием (правом вето), и их позиция имеет определяющее значение при принятии решений о выдаче разрешений на экспорт.

Министерство здравоохранения вместе с его ответственным за осуществление подразделением, Региональным управлением здравоохранения в Банска-Быстрице, является национальным органом по смыслу Конвенции о запрещении разработки, производства и накопления запасов бактериологического (биологического) и токсинного оружия и об их уничтожении.

В соответствии с Законом № 263/2015 Министерство окружающей среды является национальным регулирующим органом по вопросам использования генетических ресурсов.

Управление по ядерному регулированию осуществляет государственный надзор в области ядерной безопасности ядерных установок, включая надзор за удалением радиоактивных отходов, утилизацией отработанного ядерного топлива и другими этапами топливного цикла, в области ядерных материалов, включая их инспекцию и регистрацию, а также в области физической защиты ядерных установок и ядерных материалов. Оно также является главным органом, ответственным за обеспечение выполнения обязанностей и обязательств в области ядерной и радиационной защиты и безопасности, вытекающих из международных договоров, соглашений и документов.

В порядке выполнения обязанностей национального регулирующего органа по вопросам использования генетических ресурсов Министерство окружающей среды сотрудничает с Министерством экономики и другими учреждениями, Центральным институтом контроля и испытаний в сельском хозяйстве (Министерство сельского хозяйства и развития сельских районов), Государственным институтом контроля над наркотиками (Министерство здравоохранения), Институтом государственного контроля ветеринарных и лекарственных препаратов, а также Управлением здравоохранения Словацкой Республики (Министерство здравоохранения).

Правоприменительные меры

Правоприменительные меры относятся главным образом к компетенции Министерства экономики, Управления по ядерному регулированию, Министерства внутренних дел, Министерства финансов и иных правоохранительных органов.

Министерство экономики осуществляет контроль над торговлей, затрагивающей чувствительные товары. Управление по ядерному регулированию осуществляет надзор за любым перемещением ядерных материалов и связанных с ними материалов. Бюро уголовной полиции Президиума полиции, входящее в состав Министерства внутренних дел, отвечает за расследование преступлений, связанных с опасными веществами. Следственное управление, входящее в состав Министерства финансов, отвечает за практическое исполнение принципов, касающихся экспорта или транзитной перевозки подлежащих контролю товаров. В распоряжении вышеупомянутых подразделений находится соответствующая информация, представленная Словацкой информационной службой.

Меры, направленные на поощрение соблюдения

Поощрение соблюдения представляет собой значительную часть выполняемой правительством информационно-разъяснительной работы с соответствующими отраслевыми предприятиями. Основная направленность осуществляемой деятельности постепенно выходит за рамки базовых форм взаимодействия между соответствующими министерствами и ведомствами, ответственными по закону за политику нераспространения и экспортный контроль, с одной стороны, и отраслевыми предприятиями, с другой, и приобретает более практический характер.

К правительственным мероприятиям, направленным на поощрение соблюдения, относятся мероприятия, проводимые на основе сотрудничества со Словацкой торгово-промышленной палатой (например, семинар по правилам и процедурам выдачи лицензий для экспортеров, организованный Министерством иностранных дел и европейских дел на основе сотрудничества с Министерством экономики в 2015 году) и специальные консультации с экспортерами по конкретным вопросам экспорта.

Деятельность в рамках Европейского союза

Со времени вступления в Европейский союз Словакия активно участвует в борьбе с распространением оружия массового уничтожения и средств его доставки, а также осуществлению стратегии Европейского союза по борьбе с распространением оружия массового уничтожения.

Словакия регулярно поддерживает принятие документов Европейского союза, касающихся осуществления этой стратегии в различных областях (ядерной, химической и биологической), включая решения Совета Европейского союза в поддержку резолюции 1540 (2004).

Оказание помощи другим государствам

В рамках своих возможностей Словакия занимает активную позицию в отношении оказания международной помощи в области нераспространения. Основной объем деятельности и ресурсов в целях оказания помощи приходится главным образом на соответствующие международные учреждения, включая Европейский союз, МАГАТЭ (через посредство Управления по ядерному регулированию) и Организацию по запрещению химического оружия (Министерство экономики/национальное управление по осуществлению Конвенции по химическому оружию).

Словакия разделяет точку зрения Совета Безопасности, что некоторым государствам может потребоваться содействие в осуществлении положений резолюции 1540 (2004), и готова рассмотреть любые конкретные просьбы об оказании помощи.

Matrix of Slovakia, as updated in December 2016

The information in the matrices originates primarily from national reports and is complemented by official government information, including that made available to intergovernmental organizations. The matrices are prepared under the direction of the 1540 Committee.

The 1540 Committee intends to use the matrices as a reference tool for facilitating technical assistance and to enable the Committee to continue to enhance its dialogue with States on their implementation of Security Council resolution 1540.

The matrices are not a tool for measuring compliance of States in their non-proliferation obligations but for facilitating the implementation of Security Council resolutions 1540 (2004), 1673 (2006), 1810 (2008) and 1977 (2011). They do not reflect or prejudice any ongoing discussions outside of the Committee, in the Security Council or any of its organs, of a State's compliance with its non-proliferation or any other obligations. Information on voluntary commitments is for reporting purpose only and does not constitute in any way a legal obligation arising from resolution 1540 or its successive resolutions.
