Report of Bahrain on the implementation of Security Council resolution 2509 (2020) and previous relevant resolutions, specifically resolutions 2441 (2018) and 1970 (2011)

Pursuant to the provisions of Security Council resolution 2509 (2020) and previous related resolutions, the Government of Bahrain has taken several measures to implement effectively those resolutions.

With regard to the travel ban and asset freeze:

- As soon as those resolutions were adopted, they were circulated to the competent Bahraini authorities and institutions, including banks and licensed financial institutions, which implement and follow up on the resolutions and inform the Ministry of Foreign Affairs of the latest developments in that regard.
- Data on individuals has been added to the passenger information system, which is linked to the electronic passport management system of the Ministry of the Interior.
- The import and export activities of the entities that are on the sanctions list have been halted. The Customs Risk Management Department has added the names of those entities to its list of targets in the electronic customs clearance system (Ufuq).
- We have been working closely and on an ongoing basis with the relevant United Nations committee in relation to the assets of one of the entities that is on the sanctions list.

Following are some of the other measures that have taken:

- The officials responsible for following up on implementation of Security Council resolutions took part in a series of training sessions on the implementation of Security Council resolutions. In addition, awareness-raising workshops have been held for non-profit organizations, with a view to protecting them from being exploited by terrorists. Workshops have also been held for lawyers, the offices of foreign law firms, notaries, registered notaries and specialized notaries.

We will convey any new information to the Committee as soon as we receive it.
