## NOTE

Documents of the Security Council (symbol S/ . . .) are normally published in quarterly *Supplements* of the *Official Records of the Security Council*. The date of the document indicates the supplement in which it appears or in which information about it is given.

The resolutions of the Security Council, numbered in accordance with a system adopted in 1964, are published in yearly volumes of *Resolutions and Decisions of the Security Council*. The new system, which has been applied retroactively to resolutions adopted before 1 January 1965, became fully operative on that date.

Held in New York, on Friday, 19 November 1976, at 3 p.m.

Application of the People's Republic of Angola for admission to membership in the United Nations (S/12064);

Letter dated 15 November 1976 from the Representatives of Benin, the Libyan Arab Republic and the United Republic of Tanzania to the President of the Security Council (S/12230)

1. The PRESIDENT (*interpretation from Spanish*): This meeting of the Council has been convened in response to a request from the representatives of Benin, the Libyan Arab Republic and the United Republic of Tanzania in a letter dated 15 November [S/12230] to convene the Council urgently for consideration of the application of the People's Republic of Angola for membership in the United Nations. That application was presented on 22 April by the President of the People's Republic of Angola [S/12064]. The Council considered that application at its 1931st and 1932nd meetings, held on 22 and 23 June.

2. In accordance with rule 59 of the provisional rules of procedure and unless the Council should decide otherwise, I propose to refer the application of the People's Republic of Angola to the Committee on the Admission of New Members for its examination and report.

*It was so decided.*
