ADOPTION OF THE AGENDA

The agenda was adopted.

THE SITUATION IN THE MIDDLE EAST

REPORT OF THE SECRETARY-GENERAL ON THE UNITED NATIONS INTERIM FORCE IN LEBANON (S/20416 and Add.1 and Corr.1 and Add.2)

The PRESIDENT: The Security Council will now begin its consideration of the item on its agenda. Members of the Council have before them the report of the Secretary-General on the United Nations Interim Force in Lebanon (UNIFIL) for the period 26 July 1988 to 24 January 1989, which is contained in document S/20416 and Add.1 and Corr.1 and Add.2. Members of the Council have received photocopies of document S/20416/Add.1/Corr.1, which corrects the date in the heading of the legend of the map, so that it now reads "UNIFIL deployment as of January 1989".

In this report it is mentioned that during the current mandate period three members of the Force lost their lives. Furthermore, 17 soldiers suffered injuries. I am sure that I speak for all members of the Council in extending sincere condolences to the Governments and families of the deceased, who gave their lives in the cause of peace.

Members of the Council also have the following documents before them: S/20410, letter dated 19 January 1989 from the Permanent Representative of Lebanon to the United Nations addressed to the Secretary-General; and S/20429, which contains the text of a draft resolution prepared in the course of the Council's consultations.

It is my understanding that the Council is ready to proceed to the vote on the draft resolution before it. Unless I hear any objection, I shall put the draft resolution to the vote now.

There being no objection, it is so decided.

A vote was taken by show of hands.

In favour: Algeria, Brazil, Canada, China, Colombia, Ethiopia, Finland, France, Malaysia, Nepal, Senegal, Union of Soviet Socialist Republics, United Kingdom of Great Britain and Northern Ireland, United States of America, Yugoslavia

The PRESIDENT: There were 15 votes in favour. The draft resolution has been adopted unanimously as resolution 630 (1989).

The Security Council has thus concluded the present stage of its consideration of the item on the agenda.

The meeting rose at 3.40 p.m.
