The meeting was called to order at 6.10 p.m.

ADOPTION OF THE AGENDA

The agenda was adopted.

THE SITUATION IN CAMBODIA

The PRESIDENT (interpretation from Russian): The Security Council will now begin its consideration of the item on its agenda.

The Security Council is meeting in accordance with the understanding reached in its prior consultations.

Members of the Council have before them document S/21800, which contains the text of a draft resolution which has been prepared in the course of the Council's consultations.

I should like to draw the attention of members of the Council to the following documents: S/21689, a letter dated 30 August 1990 from the Permanent Representatives of China, France, the Union of Soviet Socialist Republics, the United Kingdom of Great Britain and Northern Ireland and the United States of America, addressed to the Secretary-General; and S/21732, a letter dated 11 September 1990 from the Permanent Representatives of France and Indonesia to the United Nations, addressed to the Secretary-General.

During the consultations the members of the Council agreed not to hold a debate on this question and not to make statements before or after the vote.

It is my understanding that the Council is now ready to proceed to the vote on the draft resolution before it. Unless I hear any objection, I shall put the draft resolution to the vote now.

There being no objection, it is so decided.

A vote was taken by show of hands.

The PRESIDENT (interpretation from Russian): There were 15 votes in
favour. The draft resolution has been adopted unanimously as resolution 668 (1990).

The Council has concluded the present stage of its consideration of the item
on its agenda.

The meeting rose at 6.15 p.m.
