### **Adoption of the agenda**

*The agenda was adopted.*

### **The situation in Timor-Leste**

**The President** (*spoke in Chinese*): I should like to inform the Council that I have received a letter from the representative of Timor-Leste, in which he requests to be invited to participate in the discussion of the item on the Council's agenda. In conformity with the usual practice, I propose, with the consent of the Council, to invite that representative to participate in the discussion, without the right to vote, in accordance with the relevant provisions of the Charter and rule 37 of the Council's provisional rules of procedure.

There being no objection, it is so decided.

*At the invitation of the President, Mr. Guterres (Timor-Leste) took a seat at the Council table.*

**The President** (*spoke in Chinese*): The Security Council will now begin its consideration of the item on its agenda. The Security Council is meeting in accordance with the understanding reached in its prior consultations.

Members of the Council have before them document S/2005/99, which contains the progress report of the Secretary-General on the United Nations Mission of Support in East Timor. Members of the

Council also have before them document S/2005/267, which contains the text of a draft resolution prepared in the course of the Council's prior consultations.

I should like to draw attention to document S/2005/103, which contains the text of a letter dated 23 February 2005 from the Permanent Representative of Timor-Leste to the United Nations addressed to the Secretary-General.

It is my understanding that the Council is ready to proceed to the vote on the draft resolution before it. Unless I hear any objection, I shall now put the draft resolution to the vote.

There being no objection, it is so decided.

*A vote was taken by show of hands.*

*In favour:*

Algeria, Argentina, Benin, Brazil, China, Denmark, France, Greece, Japan, Philippines, Romania, Russian Federation, United Kingdom of Great Britain and Northern Ireland, United Republic of Tanzania, United States of America

**The President** (*spoke in Chinese*): There were 15 votes in favour. The draft resolution has been adopted unanimously as resolution 1599 (2005).

The Security Council has thus concluded the present stage of its consideration of the item on its agenda.
