The meeting was called to order at 10.10 a.m.

Adoption of the agenda

The agenda was adopted.

International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January and 31 December 1994

Identical letters dated 13 June 2008 from the Secretary-General to the President of the General Assembly and the President of the Security Council (S/2008/436)

The President: I should like to inform the Council that I have received a letter from the representative of Rwanda in which he requests to be invited to participate in the consideration of the item on the Council's agenda. In conformity with the usual practice, I propose, with the consent of the Council, to invite that representative to participate in the consideration of the item, without the right to vote, in accordance with the relevant provisions of the Charter and rule 37 of the Council's provisional rules of procedure.

There being no objection, it is so decided.

At the invitation of the President, Mr. Nsengimana (Rwanda) took a seat at the Council table.

The President: The Security Council will now begin its consideration of the item on its agenda. The

Security Council is meeting in accordance with the understanding reached in its prior consultations.

Members of the Council have before them document S/2008/467, which contains the text of a draft resolution prepared in the course of the Council's prior consultations.

Members also have before them document S/2008/436, which contains the text of identical letters dated 13 June 2008 from the Secretary-General addressed to the President of the General Assembly and the President of the Security Council, transmitting a letter dated 6 June 2008 from the President of the International Criminal Tribunal for Rwanda.

It is my understanding that the Council is ready to proceed to the vote on the draft resolution before it. Unless I hear any objection, I shall put the draft resolution to the vote now.

There being no objection, it is so decided.

A vote was taken by show of hands.

In favour:

Belgium, Burkina Faso, China, Costa Rica, Croatia, France, Indonesia, Italy, Libyan Arab Jamahiriya, Panama, Russian Federation, South Africa, United Kingdom of Great Britain and Northern Ireland, United States of America, Viet Nam

The President: There were 15 votes in favour. The draft resolution has been adopted unanimously as resolution 1824 (2008).

The Security Council has thus concluded the present stage of its consideration of the item on its agenda. The Security Council will remain seized of the matter.
