### **Threats to international peace and security caused by terrorist acts**

**The President** (*spoke in Russian*): The Security Council will now begin its consideration of the item on its agenda.

Members of the Council have before them documents S/2014/409 and S/2014/408, each of which contains the text of a draft resolution. It is my understanding that the Council is ready to proceed to the vote on the draft resolutions before it.

I shall first put to the vote the draft resolution contained in document S/2014/409, submitted by Australia, Lithuania, Luxembourg, the United Kingdom of Great Britain and Northern Ireland, the United States of America and France.
