### **The situation in the Middle East**

#### **Letter dated 20 February 2015 from the Panel of Experts on Yemen established pursuant to resolution 2140 (2014) addressed to the President of the Security Council (S/2015/125)**

**The President** (*spoke in Chinese*): The Security Council will now begin its consideration of the item on its agenda.

Members of the Council have before them document S/2015/126, which contains the text of a draft resolution submitted by the United Kingdom of Great Britain and Northern Ireland.

I wish to draw the attention of Council members to document S/2015/125, which contains a letter dated

20 February 2015 from the Panel of Experts on Yemen established pursuant to resolution 2140 (2014) addressed to the President of the Security Council.

It is my understanding that the Council is ready to proceed to the vote on the draft resolution before it. I shall put the draft resolution to the vote now.

*A vote was taken by show of hands.*

*In favour:*

Angola, Chad, Chile, China, France, Jordan, Lithuania, Malaysia, New Zealand, Nigeria, Russian Federation, Spain, United Kingdom of Great Britain and Northern Ireland, United States of America and Venezuela (Bolivarian Republic of)

**The President** (*spoke in Chinese*): There were 15 votes in favour. The draft resolution has been adopted unanimously as resolution 2204 (2015).

The Security Council has thus concluded the present stage of its consideration of the item on its agenda.
