### **The situation in Somalia**

#### **Report of the Secretary-General on the situation with respect to piracy and armed robbery at sea off the coast of Somalia (S/2015/776)**

**The President:** In accordance with rule 37 of the Council's provisional rules of procedure, I invite the representative of Somalia to participate in this meeting.

I wish to draw the attention of Council members to document S/2015/776, which contains the report of the Secretary-General on the situation with respect to piracy and armed robbery at sea off the coast of Somalia.
