ESTIMATED COST OF THE SECOND REVIEW CONFERENCE OF THE PARTIES TO THE TREATY ON THE PROHIBITION OF THE EMPLACEMENT OF NUCLEAR WEAPONS AND OTHER WEAPONS OF MASS DESTRUCTION ON THE SEA-BED AND THE OCEAN FLOOR AND IN THE SUBSOIL THEREOF

Note by the Secretariat

1. Based on the forecasts of the workload arising from the session of the Preparatory Committee, and from the Conference itself, and taking account of the other cost elements connected with the preparation and the holding of the Conference, the total costs are tentatively estimated to amount to:

(a)	Preparatory Committee - May 1983 (1 week) (including pre-session + post-session documentation)	\$116,200
	Second Review Conference - September 1983 (2 weeks) (including pre-session + post-session documentation)	349,600
(b)	Office of the Secretary-General of the Conference (Details are not as yet determined. However, it is anticipated that the requirements will more or less follow the pattern of the First Review Conference.)	24
(c)	Travel and subsistence of substantive staff	20,810

(d)	Miscellaneous supplies and services	10,000

- 2. The estimate for conference-servicing requirements for the Preparatory Committee and for the Review Conference itself are based on the rules of procedure of the First Review Conference (SBT/CONF/2). The breakdown of the costs estimated to arise therefrom is shown in Tables 1 and 2. The estimate for administrative support costs (13 per cent of expenditure incurred) is based on the standard percentage rate approved by the General Assembly and relates to the administrative costs incurred in the implementation of the Conference.
- 3. As in the case of the First Review Conference, the costs associated with the preparation and holding of the Second Review Conference and its Preparatory Committee have no financial implications for the regular budget of the United Nations and thus will be met in accordance with the financial arrangements to be made by the Review Conference. In order to enable the United Nations Office at Geneva to meet the cost of recruitment of the staff servicing the Conference, as well as costs already incurred, an advance payment of 80 per cent of the estimated cost would be required at the time the Review Conference takes a decision on the financial arrangements. The final share of the cost to be paid will be subject to the apportionment of the actual cost of the Conference pursuant to such arrangements.
