#### Secretary-General's bulletin

#### **United Nations mandatory learning programmes**

The Secretary-General, for the purpose of informing staff about the current mandatory learning programmes for staff members of the United Nations Secretariat, regardless of their level, function or duty station, promulgates the following:

#### Section 1 Aim

In accordance with Article 101 of the Charter of the United Nations, the "paramount consideration in the employment of the staff and in the determination of the conditions of service shall be the necessity of securing the highest standards of efficiency, competence, and integrity". The aim of mandatory programmes is to build a common foundation of knowledge and promote a shared organizational culture among staff of the Organization.

#### **Section 2**

#### Implementation, monitoring and compliance

Staff members are to complete the self-paced mandatory learning programmes within six months of the issuance of the present bulletin, or within six months of joining the Organization or assuming a role for which additional learning is mandatory. The annex to the present bulletin contains the list of mandatory learning programmes according to role, category/level or duty station. For instructor-led training, staff are recommended to enrol and complete the training within one year. Supervisors and heads of departments and offices are responsible for ensuring compliance with mandatory learning requirements and shall allocate sufficient time for staff members to complete them as part of their official duties. Staff members are responsible for checking their requirements for mandatory training and ensuring that they are up to date with the programmes.

#### Section 3

#### List of mandatory learning programmes

## Section 4 Final provisions

- 4.1 The present bulletin shall enter into force on the date of its issuance.
- 4.2 Information circular ST/IC/2017/17 entitled "United Nations mandatory learning programmes" is hereby abolished.
