**Organization of the Eleventh Meeting of Heads of
National Drug Law Enforcement Agencies, Europe****Organization of the Eleventh Meeting of HONLEA, Europe**

1. The draft provisional agenda for the Eleventh Meeting of HONLEA, Europe, is annexed to the present note. The Economic and Social Council, in its resolution 2005/28, entitled "Frequency of meetings of Heads of National Drug Law Enforcement Agencies, Europe" invited the Executive Director of the United Nations Office on Drugs and Crime to convene the Seventh Meeting of Heads of National Drug Law Enforcement Agencies, Europe, in 2007 and thereafter to convene such meetings every two years under the auspices of the Office. Therefore, the Eleventh Meeting of HONLEA, Europe will be held in 2015.

2. It would be highly desirable for the Tenth Meeting of HONLEA, Europe, to identify the topics that would be most appropriate for consideration by working groups at the Eleventh Meeting. The Meeting may also wish to revisit topics that have already been discussed at previous sessions, which may benefit from further in-depth discussion or consideration from some special perspective. Alternatively, the Meeting may wish to decide to request the Secretariat to informally consult Member States of the region with a view to identify topics for consideration by working groups. The meeting may wish to request the Secretariat to prepare annotations to the provisional agenda to assist in the preparations for the meeting and to guide discussions.

3. Item 4 of the provisional agenda for the Eleventh Meeting of HONLEA, Europe, will be devoted to the examination of the status of implementation of the recommendations adopted at the Tenth Meeting of HONLEA, Europe. A questionnaire concerning action taken by Governments to implement those recommendations will be sent with the invitations for the Eleventh Meeting of HONLEA, Europe. A report summarizing the responses from Member States will be

prepared in order to facilitate a consideration of the implementation of the recommendations of the present meeting during the Eleventh Meeting.

4. Reference is further to be made to CND Resolution 56/10, entitled “Tools to improve data collection to monitor and evaluate the implementation of the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem”, in which the Commission — among others — encouraged Member States to provide to the meetings of the subsidiary bodies more detailed information on progress made in the implementation by Member States of the Plan of Action, based on the annual report questionnaire; encouraged Member States, in consultation with the United Nations Office on Drugs and Crime, to devote the topic of at least one of the working groups at the meetings of the subsidiary bodies of the Commission to the follow-up to the Political Declaration and Plan of Action, on the basis of the reports submitted by States to the United Nations Office on Drugs and Crime; and requested the meetings of the subsidiary bodies of the Commission, on the basis of their deliberations, to submit regional recommendations aimed at positively moving forward in the implementation of the Political Declaration and Plan of Action.
