

Forty-first Meeting of Heads of National Drug Law Enforcement Agencies, Asia and the Pacific

Organization of the Forty-second Meeting of Heads of National Drug Law Enforcement Agencies, Asia and the Pacific

- 1. Representatives whose Governments wish to act as host for the Forty-second Meeting of Heads of National Drug Law Enforcement Agencies, Asia and the Pacific, or a subsequent meeting, are invited to inform the Forty-first Meeting accordingly. The information will be brought to the attention of the Commission on Narcotic Drugs at its sixty-first session.
- 2. The draft provisional agenda for the Forty-second Meeting is annexed to the present document.
- 3. Item 4 of the draft provisional agenda is devoted to the examination of the status of implementation of the recommendations of the Fortieth Meeting. To facilitate reporting, Governments will receive a questionnaire concerning action they have taken to implement those recommendations, which will be transmitted along with the invitation to the Forty-second Meeting.
- 4. At the fortieth session of the Commission on Narcotic Drugs, the view was expressed that the recommendations adopted by the meetings of the subsidiary bodies of the Commission would remain meaningless if Governments did not take action, including, where necessary, the enactment of national legislation to implement those recommendations. States represented at the Meeting of Heads of National Drug Law Enforcement Agencies, Asia and the Pacific, are urged to implement such recommendations conscientiously and promptly so that an effective evaluation of their progress can be made.
- 5. It would be desirable for the Forty-first Meeting to identify the topics that would be most appropriate for consideration by working groups at the Forty-second Meeting. The Meeting may also wish to revisit topics that have already been discussed at previous meetings and that might benefit from further in-depth discussion or consideration from a particular perspective. Alternatively, the Meeting

may wish to request the Secretariat to consult the participating States informally with a view to identifying topics for consideration by the working groups.

- 6. In its resolution 56/10, the Commission on Narcotic Drugs requested the meetings of the subsidiary bodies of the Commission to contribute to the monitoring of the implementation by Member States of the Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem at the regional level.
- 7. In the same resolution, the Commission encouraged Member States to consider the expertise and composition of their delegations to the meetings of its subsidiary bodies, with a view to covering the various aspects of the world drug problem (demand, supply and international cooperation) in order to hold substantive discussions on the issue.
- 8. The General Assembly held a special session on the world drug problem from 19 to 21 April 2016 and adopted an outcome document entitled "Our joint commitment to effectively addressing and countering the world drug problem" (General Assembly resolution S-30/1, annex). The outcome document covers a broad range of operational recommendations, organized in seven thematic areas. Member States resolved to take the steps necessary to implement the operational recommendations, in close partnership with the United Nations and other intergovernmental organizations and civil society, and to share with the Commission on Narcotic Drugs, as the policymaking body of the United Nations with prime responsibility for drug control matters, timely information on progress made in the implementation of those recommendations. At the Forty-second Meeting, participants will have the opportunity to discuss national and regional issues pertaining to the world drug problem, drawing on the outcome of the special session.
- 9. In its resolution 60/1, the Commission on Narcotic Drugs decided to convene a ministerial segment during its sixty-second session, to be held in Vienna in 2019, to take stock of the implementation of the commitments made to jointly address and counter the world drug problem, in particular in the light of the 2019 target date of the Political Declaration. At the Forty-second Meeting, participants will have the opportunity to discuss the follow-up to the Political Declaration and Plan of Action, and to the special session of the General Assembly on the world drug problem held in 2016, taking into consideration also the ministerial segment of the sixty-second session of the Commission.
- 10. The Forty-second Meeting will also provide participants with an opportunity to address any action by the Commission, further to its decision 60/1, taken in response to paragraph 97 of General Assembly resolution 71/211, inviting the Commission to examine how its subsidiary bodies could better contribute to the implementation of the outcome document of the special session of the General Assembly held in 2016.
