

Report of the Secretary-General

Summary

The present report, submitted pursuant to General Assembly resolution 74/53, contains information received from Member States on the export and import of conventional arms covered by the United Nations Register of Conventional Arms, as well as information on their international transfers of small arms and light weapons, in accordance with the "seven-plus-one formula" referred to in paragraph 3 of the same resolution and the recommendation contained in paragraph 83 of the group of governmental experts, on the continuing operation of the United Nations Register of Conventional Arms and its further development (A/71/259).

The report also contains additional background information received from Member States on military holdings and procurement through national production for the calendar year 2021. As at the date of submission of the present report, the Secretary-General had received reports from 37 Governments.

I. Introduction

- 1. The present report is the thirtieth consolidated report on the United Nations Register of Conventional Arms issued by the Secretary-General since the establishment of the Register. The General Assembly, in its resolution 74/53, called upon Member States to provide, on an annual basis, their data and information on international transfers of major conventional arms covered by the Register, including "nil reports", as well as information on their national procurement of arms and military holdings, as part of additional background information.
- 2. The General Assembly, in its resolution 71/44, called upon Member States to submit their views on the continuing operation of the Register and its further development, including on whether the absence of small arms and light weapons as a main category in the Register has limited its relevance and directly affected decisions on participation, by completing a questionnaire that was dispatched by the Secretariat. Furthermore, the Assembly requested the Secretary-General to continue to assist Member States to build capacity to submit meaningful reports and encouraged States in a position to do so to provide assistance for this purpose, upon request, including capacity to report on small arms and light weapons using the seven-plus-one formula.
- 3. On 18 February 2022, the Secretariat sent a note verbale to Member States in which they were requested to submit their reports. The note verbale was followed by email reminders. The replies received are reproduced in section II of the present report. Any national reports and additional information received from Governments after the submission of the report will be made available in the online database, in the original language of submission.
- 4. The percentage of Member States using the online reporting tool in filing their national reports with the Register had been rising since its introduction in 2012, from 20 per cent that year to more than 99 per cent in 2021. However, in 2022, the percentage declined slightly, to 92 per cent.
- 5. The originals of the submissions by Member States are made available to Governments by the Secretariat. The annual reports and other relevant information on the Register are available on the website of the Register.²

Israel supports the multilateral and bilateral cooperation necessary to eradicate all aspects of the illicit trafficking and proliferation of conventional arms.

Related policies

Three Principles on Transfer of Defence Equipment and Technology

While maintaining its basic philosophy as a peace-loving nation that conforms to the Charter of the United Nations and the course it has taken as a peace-loving nation, Japan will control the overseas transfer of defence equipment and technology based on the Three Principles on Transfer of Defence Equipment and Technology. The main contents of the Principles are as follows.

(1) Clarification of cases in which transfers are prohibited (the first Principle)

Overseas transfer of defence equipment and technology will not be permitted when: (a) the transfer violates obligations under treaties and other international agreements that Japan has concluded; (b) the transfer violates obligations under United Nations Security Council resolutions; or (c) the defence equipment and technology is destined for a country party to a conflict (a country against which the United Nations Security Council is taking measures to maintain or restore international peace and security in the event of an armed attack);

(2) Limitation to cases in which transfers may be permitted as well as strict examination and information disclosure (the second Principle)

In cases not within (1) above, cases in which transfers may be permitted will be limited to the following cases. Those cases will be examined strictly while ensuring transparency. The transfer contributes (a) to active promotion of peace contribution and international cooperation; or (b) Japan's security. Significant cases that require especially careful consideration from the viewpoint of Japan's security will be examined at the National Security Council. As for the cases that were deliberated at the National Security Council, the Government will disclose their information in accordance with the Act on Access to Information Held by Administrative Organs (Law No. 42 of 1999).

(3) Ensuring appropriate control regarding extra-purpose use or transfer to third parties (the third Principle)

In cases satisfying (2) above, overseas transfer of defence equipment and technology will be permitted only in cases in which appropriate control is ensured. More concretely, the Government will in principle oblige the Government of the recipient country to gain its prior consent regarding extra-purpose use and transfer to third parties.

Related policies

Policy change vis-a-vis Türkiye

Effective 15 October 2021, the processing of licence applications for the export of military goods or dual-use goods with military end use to Türkiye has resumed. Applications are assessed on the basis of a presumption of denial. In other words, a licence will only be issued if the applicant can incontrovertibly demonstrate that the goods will not be used in north-eastern Syrian Arab Republic. In addition, licence applications must meet the eight criteria of the European Union's Common Position on Arms Exports. This is a change compared to the policy that had been in effect since October 2019, whereby the processing of all new licence applications for the export of military goods or dual-use goods with military end use to Türkiye had been suspended, and no new licences were issued. In addition, on 15 October 2021, an exemption was introduced for licences that are necessary to uphold the international obligations of the Netherlands vis-à-vis the European Union, NATO and other intergovernmental organizations. Such licence applications seldom occur and will be carefully assessed on the basis of the eight criteria of the European Union's Common Position.
