# Review of the efficiency of the administrative and financial functioning of the United Nations

## **Report of the Fifth Committee**

## I. Introduction

1. The previous recommendations made by the Fifth Committee to the General Assembly under agenda item 136 are set out in the report of the Committee contained in documents A/77/673 and A/77/673/Add.1.

2. The Fifth Committee resumed its consideration of the item at its 35th meeting, on 30 June 2023. Statements and observations made in the course of the Committee's further consideration of the item are reflected in the relevant summary records.<sup>1</sup>
