

Report of the Working Group on the Universal Periodic Review*

Lithuania

Introduction

- 1. The Working Group on the Universal Periodic Review, established in accordance with Human Rights Council resolution 5/1, held its fortieth session from 24 January to 11 February 2022. The review of Lithuania was held at the 6th meeting, on 26 January 2022. The delegation of Lithuania was headed by the Vice-Minister of Justice, Jurga Greičienė. At its 14th meeting, held on 1 February 2022, the Working Group adopted the report on Lithuania
- 2. On 12 January 2022, the Human Rights Council selected the following group of rapporteurs (troika) to facilitate the review of Lithuania: Pakistan, Paraguay and Poland.
- 3. In accordance with paragraph 15 of the annex to Human Rights Council resolution 5/1 and paragraph 5 of the annex to Council resolution 16/21, the following documents were issued for the review of Lithuania:
- (a) A national report submitted/written presentation made in accordance with paragraph 15 (a);¹
- (b) A compilation prepared by the Office of the United Nations High Commissioner for Human Rights (OHCHR) in accordance with paragraph 15 (b);²
 - (c) A summary prepared by OHCHR in accordance with paragraph 15 (c).³
- 4. A list of questions prepared in advance by Belgium, Panama, Spain, Sweden and the United Kingdom of Great Britain and Northern Ireland was transmitted to Lithuania through the troika. These questions are available on the website of the universal periodic review.

I. Summary of the proceedings of the review process

A. Presentation by the State under review

- 5. The delegation described the main institutional and regulatory changes that Lithuania had made in the context of human rights, as well as the challenges it faced.
- 6. The accreditation of the Seimas ombudspersons' office as a national human rights institution with A status under the principles relating to the status of national institutions for the promotion and protection of human rights (the Paris Principles) was the most significant institutional change.
- 7. Social policy and human rights were at the centre of the National Progress Plan for 2021–2030. The Plan set out the horizontal principles of equal opportunities and gender equality as the main criteria in achieving the goals contained in the Plan.
- 8. Lithuania had made a significant step forward in children's rights protection by completely prohibiting any violence, including corporal punishment, against children.
- 9. Considerable progress in reducing the gender wage gap had been achieved. According to the *Global Gender Gap Report 2021*, published by the World Economic Forum, Lithuania was one of the five most-improved countries.
- 10. Gender equality had improved with regard to the representation of women in the highest offices in politics and in the public sector. For the first time, Lithuania had been elected to the Executive Board of the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women), serving for the period 2020–2022. The delegation described measures taken to prevent and combat domestic violence and violence against women and noted that the ratification of the Council of Europe Convention on Preventing and Combating Violence against Women and Domestic Violence (Istanbul Convention) was on the political agenda.

- 11. The policy on the integration of persons with disabilities had significantly changed, shifting from a support approach towards capacity-building and promotion of independent living. Further measures were provided within the 2021–2023 action plan for the social integration of persons with disabilities. Lithuania had joined the World Health Organization QualityRights initiative, aimed at changing mindsets and practices and improving the lives of persons with disabilities.
- 12. Lithuania was among the few European Union countries that had adopted a cross-sectoral plan to manage the adverse effects of the coronavirus disease (COVID-19) pandemic on mental health.
- 13. With regard to the status of the national minorities, the Ministry of Justice was drafting a new law on national minorities. The delegation noted recent legislative amendments granting national minorities the right to write their names in their original language.
- 14. The delegation shared the country's concerns about an increased irregular migration in the previous year, supported by Belarus authorities.
- 15. The representative of Belarus raised a point of order denouncing the terminology used and requested that the Vice-President of the Human Rights Council presiding over the meeting call on the delegation to adhere to official United Nations terminology.
- 16. The Vice-President of the Council recalled that the universal periodic review was a substantive mechanism of the Human Rights Council aimed at discussing the human rights situation of all States Members of the United Nations in a spirit of cooperation, respect and transparency. She also stated that it was expected that, when sharing views and positions, delegations would do so in full respect of United Nations terminology, rules and standards.
- 17. The Bolivarian Republic of Venezuela intervened in support of the point of order made by Belarus, stressing the importance that delegations respect the universal periodic review and United Nations terminology.
- 18. The Vice-President of the Council reiterated her ruling.
- 19. The delegation of Lithuania stated that the country had been compelled to declare a state of emergency. A decisive element in shaping the country's response towards the stabilization of the situation was the excellent cooperation with non-governmental organizations, members of the European Union, agencies, and international and humanitarian organizations, namely the European Border and Coast Guard Agency (Frontex), the European Asylum Support Office and the Office of the United Nations High Commissioner for Refugees. With regard to combating hate crime and hate speech, joint training had been provided for police officers, prosecutors and judges, in order to strengthen their capacities in recognizing hate crime and hate speech, to improve investigation and prosecution and ensure adequate punishment, and to respond to the needs of the victims.
- 20. Owing to the legislative amendments enabling the wider use of the suspension of sentences, conditional release and alternatives to imprisonment, the total number of inmates had decreased by an additional 21 per cent, and the number of applications for conditional release had doubled (since 2018).
- 21. Lastly, the delegation noted that during the consideration of the fourth periodic report of Lithuania, the Committee against Torture had commended the country's efforts to combat trafficking in persons, which had included the extension of criminal liability, a wide range of training activities and the adoption of the Inter-institutional Action Plan on Combating Human Trafficking.

B. Interactive dialogue and responses by the State under review

- 22. During the interactive dialogue, 82 delegations made statements. Recommendations made during the dialogue are to be found in section II of the present report.
- 23. Serbia commended Lithuania for all the measures taken in order to respond to the universal periodic review recommendations.

- 24. Slovakia condemned the instrumentalization of migration for political motives and noted the importance of managing the migratory situation in accordance with international legal obligations.
- 25. Slovenia commended Lithuania for the adoption of the national programme for the prevention of domestic violence and provision of assistance to victims.
- 26. Spain acknowledged the efforts made by Lithuania to improve the situation of women since the previous universal periodic review, including through amendments to the law on equal opportunities.
- 27. The State of Palestine commended the efforts made in combating hate crime, including through the project on strengthening the response to hate crimes and hate speech.
- 28. Sweden welcomed the adoption of legislation to protect children from domestic corporal punishment. However, it remained concerned regarding the pending ratification of the Istanbul Convention.
- 29. The Syrian Arab Republic took note of the presentation made by Lithuania.
- 30. Timor-Leste noted with appreciation the adoption of the action plan on the implementation of the national programme on equal opportunities for women and men.
- 31. Tunisia welcomed the country's ratification of most core human rights instruments and the adoption of policies on gender equality and the protection of children.
- 32. Turkey expressed appreciation for the efforts made by Lithuania to protect and promote human rights and expressed sadness that irregular migrants at the border were experiencing difficult conditions.
- 33. Turkmenistan noted with appreciation the accreditation of the Seimas ombudsmen's office as a national human rights institution in compliance with the Paris Principles, with A status.
- 34. Ukraine noted the strengthening by Lithuania of the independence of the national human rights institution and the country's strong record of ratification of core human rights.
- 35. The United Kingdom urged Lithuania to continue to provide the Office of the United Nations High Commissioner for Refugees with access to asylum seekers and migrants on the border.
- 36. The United Republic of Tanzania commended Lithuania for the implementation of various initiatives, including the adoption of policies to implement the recommendations accepted during the previous universal periodic review.
- 37. The United States of America commended Lithuania for holding the Future of Democracy forum, and for its support for democratic actors in exile from Belarus, the Russian Federation and other authoritarian Governments.
- 38. Belarus once again raised a point of order denouncing the use of language that was contrary to United Nations terminology and requested that the Vice-President of the Human Rights Council remind all delegations of the need to adhere to official United Nations terminology.
- 39. The Vice-President stated that it was of the utmost importance that when discussing human rights issues everybody respected each other's views and that delegations uphold United Nations terminology and standards when referring to countries and territories.
- 40. The Bolivarian Republic of Venezuela intervened in support of the point of order made by Belarus, stressing that disrespectful terminology should not be used in the universal periodic review, which was a forum for dialogue and cooperation.
- 41. The Vice-President reiterated her previous ruling.
- 42. Uruguay welcomed the efforts made by Lithuania in the area of human rights, including through the 2021–2023 Action Plan for the Promotion of Non-discrimination.
- 43. Uzbekistan welcomed the accreditation with A status of the office of the ombudsmen, the improvement in the protection of children's rights and the role of young people in society.

- 44. The Bolivarian Republic of Venezuela expressed its deep concerns about the human rights situation in Lithuania.
- 45. Afghanistan commended strides made towards being a more inclusive society, but remained concerned about the denial of access to asylum procedures.
- 46. Albania welcomed the accreditation of the office of the ombudsmen under the Paris Principles, the increased representation of women in political life and the progress made on children's rights.
- 47. Algeria noted with appreciation the accreditation of the office of the ombudsmen and the 2017–2020 action plan to promote non-discrimination and efforts to promote the inclusion of foreigners.
- 48. Argentina welcomed the recent provision approved by the Ministry of Justice allowing the change of name and surname for transgender persons of legal age.
- 49. Armenia welcomed the increase in the number of women holding leadership positions and the policy measures taken to combat trafficking in persons.
- 50. Australia welcomed the country's progress in continuing to address violence and discrimination against women and girls, as well as against lesbian, gay, bisexual, transgender and intersex persons, through better education programmes.
- 51. The Bahamas commended Lithuania for measures to protect the rights of children and persons with disabilities and for achievements in women's representation in leadership and decision-making roles.
- 52. Bangladesh expressed appreciation for the strengthening of human rights institutions but expressed concern at reports of intolerance of, and prejudice and hate crimes against, minority groups, migrants and refugees.
- 53. Belarus stated that the real scale of human rights issues in Lithuania could not be measured as it had not been visited by the special procedures for 15 years.
- 54. Belgium stated that notwithstanding achievements made by Lithuania, further progress could be made regarding the rights of women and lesbian, gay, bisexual, transgender and intersex persons.
- 55. Brazil commended Lithuania for the adoption of measures aimed at protecting children. It expressed concern over reports of intolerance and encouraged Lithuania to combat discrimination and hate speech.
- 56. Bulgaria praised the preparation of the upcoming programme for the development of an environment suitable for persons with disabilities in all areas of life.
- 57. Canada noted the exceptional increase in the influx of asylum seekers and encouraged Lithuania to continue to adapt its procedures in accordance with its international obligations.
- 58. Chile highlighted the adoption, in 2016, of the 2017–2019 action plan for combating trafficking in persons.
- 59. China expressed concern about racism and xenophobia; the violation of the rights of, and abuse of, of ethnic minorities, refugees and migrants; domestic violence; and conditions in detention facilities.
- 60. Croatia commended Lithuania for amendments to the Criminal Code establishing criminal liability for acts of discrimination based on sex, gender and sexual orientation.
- 61. Cuba expressed concern regarding discrimination against minorities, and urged Lithuania to intensify efforts to achieve significant improvements in that regard.
- 62. Cyprus welcomed the country's signature of the Optional Protocol to the Convention on the Rights of the Child on a communications procedure, and the progress made in protecting migrants' rights while addressing unprecedented irregular influxes.
- 63. Czechia commended Lithuania for its progress regarding the effective functioning of the national preventive mechanism, and for measures taken to eliminate prison overcrowding.

- 64. The Democratic People's Republic of Korea expressed concern about continued human rights violations in Lithuania.
- 65. Denmark welcomed measures to combat gender-based violence, but expressed concern about the protection of lesbian, gay, bisexual, transgender and intersex persons from discrimination and about the lack of legal recognition of same-sex couples.
- 66. The Dominican Republic encouraged Lithuania to continue strengthening its normative framework for promoting and protecting human rights.
- 67. In response to questions raised or comments made by Belgium, Panama, Spain and Sweden, the delegation indicated that Lithuania shared their concerns with respect to violence against women and domestic violence, and issues relating to equal pay, social inclusion of the elderly, migrants in irregular situations, the Roma community, and measures taken to ensure better social security for every group in society.
- 68. The social policy of Lithuania was sustainable, inclusive and targeted to the needs of individuals. Five newly adopted long-term development programmes would be implemented by 2030.
- 69. Responding to comments from Estonia and France, the delegation reported that a new model of employment was being developed to address the employment gap faced by persons with disabilities.
- 70. Lithuania made significant efforts to protect the rights of the child. The centralized system obliged institutions to be able to respond to reports of possible child rights violations at any time of day or night, seven days per week.
- 71. With regard to women's rights, Lithuania indicated that women were actively involved in political leadership and in the high-value-added sectors of the economy.
- 72. Referring to comments made by Bangladesh, the delegation emphasized the government initiatives aimed at reducing the gender pay gap. The remuneration system was constructed to avoid discrimination on the ground of gender. Employers were legally obliged to approve pay systems and make them available to all employees.
- 73. The delegation shared that 2022 had been declared as the Year of Youth in Lithuania.
- 74. In response to concerns raised by Canada and Denmark regarding the status of samesex partnerships, and the related question from Sweden, the delegation reaffirmed the commitment of Lithuania to grant the full enjoyment of rights to same-sex partners, and provided information about developments in that respect.
- 75. Addressing questions submitted by Belgium and Sweden, the delegation acknowledged that, despite the existence of a comprehensive legal framework, the problem of domestic violence remained significant in the country. A draft legislative proposal would introduce an emergency protection order in order to better protect persons at risk of violence and provide for urgent separation from the abusive partner or relative. Work to prevent domestic violence had been enhanced through the specialized national programme for the prevention of domestic violence and provision of assistance to victims. To address a one-time spike in domestic violence, Lithuania had reacted swiftly at the beginning of the pandemic: an action plan involving tailor-made measures to improve victims' access to aid had been adopted and preventive actions directed at potential perpetrators had been taken. The law on assistance for victims of crime provided for the establishment of a comprehensive mechanism to provide assistance for the victims of any crime throughout the criminal proceedings.
- 76. The delegation underscored the successful legislative reform in the field of mental health care, aimed primarily at protecting the rights of involuntarily hospitalized patients. The country was, however, still in the process of establishing best practices. Lithuania recognized the importance of preventing the application of involuntary measures by reducing the need for them, and of increasing efforts to expand alternatives to involuntary hospitalization.
- 77. Regarding comments made by Bulgaria and questions posed by Panama, the delegation expressed the view that children with special educational needs should be

educated in a way that best met their educational and support needs. The Law on Education obliged all mainstream schools to accept children with special educational needs, as of 2024.

- 78. Several delegations, including Belgium, Canada, Slovakia, the Syrian Arab Republic, the United Kingdom and the United States, and the State of Palestine, submitted questions and/or made comments regarding combating hate crime and hate speech. The delegation of Lithuania presented a five-pillar approach and relevant measures that had been taken as a response to hate speech: building trust between law enforcement and the vulnerable communities in order to increase reporting; improving the recording and investigation of hate crimes; strengthening the skills of law enforcement and members of the judiciary; strengthening cooperation between non-governmental organizations and the Government; and supporting the victims of such crimes.
- 79. Responding to a comment from the Bahamas, Lithuania indicated that new amendments to the Criminal Code expanded the list of criteria for hate crimes by including colour of skin and ethnic origin.
- 80. Addressing questions and recommendations from the United Kingdom and Venezuela (Bolivarian Republic of) regarding the rights of transgender persons, the delegation acknowledged that the recognition of the legal status of transgender persons remained an issue, although transgender persons could change their names to names specific to the opposite sex if they so wished.
- 81. In response to questions posed by and/or comments from Belgium, Brazil, Panama and Spain regarding the criminalization of marital rape, Lithuania reaffirmed that any form of sexual abuse, including marital rape, was already criminalized under the Criminal Code, as confirmed in case law.
- 82. Responding to a question submitted by Spain and a comment from Argentina, the delegation specified that criminal liability was applied in the context of illegal abortions.
- 83. In response to comments from China and Venezuela (Bolivarian Republic of) relating to imprisonment, the delegation underlined that the Criminal Code had been supplemented with the introduction of a new offence of torture, that the possibilities for the application of bail had been extended and that other measures were envisioned.
- 84. Regarding a comment from Czechia relating to the Law on the Protection of Minors against the Detrimental Effect of Public Information, Lithuania noted that the monitoring of the application of the law's relevant provisions had not revealed any form of discrimination.
- 85. Egypt commended the progress made by Lithuania in the promotion of the rights of young people, women and persons with disabilities, the integration of migrants, and combating hate speech.
- 86. Estonia welcomed the accreditation of the Seimas ombudsmen's office with A status, in line with the Paris Principles, and the country's provision of additional funding for protecting asylum seekers.
- 87. Fiji congratulated Lithuania for regulatory and policy changes, such as the adoption of the National Progress Plan for 2021–2030, which set measurable targets in social policy and human rights.
- 88. Finland welcomed the improvements made by Lithuania in the areas of gender equality and increasing the participation of women in politics and society.
- 89. France welcomed progress made by Lithuania in the field of human rights, particularly regarding judicial independence and combating corruption.
- 90. Georgia welcomed the country's ratification of core human rights instruments and the implementation of the 2017–2019 action plan for combating trafficking in human beings.
- 91. Germany commended efforts made by Lithuania to address domestic violence effectively and for legislation allowing transgender people to change their name.
- 92. Greece commended Lithuania for amending its domestic legislation on the protection of the rights of the child and adopting action plans for the promotion of equal opportunities.

- 93. Iceland welcomed the delegation and its national report.
- 94. India expressed appreciation for the country's submission of various treaty body reports and the development of sector policies guiding the promotion and protection of human rights.
- 95. Indonesia expressed appreciation for the country's strengthening of legislation aimed at providing better protection for children.
- 96. The Islamic Republic of Iran welcomed the delegation.
- 97. Iraq expressed appreciation for efforts to amend the Law on Fundamentals of Protection of the Rights of the Child and the subsequent awareness campaigns.
- 98. Ireland welcomed the 2017 amendments to the Criminal Code and notable progress in strengthening legislation on domestic violence, including amendments to improve assistance for victims.
- 99. Israel commended Lithuania for including young people in decision-making and recognized progress made towards ensuring the full enjoyment of human rights by LGBTQI+ persons.
- 100. Italy welcomed the adoption of several action plans for promoting and protecting human rights, including the Action Plan for the Promotion of Non-discrimination.
- 101. Japan expressed great appreciation for the positive steps taken since the previous review cycle, notably for protecting children from human rights violations.
- 102. Jordan commended Lithuania for its methodology for preparing the national report in cooperation and consultation with all relevant stakeholders.
- 103. Latvia welcomed the criminalization of torture in conformity with the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, and the introduction of a complete prohibition of the use of corporal punishment on children.
- 104. Lebanon commended Lithuania for the criminalization of torture in conformity with the Convention against Torture.
- 105. Liechtenstein thanked the delegation for the information provided in the introductory statement and national report.
- 106. Luxembourg noted with great satisfaction that Lithuania had ratified almost all core United Nations human rights instruments and Optional Protocols thereto.
- 107. Malaysia expressed the hope that the Government would continue to empower women, and encouraged Lithuania to take steps to further integrate women facing various challenges.
- 108. Maldives welcomed the implementation of measures to prevent domestic violence and human trafficking and to integrate national minorities and migrants.
- 109. The Marshall Islands welcomed efforts to combat domestic violence through the National Programme for the Prevention of Domestic Violence and Provision of Assistance to Victims and endeavours to address climate change.
- 110. Mexico welcomed the Law on Strategic Management, which enshrined gender equality as a cross-cutting principle, and the Law on Assistance for Victims of Criminal Offences.
- 111. Montenegro echoed the recommendation made by the Human Rights Committee that Lithuania strengthen efforts to combat discrimination, stereotypes and prejudice towards vulnerable and minority groups.
- 112. Morocco welcomed the establishment of the National Progress Plan for 2021–2030 as a reference framework for protecting and promoting human rights.
- 113. Nepal hailed the international accreditation of the Seimas ombudspersons' office as a national human rights institution with A status, and efforts for the inclusion of national minorities.

- 114. The Netherlands commended the Government of Lithuania on its firm support for dissidents of the Russian and Belarusian opposition and for supporting human rights defenders.
- 115. The Niger took note of the different national action plans introduced, including the Action Plan for the Promotion of Non-discrimination.
- 116. Norway welcomed important progress towards further protection of human rights, but noted that there was a need to strengthen the response to domestic and gender-based violence.
- 117. Pakistan commended Lithuania for its efforts to strengthen the human rights framework, while expressing concern over rising incidents of incitement to violence against migrants, refugees and the Roma and Muslim communities.
- 118. Paraguay expressed appreciation for the efforts to protect the rights of persons with disabilities and improvements in domestic legislation to ensure equality between women and men.
- 119. The Philippines acknowledged the steps taken to combat trafficking in persons and to promote the participation of women in the public sphere.
- 120. Poland encouraged Lithuania to address challenges faced by its national minorities, inviting the country to continuously include their voices in the decision-making processes concerning them.
- 121. Portugal expressed appreciation for the recently adopted regulation allowing transgender persons to change their names, and for efforts to improve the access of young persons to free mental health services.
- 122. The Republic of Korea welcomed the work of the Seimas ombudsmen's office and commended the country's efforts in strengthening the legal and institutional framework for the protection of children's rights.
- 123. The Republic of Moldova welcomed the adoption of the National Progress Plan for 2021–2030, aimed at ensuring equal opportunities and gender equality.
- 124. Romania congratulated Lithuania for its election as a member of the Human Rights Council and commended its achievements in advancing the human rights legal and policy framework.
- 125. The Russian Federation was concerned at the delay in the adoption of the law on national minorities, and at the policy to make the so-called Lithuanian partisans into heroes.
- 126. Senegal welcomed the accreditation of the Seimas ombudsmen's office in line with the Paris Principles, and measures to combat hate speech.
- 127. On the issue of migration and asylum, the delegation stressed that Lithuania had suffered an unprecedented hybrid attack by means of instrumentalized migration. The asylum and reception systems had been intentionally overwhelmed with the artificially facilitated migrant flows, with the deliberate goal to limit response capabilities and endanger the lives of irregular migrants. However, the domestic procedures had been adapted and currently the system was functioning properly, in accordance with the requirements of international law.
- 128. In response to a question submitted by Spain, and comments and/or recommendations made by Estonia, Luxembourg, Mexico, Morocco and Portugal, the delegation highlighted, among other things, that the asylum procedures were transparent, the rights of asylum seekers were fully respected, namely, access to legal aid was granted, judicial appeals were provided for, and asylum applications were examined strictly, applying an individual approach. Moreover, vulnerable groups, such as families, minors, and lesbian, gay, bisexual, transgender and intersex persons, were accommodated separately, and their asylum procedures were prioritized. It was envisioned that, from 2022, it would be possible for children seeking asylum to attend pre-school or school.
- 129. The delegation confirmed the country's commitment to reducing statelessness. In response to comments from the United Kingdom and Uruguay, it pointed out that the number of stateless persons was constantly decreasing.

- 130. With regard to the issue on the rights of the national minorities raised by a number of delegations (Afghanistan, Albania, Belarus, China, Croatia, Cuba, Indonesia, Iran (Islamic Republic of), Italy, Lebanon, Montenegro, Pakistan, Poland, the Russian Federation, Serbia, Spain, Timor-Leste, Tunisia, Turkmenistan and the United Kingdom), Lithuania noted that all national minorities (Belarusian, Polish, Russian and others) residing in Lithuania were well integrated. Children attended national kindergartens and schools; they learned in their mother tongues, and the Lithuanian language was taught as a separate subject. Persons belonging to the national minorities participated fully in social life, the labour market, science, politics, and public and cultural life.
- 131. In response to comments from Bangladesh, Brazil, Croatia, Cuba, Iran (Islamic Republic of), Romania, Spain, Tunisia, the United States, Uzbekistan and Venezuela (Bolivarian Republic of) on the rights of Roma, Lithuania highlighted that the measures outlined in the strategic action plans and the action plan for the integration of Roma into Lithuanian society for 2015–2020 had been successfully implemented, and a new plan was being drafted. Roma pupils were enrolled in general education institutions in Lithuania in more than half of the municipalities, and individual measures to improve the social and educational situation of Roma pupils were taken.
- 132. In reference to comments from Liechtenstein, Nepal, the United Kingdom and the United States, the delegation emphasized the seriousness of the approach that the State had taken with regard to trafficking in persons and modern slavery. The policy in that area was coordinated at the highest level. A coordinating body had been established by the Government, comprising representatives of all relevant stakeholders, namely, the Government and non-governmental organizations.
- 133. With regard to questions posed and/or comments made by Albania, Morocco and Italy, the delegation noted that the process for the ratification of the Optional Protocol to the Convention on the Rights of the Child on a communications procedure was progressing.
- 134. Regarding the ratification of the Optional Protocol to the International Covenant on Economic, Social and Cultural Rights, and the International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families, the Government's position had not changed since the second universal periodic review cycle. That was relevant to recommendations made by Bangladesh, Belgium, Fiji, the Niger, the Philippines and Venezuela (Bolivarian Republic of).
- 135. Responding to questions and recommendations submitted by Belgium, Croatia, Romania, Spain, Sweden and others, on the ratification of the Istanbul Convention, the delegation emphasized that the relevant draft law had been registered in the Parliament in 2018. The work on the improvements of the national legislation related to the implementation of the Convention was ongoing.
- 136. Lastly, the delegation commented on certain issues raised during the universal periodic review process. The end of the Second World War had not brought peace to Lithuania, but rather hard years of occupation. Lithuanian freedom fighters were the real partisans who had upheld hope for an independent country fighting the brutal communist occupation. Only by recognizing crimes committed by all totalitarian regimes and respecting fallen victims could it be ensured that such crimes were never repeated in the future. The horrors of the Holocaust and the Gulag would remain black pages in history.

- 138.22 Continue adopting measures to respect the rights of LGBTQI+ people, including within the fight against all types of discrimination, and regarding the recognition of civil rights, such as equal marriage (Argentina);
- 138.23 Take effective measures to eradicate intolerance towards, and prevailing prejudices and discrimination against, vulnerable groups, including lesbian, gay, bisexual, transgender and intersex persons (Cuba);
- Review the provisions in the Law on the Protection of Minors against the Detrimental Effect of Public Information which limit the dissemination of information about various family and personal relations in order to strengthen the protection of lesbian, gay, bisexual, transgender and intersex persons (Czechia);
- 138.25 Eliminate discrimination against the lesbian, gay, bisexual, transgender and intersex community, including by amending the Law on Equal Treatment to also prohibit discrimination on the basis of gender identity, and by adopting legislation recognizing registered same-sex partnerships (Denmark);
- Revise the law on the protection of minors to ensure it is not applied to censor LGBTI+-related public information (Iceland);
- Develop and adopt a new national human rights plan that addresses discrimination based on sexual orientation, which is a serious issue in the country (Bolivarian Republic of Venezuela);

- 138.28 Adopt gender identity legislation that protects, respects and recognizes transgender people, and facilitates the change of name and identity on personal documents (Mexico);

 - 139.6 Stop violating the rights of refugees and migrants (China).
- 140. Lithuania could not support the recommendations contained in paragraphs 139.1, 139.2, 139.3, 139.4, 139.5, 139.6 as it considers them to be impertinent to the content of the review and Human Rights Council resolutions 5/1 and 16/21.
