**Land violations committed in December 2018**

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
4 December	1140	From inside occupied Palestinian territory opposite the town of Mays al-Jabal, near point BP31, an Israeli enemy Raccoon Stalker vehicle mounted with surveillance cameras pointed its cameras in the direction of Lebanese territory. At 1250 hours, a tunnel-detection vehicle accompanied by an armoured truck for protection appeared, escorted by two Hummer vehicles, from which 15 soldiers disembarked, deployed and took up positions. Some of the soldiers pointed their individual weapons at Lebanese Army soldiers and a United Nations Interim Force in Lebanon (UNIFIL) liaison unit patrol. The tunnel-detection vehicle operated along the road opposite the aforementioned point. At 1645 hours, the enemy vehicles and soldiers left in the direction of occupied territory.
	1000	From inside occupied Palestinian territory at the Israeli enemy's Tallat Karantina post, opposite the town of Yarun, Israeli enemy soldiers pointed their individual weapons in the direction of a Lebanese Army patrol.
5 December	0700	Opposite the town of Mays al-Jabal and points B65 and B63-1, five Israeli enemy soldiers planted sensors attached to poles. They operated a machine that produced strong vibrations near the sensors that they had planted. An individual was also observed carrying a device on his back and a screen in front of him, escorted by 10 soldiers and a Defender vehicle. While the work was going on, several soldiers pointed their weapons in the direction of Lebanese Army patrols. At 1540 hours, the work finished and the soldiers left in the direction of occupied Palestinian territory.
	0700	At the Israeli enemy post east of the town of Mays al-Jabal, an Israeli enemy Raccoon Stalker vehicle mounted with surveillance cameras pointed them in the direction of Lebanese territory.
6 December	–	At various times, the Israeli enemy called Lebanese civilians and Lebanese military posts in border areas, including the town of Kafr Killa, from unknown numbers and left voice messages warning them to steer clear of alleged tunnels that they were planning to blow up.
	1410	From inside occupied Palestinian territory opposite the town of Ayta al-Sha'b and opposite points B32-1 and B32-2, some 10 Israeli enemy soldiers deployed and pointed their automatic weapons and individual weapons at in the direction of a Lebanese Army patrol. They also directed insults at the patrol and warned it not to come near Blue Line.
	1510	From inside occupied Palestinian territory, in the Israeli enemy post north-west of Abu Dajaj opposite the town of Ramiya, the Israeli enemy pointed a Merkava tank cannon in the direction of Lebanese territory. From inside the Israeli enemy post north of the Zar'it barracks, an Israeli enemy soldier pointed his weapon in the direction of Lebanese territory.
7 December	0700	Some Israeli enemy soldiers pointed military weapons in the direction of Lebanese Army patrols at points BP2, BP2-1, B4, B6-1 and B7.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	1700	Inside occupied Palestinian territory, while the Israeli enemy was putting up one tent west of point BP2 and another tent east of point B7, civilian and military vehicles and wheeled bulldozers were observed entering and exiting the Jall al-Alam post and moving along the military road leading to the aforementioned post west of point BP2. Enemy soldiers pointed military weapons in the direction of Lebanese Army patrols.
8 December	1100	Opposite the town of Mays al-Jabal and points B64 and B65, an Israeli enemy patrol comprising five Defender vehicles, 30 soldiers and a tunnel-detection vehicle accompanied by an armoured truck appeared. As they deployed, a member of the patrol fired two rounds from his individual weapon into the air in the direction of Lebanese territory, without injuring anyone. Nine soldiers crossed the technical fence without violating the Blue Line and made marks with blue spray paint near the Blue Line. They pointed their individual weapons in the direction of Lebanese Army soldiers. All this occurred in the presence of two UNIFIL liaison unit personnel inside occupied Palestinian territory. Lebanese Army patrols and the UNIFIL liaison unit monitored the activity.
9 December	0700	Opposite point BP2, Israeli enemy army soldiers photographed Lebanese territory.
	0800	On the outskirts of the town of Mays al-Jabal between points B64 and B64-1, Israeli enemy army soldiers took up combat positions and pointed their weapons in the direction of Lebanese territory and a Lebanese Army patrol.
	0830	Opposite the town of Mays al-Jabal, Israeli enemy soldiers deployed, took up combat positions behind rocks, and pointed automatic weapons in the direction of the Lebanese Army, in the presence the patrols from the UNIFIL liaison unit and the Nepalese unit. Subsequently, Lebanese Army personnel took up defensive positions and pointed their weapons in the direction of the enemy soldiers. Personnel from the UNIFIL liaison unit defused the situation after coordinating between the Lebanese side and the Israeli enemy side.
	1400	Opposite the town of Mays al-Jabal, the Israeli enemy observation sent up an observation balloon inside occupied territory while two enemy reconnaissance aircraft violated Lebanese airspace multiple times. Subsequently, Lebanese Army soldiers deployed and took up defensive positions. A UNIFIL liaison unit patrol was asked to warn the Israeli enemy to cease the violation being perpetrated by the two aircraft, or the aircraft would be fired on immediately. Upon being so warned, Israeli enemy soldiers deployed, took up combat positions and pointed their weapons in the direction of the Lebanese side.
10 December	0830	Inside occupied Palestinian territory, while the Israeli enemy was active at points B28 (the Kafr Killa crossing) and (B85), five surveillance cameras were mounted on a pole above a cement wall and pointed in the direction of Lebanese territory.

		<ul style="list-style-type: none"> <li>– Opposite the town of Mays al-Jabal, five Israeli enemy excavators crossed the technical fence, and enemy personnel took up combat positions behind newly raised earthen berms. They pointed their weapons in the direction of Lebanese territory in full view of UNIFIL liaison unit personnel. In addition, a reconnaissance aircraft violated Lebanese airspace at high altitude over the town.</li> </ul>
	1100	Opposite the town of Blida, enemy vehicles followed up digging activities, using excavators and searchlights to work at night. While that was going on, a camera was raised on a pole and point in the direction of Lebanese territory.
	1230	Inside the occupied Shab'a farms in Hasbayya, several explosions were heard in the area south of the Israel enemy's Sammaqah outpost.
12 December	1000	From inside occupied Palestinian territory opposite the town of Ramiya and points BP10-1 and BP28 near a Green without Borders association post, while the Israeli enemy army was raising earthen berms, enemy soldiers army pointed their weapons in the direction of Lebanese territory, while a personnel carrier released smoke to create a smokescreen.
	1030	Inside the occupied Shab'a Farms behind the Fashkul post, the sound of
	1130	light- and medium-military-weapons fire was heard. The Israeli enemy also launched a balloon without a camera inside occupied territory near the Abbasiyah post.
15 December	0900	From inside occupied Palestinian territory, opposite the town of Yarun and the Hadab post, the Israeli enemy pointed a Merkava tank cannon in the direction of Lebanese territory.
16 December	0900	Inside occupied Palestinian territory, between points B64 and B64-1, while the Israeli enemy was engaged in bulldozing activities, 20 enemy soldiers deployed and pointed their weapons in the direction of Lebanese territory.
	1140	Inside the occupied Shab'a Farms, bursts of medium- and heavy-military-
	1330	weapons fire were heard in the area around the Israeli enemy's Ruwaysat al-Alam and Jabal al-Rus posts. That was accompanied by an overflight by an Israeli enemy reconnaissance aircraft.
17 December	0800	From inside occupied Palestinian territory opposite the town of Mays al-Jabal between points B64 and B64-1, two Poclain bulldozers escorted by 15 Israeli enemy soldiers crossed the technical fence in order to carrying out bulldozing activities. At 1020 hours, seven enemy soldiers laid barbed wire opposite the two aforementioned points, crossing the Blue Line at three places along an 18-metre stretch. At 1630 hours, the Israeli enemy finished its work and the vehicles and soldiers left in the direction of occupied territory.
	1415	Opposite the town of Ramiya and point BP9, the Israeli enemy Israeli completed excavation work with a well digger, a Poclain backhoe, a Poclain bulldozer, a Port Char truck carrying two prefabricated rooms and a civilian pickup, accompanied by 10 soldiers. The boom of the digger crossed the technical fence. At 1730 hours, the Israeli enemy directed a searchlight in the direction of Lebanese territory. At 1800 hours, the work finished, but the vehicles and soldiers remained at their locations.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
20 December	1600	Inside occupied Palestinian territory near point BP9, the Israeli enemy deployed two trucks loaded with various kinds of equipment. It set up the equipment and then broadcast a message over social networks that it was going to blow up alleged tunnels. A number of Lebanese civilians and Lebanese military posts in border areas, including the town of Ramiya, received voice messages in Arabic from unknown numbers warning them to steer clear of the tunnels that they were planning to blow up. At 2045, a massive explosion was heard near the aforementioned point, which broke glass in the home of civilian Ali Isa. Only material damages occurred, without any injuries.
22 December	1100	From inside occupied Palestinian territory opposite the town of Ayta al-Sha'b, between points BP12 and BP12-1, some 10 Israeli enemy soldiers escorted by 20 other Israeli enemy soldiers laid barbed wire opposite the two aforementioned points, violating the Blue Line. After protests from the Lebanese Army, a UNIFIL liaison unit patrol in Lebanon that had been monitoring activities in Lebanese territory contacted the Israeli enemy, which then removed the aforementioned barbed wire. At 1415 hours, the Israeli enemy finished its work and the enemy soldiers left in the direction of occupied territory.
23 December	0830	From inside occupied Palestinian territory opposite the town of Ayta al-Sha'b between points BP12 and BP12-1, the Israeli enemy completed the work it had begun on 22 December. It also moved the barbed wire strip so that it violated the Blue Line in four places. At 1625 hours the Israeli enemy removed the barbed wire from the four places where it violated the Blue Line and moved the barbed wire back inside occupied territory.
25 December	0130	A number of Lebanese citizens in border areas, including the town of Kafr Killa, received calls from unknown numbers originating with the Israeli enemy warning them to steer clear of the location of alleged tunnels that they were planning to destroy.
26 December	1205	Inside occupied Palestinian territory, opposite points BP10, BP10-1 and BP29 and the town of Ramiya, an armoured personnel carrier mounted with a 12.7 mm machine gun approached. It pointed the machine gun in the direction of Lebanese territory and a Lebanese Army patrol. The personnel carrier released smoke to create a smokescreen, which cause slight shortness of breath to members of the Lebanese Army patrol. At 1250 hours, it left in the direction of occupied territory. At 1220 hours, a second armoured personnel carrier mounted with a 12.7 mm machine gun approached, and pointed the machine gun in the direction of Lebanese territory and the Lebanese Army patrol.
27 December	0700	From inside occupied Palestinian territory opposite the town of Ayta al-Sha'b at point BP12-1, while the Israeli enemy was performing repair work on the dirt road between the technical fence and the Blue Line, some stones were pushed onto the Lebanese side, and the boom of one of the vehicles crossed the Blue Line several times. Enemy soldiers also pointed a 12.7 mm machine gun in the direction of a Lebanese Army patrol located on the opposite side in Lebanese territory.
28 December	1600 1700	Inside the occupied Shab'a Farms, in the area around the Ruwaysat al-Alam post, several bursts of medium- and heavy-weapons fire were heard.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	0900	Inside occupied Palestinian territory, opposite the town of Ayta al-Sha‘b, near point BP12-1, an Israeli enemy patrol comprising three military pickups and a personnel carrier approached. Some 16 enemy soldiers disembarked, of whom 10 crossed the technical fence, performed follow-up work on the technical fence, and placed sensor devices on it. They were accompanied by two personnel from the UNIFIL liaison unit. One of the Israeli enemy soldiers pointed his individual weapon in the direction of Lebanese Army soldiers. While all this was happening, a remote-controlled aircraft circled over the area where the work was taking place without violating the Blue Line. The work was completed at 1500 hours and everyone involved left in the direction of occupied territory.

The launch then left in the direction of occupied Palestinian territorial waters.
2 December	1605	Off Ra’s al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five minutes, proceeding on its way for some 315 metres. The launch then left in the direction of occupied Palestinian territorial waters.
3 December	1615	Off Ra’s al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for four minutes, proceeding on its way for some 575 metres. The launch then left in the direction of occupied Palestinian territorial waters.
9 December	2032	Off Ra’s al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for four minutes, proceeding on its way for some 295 metres. The launch then left in the direction of occupied Palestinian territorial waters.
14 December	0230	Off Ra’s al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for one minute.
17 December	0205	Off Ra’s al-Naqurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards the Lebanese Army Ra’s al-Naqurah post for 15 seconds.
	0503	Off Ra’s al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for nine minutes, proceeding on its way for some 960 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 0520 hours, it violated the boundary again for 15 minutes, proceeding on its way for some 830 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 0547 hours, it violated the boundary again for one hour and two minutes, proceeding on its way for some 800 metres. The launch then left in the direction of occupied Palestinian territorial waters.
21 December	1915	Off Ra’s al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for five

		minutes, proceeding on its way for some 50 metres. The launch then left in the direction of occupied Palestinian territorial waters. At 1930 hours, it violated the boundary again for eight minutes, proceeding on its way for some 100 metres, in the course of which it directed a searchlight at Lebanese territorial waters and broadcast in Arabic over loudspeakers. The launch then left in the direction of occupied Palestinian territorial waters.
24 December	1648	Off Ra's al-Naqrurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for one minute, proceeding on its way for some 519 metres. The launch then left in the direction of occupied Palestinian territorial waters.
29 December	0504	Off Ra's al-Naqrurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for one minute.
	0504	Off Ra's al-Naqrurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for six minutes, proceeding on its way for some 370 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0513	Off Ra's al-Naqrurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for one hour and seven minutes, proceeding on its way for some 570 metres. The launch then left in the direction of occupied Palestinian territorial waters.
	0519	Off Ra's al-Naqrurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for four minutes.
	0602	Off Ra's al-Naqrurah, from inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters for one minute.

9 December	1110	Two Israeli enemy warplanes violated Lebanese airspace, entering over the sea west of Jubayl. They circled between Shikka and Jubayl before leaving at 1135 hours over the sea west of Naqurah.
	1115	Two Israeli enemy warplanes violated Lebanese airspace, entering over Rumaysh. They left at 1125 hours over the sea west of Shikka.
	1145	Two Israeli enemy warplanes violated Lebanese airspace, entering over the sea west of Shikka. They circled over all regions of Lebanon before leaving at 1245 hours over the sea west of Naqurah.
	1215	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Rumaysh. It circled over Riyaq, Ba'albek, Hirmil and the South before leaving at 2150 hours over Naqurah.
	1540	An Israeli enemy reconnaissance aircraft violated Lebanese territory, entering over Aytarun. It circled over the South before leaving at 1640 hours over Alma al-Sha'b.
10 December	0615	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Naqurah. It circled over Riyaq, Ba'albek and Hirmil before leaving at 1730 hours over Rumaysh.

	1630	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Rumaysh. It circled over Riyaq, Zahlah, Ba'albek, Hirmil and the South before leaving at on at 0340 hours on 11 December over Kafr Killa.
11 December	0340	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Kafr Killa. It circled over the South before leaving at 1200 hours over Alma al-Sha'b.
13 December	1220	Five Israeli enemy warplanes violated Lebanese airspace, entering over the sea west of Naqurah. They circled over the sea between Beirut and Naqurah before leaving at 1405 hours over the sea west of Naqurah.
	2000	An Israeli enemy reconnaissance aircraft violated Lebanese airspace, entering over Kafr Killa. It circled over Riyaq, Ba'albek and Hirmil before leaving at 0225 hours on 14 December over Kafr Killa.
