1 February	1045	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1317 hours.
	1130	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1300 hours.
	1940–2130	The Israeli enemy fired three flare shells over the Radar position inside the occupied Shab'a Farms.
2 February	0900	Opposite Ra's al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory west of point M2 along the Blue Line, in the area to which Lebanon maintains a claim. The enemy placed steel rods into a pier for a steel bridge that had been put into place earlier in preparation for pouring concrete. The work ended at 1545 hours.
	0930	In occupied Palestinian territory, opposite the town of Udaysah, the Israeli enemy used a construction vehicle and an excavator to finish installing an advanced system to identify and detect tunnels. The work ended at 1700 hours, and the vehicles returned to occupied territory.
3 February	0740	In occupied Palestinian territory, at the Israeli enemy's Jabal al-Tayyarah position, opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The vehicle left in the direction of occupied territory at 0900 hours.
	0830	Opposite Ra's al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory west of point M2 along the Blue Line, in the area to which Lebanon maintains a claim. The enemy placed steel rods into a pier for a steel bridge that had been put into place earlier in preparation for pouring concrete. The work ended at 1530 hours.
		In occupied Palestinian territory, opposite the town of Ayta al-Sha'b, near point BP13/1, an Israeli enemy patrol passed through a gate in the technical fence without notifying the United Nations Interim Force in Lebanon (UNIFIL). The patrol left in the direction of occupied territory at 1730 hours.
		In occupied Palestinian territory, opposite the town of Udaysah, the Israeli enemy used a construction vehicle and an excavator to continue installation of an advanced system to identify and detect tunnels. The work ended at 1740 hours, and the vehicles returned to occupied territory.

	0830–1000	Inside the occupied Shab'a Farms, near the Israeli enemy's posts at Summaqah–Zabdin and Ramta, the sound of light- and heavy-weapon fire was heard.
	1100	An Israeli enemy army patrol entered Lebanese territory in Zabdin Farm, took up a position at the gate of the Shab'a Farms, Bastra district, and conducted a foot patrol of the area. The patrol proceeded as far as the concrete blocks and remained there for some time. The patrol left in the direction of the Zabdin post at 1200 hours.
	1200	A patrol aboard a civilian bus and a civilian vehicle approached from the Israeli enemy's Jabal al-Tayyarah position inside occupied Palestinian territory, opposite the town of Kafr Kila. Some 35 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1350 hours.
	1300	As members of the Lebanese Association for Mine and Natural Disaster Action were clearing mines on the outskirts of the town of Bustan, enemy personnel directed profanities at a Lebanese worker from their position at Hadb al-Bustan.
	1740	Opposite Ra's al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory west of point M2 along the Blue Line, in the area to which Lebanon maintains a claim. The enemy used two pumps and concrete mixers to pour concrete into a pier for a steel bridge that had been put into place earlier. The work ended at 0500 hours on 4 February.
	2132	In occupied Palestinian territory, opposite the town of Ayta al-Sha'b, near point BP13(1), an Israeli enemy patrol passed through a gate in the technical fence without notifying UNIFIL. The patrol left in the direction of occupied territory at 2245 hours.
4 February	0750	In occupied Palestinian territory, opposite the town of Wazzani, an Israeli enemy patrol passed through a gate in the technical fence without notifying UNIFIL. The patrol left in the direction of occupied territory at 0830 hours.
	0820	In occupied Palestinian territory, opposite the town of Udaysah, the Israeli enemy used a construction vehicle and an excavator to continue installation of an advanced system to identify and detect tunnels. The work ended at 1400 hours, and the vehicles returned to occupied territory.
	1100	Five Israeli enemy personnel used a truck and a bulldozer to repair a road in occupied Lebanese territory, at point TP16, opposite the town of Rumaysh. The enemy personnel and the vehicles left in the direction of occupied territory at 1530 hours. Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP36, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1240–1330	Several explosions, the cause of which is unknown, were heard inside the occupied Shab'a Farms, opposite the town of Abbasiyah.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	1310	A 12-person Israeli enemy patrol approached from occupied Palestinian territory, opposite the town of Udaysah, and opened the gate in the technical fence. The united conducted a foot patrol in Udaysah, in occupied Lebanese territory, near point TP36, proceeding some 150 m towards point TP35. Meanwhile, the cannon of Merkava tank in occupied territory was pointed towards Lebanese territory. The patrol left in the direction of occupied territory at 1412 hours.
	1515	At the Israeli enemy's Shaykh Abbad position, in occupied Palestinian territory, six persons reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1540 hours.
6 February	0700	From occupied Palestinian territory, opposite the town of Ayta al-Sha'b, next to the Israeli enemy's Tall al-Rahib position, two excavators equipped with hydraulic breakers, a wheel loader and eight personnel crossed the technical fence and proceed to reposition some concrete blocks. As the work was being carried out, the booms of the excavators were extended over the Blue Line several times, between points BP13(2) and B32.
	1015	In occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy's Jabal al-Tayyarah position, some 25 individuals in military and civilian clothing reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1050 hours.
	1410	Three journalists in civilians clothing carrying a camera and three persons in military clothing climbed onto the roof of the control room atop the steel observation and communications tower located inside the Ra's al-Naqurah position and photographed the Lebanese side. They left in the direction of occupied territory at 1525 hours.
7 February	0630	A suspicious object was found Surayri, Jazzin district. It was examined by a Lebanese Army engineering squad and determined to be a MK-83 bomb, bearing inscriptions in Hebrew, from an Israeli aircraft. The bomb, which was equipped with two fuses, an electrical fuse in the tail and a mechanical impact fuse in the tip, and weighed approximately 450 kg, had been dropped by the Israeli enemy but had not exploded.
	0750	In occupied Palestinian territory, at the Israeli enemy's Jabal al-Tayyarah position, opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0820 hours.
	0820	In occupied Palestinian territory, opposite the town of Udaysah, near point B93, Israeli enemy soldiers pointed a machine gun mounted on a vehicle towards a Lebanese Army patrol. The vehicle left in the direction of occupied territory at 0827 hours.
	0820	In occupied Palestinian territory, opposite the town of Wazzani, Israeli enemy soldiers pointed a machine gun mounted on a vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 0827 hours.

	1700	Opposite Ra's al-Naqurah, at the Lebanese-Palestinian border, a 14-person Israeli enemy patrol violated the Blue Line in the area to which Lebanon maintains a claim. The patrol searched the area around the technical fence and one of the soldiers climbed over the steel fence and the gate of the position of the Italian contingent of UNIFIL. They used a handheld light to search the courtyard and the perimeter of the steel fence, without any objection or interference from the members of the aforementioned contingent. The patrol left in the direction of occupied territory at 1920 hours.
8 February	1800	Two Israeli enemy vehicles stopped in occupied Palestinian territory, opposite Ra's al-Naqurah, west of point M2 on the Blue Line, in the area to which Lebanon maintains a claim. Three individuals disembarked and conducted a foot patrol south of the steel separation fence. They proceeded as far as the yellow gate opposite point M1 and then headed back to the east before leaving towards occupied territory.
9 February	0930	In occupied Palestinian territory, opposite Ra's al-Naqurah, at point M1 on the Blue Line, in the area to which Lebanon maintains a claim, five Israeli enemy soldiers crossed the Lebanon-occupied Palestine border. They left in the direction of occupied territory at 0950 hours.
10 February	1400	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1420 hours.
11 February	0850– 0940	An Israeli enemy civilian bus approached from occupied Palestinian territory, opposite the town of Udaysah, near point TP36/2. Some 30 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side. Six civilian vehicles approached from the Israeli enemy's Jabal al-Tayyarah position inside occupied Palestinian territory, opposite the town of Kafr Kila. Some 20 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side.
	1100	An Israeli enemy civilian bus and a civilian pickup truck approached from occupied Palestinian territory, opposite the town of Kafr Kila, near point B82. Some 25 individuals in military clothing disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1300 hours.
	1545	In occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers pointed the cannon of a Merkava tank towards a UNIFIL patrol until 1550 hours.
12 February	1550	In occupied Palestinian territory, opposite the town of Udaysah, near point TP36, Israeli enemy soldiers pointed a machine gun mounted on a vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1603 hours.

	1930	From above occupied Palestinian territory, opposite Rumaysh, searchlights were directed towards Lebanese territory from two Israeli enemy balloons. They left in the direction of occupied territory at 1930 hours.
13 February	1000–1030	As two Lebanese Army officers and a patrol from the UNIFIL liaison unit were inspecting the entrance to the railway tunnel in Ra's al-Naqurah district, eight Israeli enemy soldiers crossed the Blue Line by 30 m between points M1 and B1.
	1130	In occupied Palestinian territory, opposite Sahl al-Khiyam, near point BP37(2), Israeli enemy soldiers pointed a machine gun mounted on a vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1200 hours.
	1825	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1840 hours.
	2025	In occupied Palestinian territory, next to the Israeli enemy's Zar'it position, an enemy patrol directed a searchlight towards Lebanese territory.
14 February	1440	In occupied Palestinian territory, opposite points B64 and B64(1), Israeli enemy soldiers pointed their weapons towards Lebanese Army soldiers for 15 minutes. They left in the direction of occupied territory at 1620 hours.
16 February	1005	In occupied Lebanese territory, opposite Ra's al-Naqurah, two Israeli enemy soldiers conducted a reconnaissance patrol south of the steel separation fence, from point M2, which lies on a stretch of the Blue Line to which Lebanon maintains a claim, and then west to point M1. They left in the direction of occupied territory at 1015 hours.
	1453	In occupied Palestinian territory, opposite the town of Mays al-Jabal, near the Israeli enemy's Ruwaysah position, enemy soldiers pointed the cannon of a Merkava tank towards a UNIFIL patrol until 1503 hours.
17 February	0830	In occupied Palestinian territory, opposite the town of Ayta al-Sha'b, at point BP13(1), an Israeli enemy patrol passed through a gate in the technical fence without notifying UNIFIL and carried out construction work and cut down trees. The patrol left in the direction of occupied territory at 1630 hours.
	0915	In occupied Lebanese territory, opposite Ra's al-Naqurah, an Israeli enemy soldier and two UNIFIL soldiers conducted a reconnaissance patrol south of the steel separation fence, from point M1, which lies on a stretch of the Blue Line to which Lebanon maintains a claim, and then east to a location west of point M2. They left in the direction of occupied territory at 0920 hours.
	1315	A civilian vehicle and a civilian bus approached from the Israeli enemy's Jabal al-Tayyarah position inside occupied Palestinian territory, opposite the town of Kafr Kila. Some 30 individuals in civilian clothing

		disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1115 hours.
	1500– 1600	The sound of eight explosions was heard in the occupied Shab'a Farms and the occupied Golan Heights as warplanes flew overhead.
	1630	In occupied Lebanese territory, opposite Ra's al-Naqurah, five Israeli enemy soldiers and four UNIFIL soldiers conducted a reconnaissance patrol south of the steel separation fence, from point M1, which lies on a stretch of the Blue Line to which Lebanon maintains a claim, and then east to a location west of point M2. They left in the direction of occupied territory at 1640 hours.
18 February	0820	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1030 hours.
	0845	In occupied Lebanese territory, opposite Ra's al-Naqurah, the Israeli enemy used a bulldozer to level earth south of the steel separation fence, west of point M2, which lies on a stretch of the Blue Line to which Lebanon maintains a claim. The work ended at 1250 hours.
	1100	Two civilian buses approached from the Israeli enemy's Jabal al-Tayyarah position inside occupied Palestinian territory, opposite the town of Kafr Kila. Some 60 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1200 hours.
19 February	1000	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1530 hours.
	1130	In occupied Palestinian territory, opposite the town of Hula, at the Israeli enemy's Shaykh Abbad position, eight individuals in military clothing reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1150 hours.
20 February	0800	In occupied Palestinian territory, at the Israeli enemy's Jabal al-Tayyarah position, opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0830 hours.
	0900	Opposite Ra's al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory west of point M2 along the Blue Line, in the area to which Lebanon maintains a claim. Civilian workers used a winch to weld grids of steel rods onto bridges that had been built earlier. The work ended at 1615 hours, and the workers left in the direction of occupied territory.
	1300	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Hummer vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1305 hours.

	1445	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, two individuals in civilian clothing stepped out of an Israeli enemy civilian vehicle and photographed the Lebanese side. They left in the direction of occupied territory at 1445 hours.
21 February	1135	In occupied Palestinian territory, near point TP36, opposite the town of Udaysah, some 20 individuals disembarked from a Hummer vehicle and a civilian bus, reconnoitred the area and photographed the Lebanese side. One of those individuals pointed the weapon mounted on the Hummer vehicle towards Lebanese territory. They left in the direction of occupied territory at 1250 hours.
	1320– 1340	The sound of several explosions was heard in the occupied Shab‘a Farms and the sound of sirens was heard inside the Israeli enemy’s Summaqah position.
23 February	0830	In occupied Lebanese territory, opposite Ra’s al-Naqurah, the Israeli enemy used a wheeled bulldozer to level earth south of the steel separation fence, west of point M2, which lies on a stretch of the Blue Line to which Lebanon maintains a claim. The work ended at 1445 hours.
24 February	0830	Opposite Ra’s al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory west of point M2 along the Blue Line, in the area to which Lebanon maintains a claim. Civilian workers used a winch to continue welding grids of steel rods onto bridges that had been built earlier. The work ended at 1615 hours, and the workers left in the direction of occupied territory.
	2310– 2350	From inside the occupied Shab‘a Farms, the Israeli enemy fired four flare shells over the Radar position.
25 February	1150	A civilian bus and three civilian vehicles approached from occupied Palestinian territory, near point TP36(1), opposite the town of Udaysah. Some 50 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1250 hours.
26 February	0810	From inside the occupied Palestinian territories opposite the town of Wazzani, some 15 Israeli enemy soldiers crossed the gate at the technical fence and carried out a patrol on foot towards the river without informing UNIFIL. They left in the direction of occupied territory at 0950 hours.
	1000	Opposite Ra’s al-Naqurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory west of point M2 along the Blue Line, in the area to which Lebanon maintains a claim. Civilian workers used a winch to continue welding grids of steel rods onto bridges that had been built earlier. The work ended at 1600 hours, and the workers left in the direction of occupied territory.
	1500	Inside occupied Palestinian territory, opposite the town of Udaysah, near point TP37, two individuals in civilian clothing stepped out of an Israeli enemy civilian vehicle and photographed the Lebanese side. They left in the direction of occupied territory at 1520 hours.

	1631	In occupied Palestinian territory, opposite the town of Udaysah, near point TP37, Israeli enemy soldiers pointed a machine gun mounted on a Humvee vehicle towards Lebanese territory. The vehicle left in the direction of occupied territory at 1700 hours.
27 February	0825	Inside occupied Palestinian territory, opposite the town of Mays al-Jabal and points B64 and B64(2), Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0930 hours.
	0840	In occupied Palestinian territory, opposite the town of Mays al-Jabal, an Israeli enemy patrol consisting of approximately 18 soldiers passed through a gate in the technical fence without notifying UNIFIL. Meanwhile, the cannon of a Merkava tank positioned at that location was pointed towards Lebanese territory. The patrol left in the direction of occupied territory at 0940 hours.
	0900	Opposite Ra's al-Naqrurah, at the Lebanese-Palestinian border, the Israeli enemy continued with construction work inside occupied Lebanese territory west of point M2 along the Blue Line, in the area to which Lebanon maintains a claim. Civilian workers used a winch to continue welding grids of steel rods onto bridges that had been built earlier. The work ended at 1545 hours, and the workers left in the direction of occupied territory.
	1120	Two Israeli enemy civilian buses approached from occupied Palestinian territory, opposite the town of Wazzani, near point B93. Some 50 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1150 hours.
	1200	Several explosions were heard inside the occupied Shab'a Farms as three helicopters circled at medium altitude over the Israeli enemy's Zabdin, Ramta, Summaqah and Ruwaysat al-Alam positions.
28 February	0750	In occupied Palestinian territory, at the Israeli enemy's Jabal al-Tayyarah position, opposite the town of Kafr Kila, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory. The tank left in the direction of occupied territory at 0840 hours.
	0800	Two Israeli enemy civilian vehicles approached from occupied Palestinian territory, opposite point BP38(2). Some 10 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 0840 hours.
	0830	In occupied Palestinian territory, opposite the town of Hula, at the Israeli enemy's Shaykh Abbad position, three Israeli enemy soldiers installed a camera and pointed it towards Lebanese territory. The left in the direction of occupied territory at 0910 hours.
	1015	Two Israeli enemy civilian buses approached from the Israeli enemy's Jabal al-Tayyarah position inside occupied Palestinian territory, opposite the town of Kafr Kila. Some 50 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1120 hours.

29 February	1125	A civilian bus approached from occupied Palestinian territory, near point TP 36, opposite the town of Udaysah. Some 20 individuals in civilian clothing disembarked, reconnoitred the area and photographed the Lebanese side. They left in the direction of occupied territory at 1200 hours.

Sea violations committed in February 2020

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
2 February	0450	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) of 1 October 2011 for four minutes, proceeding on its way for some 300 m. The launch then left in the direction of occupied Palestinian territorial waters.
	0520	Off Ra's al-Naqurah, inside occupied Palestinian territorial waters, the crew of an Israeli enemy military launch directed a searchlight towards Lebanese territorial waters and sounded warning sirens for five minutes.
3 February	0450	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree 6433 (2011) for 40 minutes, proceeding on its way for some 185 m. During the incursion, the crew of the launch directed a searchlight and fired rounds at Lebanese territorial waters. The launch then left in the direction of occupied Palestinian territorial waters.
	1400	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree 6433 (2011) for six minutes, proceeding on its way for some 90 m. The crew of the launch sounded warnings sirens and made announcements in Hebrew. The launch then left in the direction of occupied Palestinian territorial waters.
4 February	0525	Off Ra's al-Naqurah, an Israeli enemy military launch violated the southern maritime boundary established by Decree No. 6433 (2011) for three minutes, proceeding on its way for some 260 m. The launch then left in the direction of occupied Palestinian territorial waters.
