**Land violations committed in May 2020**

1 May	1212	Inside occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers trained their firearms on a patrol of the United Nations Interim Force in Lebanon (UNIFIL). The patrol left in the direction of occupied territory at 1219 hours.
3 May	1020	In occupied Palestinian territory, opposite the town of Aytarun, between points BP25(1) and B56, Israeli enemy soldiers pointed their weapons at a Lebanese Army patrol.
	1820	Inside occupied Palestinian territory, opposite the town of Aytarun between points BP25 (1) and B56, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	2120– 2130	The Israeli enemy launched five flares around the occupied town of Ghajar, on the SD1 road, near observation point CKP2, which is controlled by the Spanish contingent of UNIFIL.
	2130	Inside occupied Palestinian territory, opposite the town of Wazzani, Israeli enemy soldiers launched 10 flares over the occupied town of Ghajar.
	2200	An Israeli enemy patrol set out from inside the occupied town of Ghajar and entered liberated Lebanese territory at observation post CKP2, which is controlled by the Spanish contingent of UNIFIL. The patrol proceeded for approximately 30 m towards the SD1 road before leaving in the direction of occupied territory at 2215 hours.
4 May	1730	Near point B85 opposite the town of Kafr Kila, inside occupied Palestinian territory, Israeli enemy soldiers installed four observation cameras on the metal platform located on the cement wall and trained them on Lebanese territory. Work ended at 0800 hours.
5 May	0740	At the Israeli enemy position of Jabal al-Tayyarah opposite the town of Kafr Kila, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The tank left in the direction of occupied territory at 0850 hours.
6 May	1110	Four civilian cars approached near point B82 opposite Kafr Kila, in occupied Palestinian territory. Some 10 individuals in civilian clothing stepped out, conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1150 hours.
	1950	The Israeli enemy launched three flares over the occupied town of Ghajar, opposite the town of Wazzani.
	2050	In the locality of Abbasiyat al-Ghajar, members of the Spanish contingent of UNIFIL saw three Israeli enemy vehicles and two soldiers observing Lebanese territory through rifle sights. At 2055 hours, the Israeli enemy launched two flares that landed on Lebanese territory.
7 May	0747	At the Israeli enemy position of Jabal al-Tayyarah opposite the town of Kafr Kila, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The patrol left in the direction of occupied territory at 0820 hours.

	0900	Some 15 uniformed individuals approached from the Israeli enemy position of Jabal al-Tayyarah opposite the town of Kafr Kila, inside occupied Palestinian territory, and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1040 hours.
	1100	Some 15 uniformed individuals approached at the Israeli enemy position of Shaykh Abbad, inside occupied Palestinian territory. They conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1130 hours.
8 May	1025	Inside occupied Lebanese territory, north of the town of Ghajar, four Israeli enemy soldiers crossed the technical fence by a distance of some 20 m. The patrol left in the direction of occupied territory at 1035 hours.
10 May	1330	Some 15 uniformed individuals approached from the Israeli enemy position of Shaykh Abbad opposite the town of Hula, inside occupied Palestinian territory, and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1400 hours.
11 May	0910	Opposite Naqurah, at the Lebanese-Palestinian border, the Israeli enemy carried out construction work inside occupied Lebanese territory near point M2 along the Blue Line, in the area to which Lebanon maintains a claim. Civilian workers poured concrete over a distance of some 10 m. The work ended at 1205 hours, and the vehicles returned into occupied territory.
	1530	Some 15 uniformed individuals approached from the Israeli enemy position of Shaykh Abbad opposite the town of Hula, inside occupied Palestinian territory, and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1600 hours.
	2125	From inside occupied Palestinian territory, opposite the town of Ra's al-Naqurah, the Israeli enemy directed a searchlight towards Lebanese territory until 2210 hours.
12 May	0730	At the Israeli enemy position of Shaykh Abbad opposite the town of Hula, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The patrol left in the direction of occupied territory at 0800 hours.
	1035	Five civilian vehicles and four military vehicles approached near point TP36 opposite Udaysah, in occupied Palestinian territory. Some 10 individuals, some in uniform and some in civilian clothing, stepped out, conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1105 hours.
13 May	0745	In occupied Palestinian territory opposite the town of Udaysah, near point TP36, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The patrol left in the direction of occupied territory at 1000 hours.

	1130	Near point B82(1) opposite the town of Kafr Kila, inside occupied Palestinian territory, Israeli enemy soldiers installed an observation camera on the metal platform located on the cement wall and trained them on Lebanese territory. The patrol left in the direction of occupied territory at 1200 hours.
	1310	From its position in Khallat al-Budiyah, opposite the town of Rumaysh, the Israeli enemy point a Merkava tank cannon towards the members of a UNIFIL patrol for five minutes.
	1900– 2130	Explosions, the cause of which is unknown, were heard inside the occupied Shab'a Farms.
14 May	0730	In the occupied town of Ghajar, opposite the town of Wazzani, enemy soldiers trained a vehicle-mounted machine gun on Lebanese territory. The patrol left in the direction of occupied territory at 1100 hours.
	0845	Inside occupied Palestinian territory, opposite the town of Mays al-Jabal, Israeli enemy soldiers pointed a Merkava tank cannon towards Lebanese territory for two minutes.
	1400	Some 15 uniformed individuals approached from the Israeli enemy position of Shaykh Abbad opposite the town of Hula, inside occupied Palestinian territory, and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1500 hours.
15 May	0720	At the Israeli enemy position of Jabal al-Tayyarah opposite the town of Kafr Kila, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The patrol left in the direction of occupied territory at 0750 hours.
17 May	0540	At the Israeli enemy position of Shaykh Abbad opposite the town of Hula, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The tank left in the direction of occupied territory at 0630 hours.
	1230	Opposite the town of Ramiya, inside occupied Palestinian territory, Israeli enemy soldiers installed a metal pillar mounted with an observation camera, which was trained on Lebanese territory.
	1336	In the locality of Rus on the outskirts of the town of Kafr Shuba, near point OP5 belonging to the Indian contingent of UNIFIL, Israeli enemy soldiers opened fire on the herder Muhammad Abdul'azim, a Syrian citizen, who had been grazing his herd on Lebanese territory. A bloodstained pullover belonging to him was found, but he was not. At 1515 hours, UNIFIL stated that it had received a message from the Israeli enemy stating that Israeli forces had opened fire on the herder, detained him and taken him to a hospital in Haifa.

18 May	0730	At the Israeli enemy position of Jabal al-Tayyarah opposite the town of Kafr Kila, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The tank left in the direction of occupied territory at 0805 hours.
	1030	Four civilian cars approached near point B82 opposite Kafr Kila, in occupied Palestinian territory. Some five individuals in military clothing stepped out, conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1100 hours.
19 May	0820	At the Israeli enemy position of Jabal al-Tayyarah opposite the town of Kafr Kila, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The tank left in the direction of occupied territory at 0910 hours.
21 May	0730	At the Israeli enemy position of Jabal al-Tayyarah opposite the town of Kafr Kila, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The tank left in the direction of occupied territory at 0810 hours.
	1050	Some 40 uniformed individuals approached from the Israeli enemy position of Jabal al-Tayyarah inside occupied Palestinian territory, opposite the town of Kafr Kila, and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1120 hours.
22 May	0700	At the Israeli enemy position of Jabal al-Tayyarah opposite the town of Kafr Kila, inside occupied Palestinian territory, enemy soldiers pointed a Merkava tank cannon in the direction of Lebanese territory. The tank left in the direction of occupied territory at 0855 hours.
	0947	A civilian bus belonging to the Israeli enemy approached near point TP31, opposite the town of Udaysah, in occupied Palestinian territory. Some 20 individuals, some in uniform and some in civilian clothing, stepped out and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1020 hours.
25 May	1430	Some 10 uniformed individuals approached the Israeli enemy position of Jabal al-Tayyarah inside occupied Palestinian territory, opposite the town of Kafr Kila, and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1510 hours.
26 May	2130– 2135	From the occupied Shab'a Farms, the Israeli enemy fired four flare shells opposite the \in Abbasiyat al-Ghajar mosque.
27 May	0635	At point B56 opposite the town of Aytarun, in occupied Palestinian territory, Israeli enemy soldiers trained their firearms on a Lebanese Army patrol.

	1520	At point B74 opposite the towns of Wadi Hunin and Markaba, in occupied Palestinian territory, Israeli enemy soldiers trained their firearms and a vehicle-mounted weapon on Lebanese territory. The patrol left in the direction of occupied territory at 1626 hours.
	2240	The Israeli enemy launched seven flares from inside occupied Palestinian territory. One crossed the Blue Line and landed in Lebanese territory in the Khillat al-Wardah area, on the outskirts of Ayta al-Sha'b, near point BP11(3), causing a fire that spread across 100 m <sup>2</sup> of scrub land. The townspeople put out the fire.
30 May	0735	A civilian vehicle belonging to the Israeli enemy approached point TP37, opposite the town of Udaysah, in occupied Palestinian territory. Three individuals in civilian clothing stepped out and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 0757 hours.
	1240	Some 12 uniformed individuals approached from the Israeli enemy position of Shaykh Abbad opposite the town of Hula, inside occupied Palestinian territory, and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1710 hours.
	1300	Eight civilian vehicles belonging to the Israeli enemy approached near point B82, opposite the town of Kafr Kila, in occupied Palestinian territory. Some 30 individuals, some in uniform and some in civilian clothing, stepped out and conducted a reconnaissance patrol in the area and took pictures of the Lebanese side. The patrol left in the direction of occupied territory at 1329 hours.
